

## **Assembly Instruction Manual**

Please read instructions thoroughly before beginning assembly.

Check boxes carefully for contents listed. Some parts are packaged inside of others.

Assemble on a clean, flat, non-abrasive surface to prevent scratching.

In the event of missing or damaged parts please call or email our customer service department at the contact info below.

### **Tools Required**

- -Battery or Electric Drill (#2 phillips bit, 1/4" & 3/32" drill bits)
- -Tape Measure
- -(2) 7/16" Wrenches or Sockets
- -File
- -All Purpose Grease (Optional)\*

\*In steps requiring nuts and bolts for assembly, we recommend placing a small amount of grease on the end threads of the bolt. All hardware is stainless steel and this practice will prevent galling or adhering together which may cause the bolt to snap during assembly while using power tools.








6' Picnic Table with Benches - Page 2




- Lay out four 72" table top rails (part 1) and one center table rail (part 2) as shown above with pilot holes facing up, leaving ½" gap between rails. Set four 12 ¾"" table brackets (part 3) over pilot holes at each end of table top rail, making sure brackets are offset as shown. Using ¾" screws, fasten each bracket to table top rails.
- Apply glue to inner edges of  $\frac{7}{8}$  x  $\frac{1}{2}$ " end cap (from hardware bag) and press on each end of 27" cross brace (part 5). Set center brace over pilot holes in center of table top. Using  $\frac{1}{2}$ " screws, fasten cross brace to table top.
- Apply glue to inside edges of 28" table top end cap (part 9). Press end cap onto ends of table top (DO NOT slide from end). Take care that end cap is flush with ends of table and use a file to round off any sharp edges.





- Loosely bolt two table legs (part 14) together using 3½" bolts, washers and nylock nuts. Make sure pilot holes for brackets are at the same end. Place each set of bolted legs into the bracket slots from step 1. Line up pilot hole and fasten legs to table using 2 ½" bolts, washer and nylock nuts.
- Remove bottom nylock nut on one leg and slide bolt through the hole on angel brace (part 7). Replace nut and tighten snugly. Repeat for opposite side. Overlap the two diagonal braces in the center of table. Drill two 3/32" pilot holes through the diagonal braces and into center brace. Fasten with 1 ½" screws to the center tabletop brace.
- Apply glue to inside edges of four 7 ¼" (part 11) table leg end caps. Press end caps onto ends of table legs (DO NOT slide from end). Take care that end cap is flush and use a file to round off any sharp edges.





- Lay out two of the 72" bench rails (part 13) as shown, leaving a 1/8" gap between rails. Set the two bench brackets (part 4) over pilot holes and fasten brackets to bench rails using ¾" screws. Apply glue to the 7/8 x 1 ½" molded end caps and push onto ends of center bench brace. Lay the brace over the pilot holes in center of rails and fasten using 1.5" screws.
- Apply glue to the  $7/8 \times 1 \frac{1}{2}$ " molded end caps and push onto ends of center bench brace (part 6). Lay the brace over the pilot holes in center of rails and fasten using  $1 \frac{1}{2}$ " screws.





- Loosely bolt two bench legs (part 15) together using 4" bolts, washers and nylock nuts. Make sure pilot holes for brackets are at the same end. Place each set of bolted legs into the bracket slots from step 8. Line up pilot hole and fasten legs to bench using 4" bolts, washer and nylock nuts.
- Remove bottom nylock nut on one leg and slide bolt through the hole on angel brace (part 8). Replace nut and tighten snugly. Repeat for opposite side. Overlap the two angle braces in the center of table. Drill two 3/32" pilot holes through the angle braces and into center brace. Fasten with 1 ½" screws to the bench cross brace.
- Apply glue to 11 ½" bench end caps (part 12). Press end caps onto ends of bench legs (DO NOT slide from end). Take care that end cap is flush and use a file to round off any sharp edges.
