
Assembly Instructions




OVERVIEW



This Barstool has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Barstool parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.



Unpack and place all parts on a clean, non-marring surface.




Put the Seat Panel (A) onto Left Leg Panel (D) in the direction of the arrow as shown in above picture.

Step 2.1 Attach the Seat Panel (A) to the Left Leg Panel (D) using Bolts (4), Spring Washer (5), Washer (6) and Allen Key (7).

Step 2.2 Attach the Seat Panel (A) to the Left Leg Panel (D) using Bolts (1), and Allen Key (7).


Do not fully tighten the Bolts.

Step 3



Put the Backrest (B) onto Left Leg Panel (D) in the direction of the arrow as shown in the above picture.


Step 4



Put the Front Leg Connection (E) and Back Leg Connection (F) onto Left Leg Panel (D). Then attach the Front Leg Connection(E) to the Left Leg Panel (D) using Screws (3) and Allen Key (7).

Do not fully tighten the Screws.


Step 5



Attach the Right Leg Panel (C) to the Seat Panel (A) using Bolts (4), Bolts (1), Spring Washer (5), Washer (6) and Alley Key (7).


Secure the Right Leg Panel (C) to the Backrest (B) using Screws (2) and Allen Key (7) **Do not fully tighten the Bolts.**

Step 6



Attach the Right Leg Panel (C) to the Front Leg Connection (E) and Back Leg Connection (F) using Screw (3), Screw (2) and Alley Key (7). **Do not fully tighten the Screws.**


Step 7



With the assistance of your adult partner, stand the Barstool up. Then secure the Left Leg Panel (D) to the Back Leg Connection (F) and Backrest (B) using Screws (2) and Allen Key (7).

Do not fully tighten the Screws.

Step 8



Exert pressure floorwards, onto the Barstool with both your hands.

This pressure will help the Legs and Barstool reach full alignment status.

Check for wobbles on a LEVEL surface.

If no wobbles are found proceed to tighten Bolts and Screws in a sequential manner, until evenly secured.

When tightening Bolts and Screws tighten sequentially.

Do not tighten any Bolt and Screw fully then move on towards the next one.

If there are still wobbles after tightening, loosen Bolts and Screws and excute the same above process.

Your Barstool is ready for use.

This Barstool can only be used on a flat, level surface.

Care & Maintenance



Do not put hot items directly on furniture surface



Do not clean furniture with harsh cleansers or polish.



 To obtain the longest lifespan of your outdoor prodcts, minimizing exposure to direct sunlight is recommended.



Children should not climb or jump on the furniture.



Do not write on furniture without a padded barrier to protect the surface.



 To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.



Not for commercial use. For residential use only.



Stains may be removed with mild soap solution and damp cloth.



Keep away from sources of ignition.



Dust and pick-up spills using a clean, non-colored, lint-free cloth.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
