
#### Overview



This Night Stand Cabinet has multiple parts and may require up to 20 minutes to assemble. To give an overview on the Night Stand parts, the above picture is to help you put the various parts into perspective. Please read through the instrustions below to familiarise yourself with the parts and steps before assembly.




Unpack and place all parts on a clean, non-marring surface. Before starting the assembly work, make sure the surface is clean and soft to avoid and scratches or damage.




Place the A. Back Panel face down, then insert the B. Side Panel (R) directly into the mounting position.

#### Step 3




For each step, Align the compress fit locking dowels with the corresponding receptor holes, then push them firmly into the final locked position, please note once locked, these will not come back apart without potential damage




Repeat the step C. Side Panel (L) for the panel D. Apron assembly as shown




Align the dovetails on E. Top Panel with the grooves on the B. Side Panel (R), and C. Side Panel (L) and gently slide the E. Top Panel into position




Align the dovetails on parts G. Drawer Side (R) with the grooves on the part Drawer Front (F) and gently slide it into position




Make sure the grooves of the drawer side panel H. Drawer Side (L) is facing inside



Ensure the proper position of the grooves of the drawer sides and the drawer front as shown above, then slide the panel I. Drawer Base into the place




Use the same compress fit locking style for the panel J. Drawer Back assembly as in step 3, as shown above. Push the Drawer Back Panel, into the locked positions.




Use your hand to tighten the Bolt 2 with the K. Handle until finished, as shown above.

#### Step 11




Tilt the completed drawer slightly to align the rail wheels with the fixed side rails, then slide them into place.



#### Installation Instruction:

This tip restraint must be attached to a wall stud using the 2" screw enclosed.

- 1. Attach a bracket securely to the back top rail of the furniture using the 5/8" screw provided, through the smaller hole.
- 2. Locate the other bracket on the wall over a wall stud and 2 inches below the mounting bracket secured to the back of your unit. Attach to the wall stud using the 2" screw provided, though the smaller hole.
- 3. Place the furniture into position so both mounting brackets are vertically in line.
- 4. Lace the end of the restraint strap through the larger hole in each mounting bracket. Bring both ends together and slide the flat end through the locking end and draw it through until all slack is removed.
- 5. Confirm that the strap is securely laced and locked.



Your Night Stand is ready for use.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list? The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.
- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
