

# **Assembly Instruction Manual**

Please read instructions thoroughly before beginning assembly.

Check boxes carefully for contents listed. Some parts are packaged inside of others.

Assemble on a clean, flat, non-abrasive surface to prevent scratching.

In the event of missing or damaged parts please call or email our customer service department at the contact info below.

### **Tools Required**

- -Battery or Electric Drill (#2 phillips bit, 1/4" & 1/8" drill bits)
- -Tape Measure
- -(2) 7/16" Wrenches or Sockets
- -File
- -All Purpose Grease (Optional)\*


\*In steps requiring nuts and bolts for assembly, we recommend placing a small amount of grease on the end threads of the bolt. All hardware is stainless steel and this practice will prevent galling or adhering together which may cause the bolt to snap during assembly while using power tools.






6' Picnic Table - Page 2



- Lay out five 72" table top rails (part 1) as shown above with pilot holes facing up, leaving 1/8" gap between rails. Table top rails have two holes in the center of each rail, seat rails do not. Set two 25½" table brackets (part 5) over pilot holes at each end of table top rail. Using twenty 3/4" screws per bracket, fasten each bracket to table top rails.
- Apply glue to inner edges of % x 1%" end cap (from hardware bag) and press on each end of 27" center brace (part 7). Set center brace over pilot holes in center of table top. Using ten 1%" screws, fasten center brace to table top.
- Apply glue to inside edges of 28" table top end cap (part 9). Press end cap onto ends of table top (DO NOT slide from end). Take care that end cap is flush with ends of table and use a file to round off any sharp edges.


Lay out two 72" seat rails (part 2) with pilot holes facing up, leaving  $\frac{1}{2}$ " gap between rails. Seat rails do no have any holes in the center of each rail. Set two  $8\frac{1}{2}$ " seat brackets (part 6) over pilot holes at each end of seat rail. Using eight  $\frac{1}{2}$ " screws per bracket, fasten each bracket to seat rails.


Apply glue to inside edges of 11%" seat end cap (part 10). Press end cap onto ends of seat (DO NOT slide from end). Take care that end cap is flush with ends of seat and use a file to round off any sharp edges.

Repeat to assemble second seat.





- 6 Lay out two 30%" legs (part 4) on an angle, with pre-drilled holes for attaching table top nearest each other at top. Lay one 59%" cross brace (part 3) across legs; adjusting legs so bolt holes line up.
- Using four 3½" bolts, eight washers and four nuts, fasten cross brace to legs. (Do not over tighten as this will crush the vinyl) Bolt heads will face outside of the table.
- Apply glue to inside edges of 5½" cross brace end cap (part 12). Press end cap onto ends of cross brace (DO NOT slide from end). Take care that end cap is flush with ends and use a file to round off any sharp edges.
- Apply glue to inside edges of 6½" seat end cap (part 11). Press end cap onto ends of seat (DO NOT slide from end).



- Insert one cross brace / leg assembly into bracket on underside of table top, with cross brace facing table edge. Using four 2¼" bolts, washers and nuts, fasten assembly to table top. Repeat with second cross brace / leg assembly for opposite end of table.
- Using one 2½" bolt, washer and nut, attach one 26½" diagonal brace (part 8) to center of each cross brace. In center of table, overlap free ends of diagonal braces and pre-drill two ½" holes through braces and into center brace. Using two 1½" screws, fasten both diagonal braces to center brace.
- Position seat assembly over cross brace and line up bolt holes of brackets to holes in cross brace. Using four 2¼" bolts, washers and nuts, fasten seat assembly to cross brace.

  Repeat for second seat assembly.
