
#### SAFETY WARNING

Never adjust chaise lounge or recliner backrest while seated.

Always make sure the backrest is flat before moving the chaise lounge.

Keep all limbs clear from under the backrest when it is in a raised position.



# Assembly Preparation







Read instructions, cover to cover-



Have 2 adults on hand for assembly-




Do not assemble on flooring or carpet-




Assemble on a clean non-marring surface (packing foam)-

This Chaise Lounge has multiple parts and may require up to 30 minutes to assemble. To give you an overview ofthe Chaise Lounge parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.




Open the carton and place all parts on a clean, non-damaged surface.

Attach the Seat Panel(C) to Right Legs(B), using Bolts(③) and Washer(④) Allen Wrench(①) as shown above.

One mounting position need washer, and the washer will be placed between leg and seat panel.

Do Not Fully tighten the bolts.


### Step 2



Repeat the last step to attach the Left Legs(A) as shown above.

Do Not Fully tighten the bolts.

#### Step 3




Attach the Backrest Panel(D) to Left Legs(A) & Right Legs(B), using Bolts(③) and Washers(④) with Allen Wrench(①).

As shown above, the Washer will be placed between Backrest Panel and Legs.

Do Not Fully tighten the bolts.


### Step 4



Attach the Legs Support Bar(E) to left and right legs(A, B), using bolts(②) with Allen Wrench(0) as shown above.

#### Do Not Fully tighten the bolts.


## Step 5



Attach the Gear Support Bar(F) to left and right legs(A, B), using bolts(3) with Allen Wrench(①) as shown above.

Do Not Fully tighten the bolts.

# Step 6



Stand the Chaise Lounge up.

Place the Chaise Lounge on a LEVEL SURFACE.

inspect it and make sure all parts are adequately connected.

Gently and carefully sit onto the Chaise Lounge.

This will help to align all parts at all joints.

Then get off the Chaise Lounge, and in a sequential manner, proceed to tighten all Bolts.

When tightening the Bolts, tighten sequentially.

DO NOT tighten any Bolt fully and then move on to the next one.

This may cause the frame to warp.

If there is still wobbles, loosen the Bolts and execute this same process. If the Chaise Lounge is not stable it could lead to damage to the product.

Note: This step is done best with the assistance of a second adult.

Your Chaise Lounge is ready for use.

This Chaise Lounge can only be used on a flat, level surface.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
