Step 2




Attach the Front Left Leg (A) to Back Leg (C) and Support Left Leg (D), using Bolts (③) ,Washer (⑤) with Allen Wrench (①) as shown above.




Attach the Back Leg (C) to Support Right Leg (E), using Screw (4) with Allen Wrench (1) as shown above.

Do not fully tighten the Bolts.

Step 4






Attach the Back (F) to the Seat (G), using Bolts (2), with Allen Wrench (1) as shown above.

Step 6




Attach the Back (F) and the Seat (G) to Right Frame, using Bolts (2), Screw (4) , with Allen Wrench (1) as shown above.



Attach the Back (F) and the Seat (G) to Left Frame, using Bolts (②), Screw (④), with Allen Wrench (①) as shown above.


Do not fully tighten the Bolts.

Turn the Chair right side up.

Place the Seat Cushion (I) and Back Cushion (H) on the Chair as shown above.



Place the Chair on a LEVEL SURFACE.

Inspect it and make sure all parts are adequately connected.

Gently and carefully sit onto the Chair.

This will help to align all parts at all joints.

Then get off the Chair, and in asequential manner, proceed to tighten all Bolts.

When tightening the Bolts, tighten sequentially.

DO NOT tighten any Bolt fully and then move on to the next one.

This may cause the frame to warp.

If there are still wobbles, loosen the Bolts and execute this same process.

Note: This step is done best with the assistance of a second adult.

Ensure all screws are fully locked into position.


Attach the Back Leg(C)to Support Right Leg(E), using Screw (④) with Allen Wrench (①) as shown above.






Attach the Back (F) to the Seat (G), using Bolts (2), with Allen Wrench (1) as shown above.

Do not fully tighten the Bolts.




Attach the Back (F) and the Seat (G) to Right Frame, using Bolts (2), Screw (4), with Allen Wrench (1) as shown above.




Attach the Back (F) and the Seat (G) to Left Frame , using Bolts (②), Screw (④), with Allen Wrench (①) as shown above.


Attach the Center Leg (J) and the Seat (G), using Screw (©) as shown above.






