• Do not write on furniture without a padded barrier to protect the surface.



 To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.




 Stains may be removed with mild soap solution and damp cloth.


Assembly Steps

Overview




This Table has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Table parts, the above picture is provided to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1



Unpack and place all parts on a clean, non-marring surface.



Place the Table Top (A) and Leg (B) with its inner side face skywards onto a clean, soft surface to avoid any scratches or damages to the product.

Align the Mounting Position of Table Top (A) into the Mounting Position of Leg (B) as shown above.

Then, affix the Table Top (A) with Leg (B) by using Bolts (1), Spring Washers (2), Flat Washers (3) with Allen Wrench (M4) (4).

Step 3



Stand the Table up, with assistance from your adult partner. Exert pressure floorwards, onto the Table with both your hands. This pressure will help the Legs and Table Top reach full alignment status. Check for wobbles on a LEVEL surface. If no wobbles are found proceed to tighten the Bolts in a sequential manner, until evenly secured. When tightening the Bolts tighten sequentially. Do not tighten any Bolt fully and then move on towards the next one. If there are still wobbles, loosen the Bolts and excute the same above process. Your Table is ready for use.
This Table can only be used on the flat, level surface.

Questions & Answers about Proposition 65

• What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals. Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list? The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.
- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
