 Stains may be removed with mild soap solution and damp cloth.



Keep away from sources of ignition.



 Dust and pick-up spills using a clean, non-colored, lint-free cloth.



Do not assemble on flooring or carpet-





Assembly Steps



This Loveseat has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Sofa parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.


Step 1



Open the carton and place all parts on a clean, non-marring surface. Attach the Left Frame (A) to the Back (C) and Seat (D), using Screw (2), with Allen Wrench (1) as shown above.

Do not fully tighten the Bolts.


Step 2



Attach the Right Frame (B) to the Back (C) and Seat (D), using Screw (2), with Allen Wrench (1) as shown above.


Do not fully tighten the Bolts.

Step 3



Attach the Left Seat cushion (F), Right Seat Cushion (G), Back Cushion (E) to the loveseat as shown above.

Step 4



Place the Loveseat on a LEVEL SURFACE.

Inspect it and make sure all parts are adequately connected.

Gently and carefully sit onto the Sofa.

This will help to align all parts at all joints.

Then get off the Loveseat, and in asequential manner, proceed to tighten all Bolts.

When tightening the Bolts, tighten sequentially.

DO NOT tighten any Bolt fully and then move on to the next one.

This may cause the frame to warp.

If there are still wobbles, loosen the Bolts and execute this same process.

Note: This step is done best with the assistance of a second adult.

Ensure all screws are fully locked into position.

Your Loveseat is ready for use.

Caution: This Loveseat can only be used on a flat, level surface.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water. Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?
The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products,

food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals. By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
