CAUTION : You must read these Assembly Instructions before you proceed.



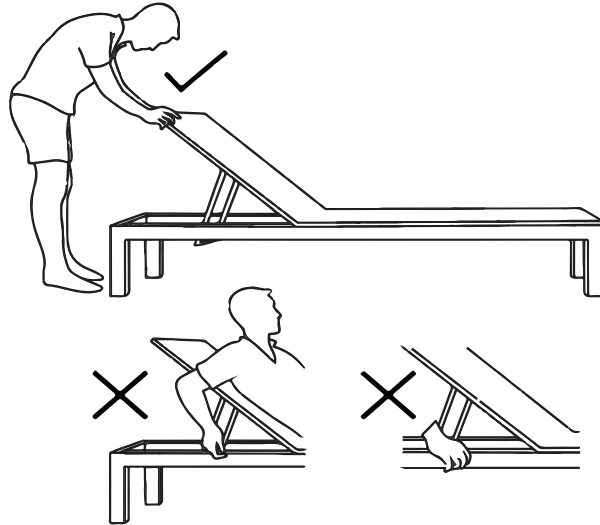
SAFETY WARNING

Never adjust chaise lounge or recliner backrest while seated.

Always make sure the backrest is flat before moving the chaise lounge.











Keep all limbs clear from under the backrest when it is in a raised position.

Serious finger, hand, or other bodily injuries may result from adjusting the chaise lounge backrest position while seated.



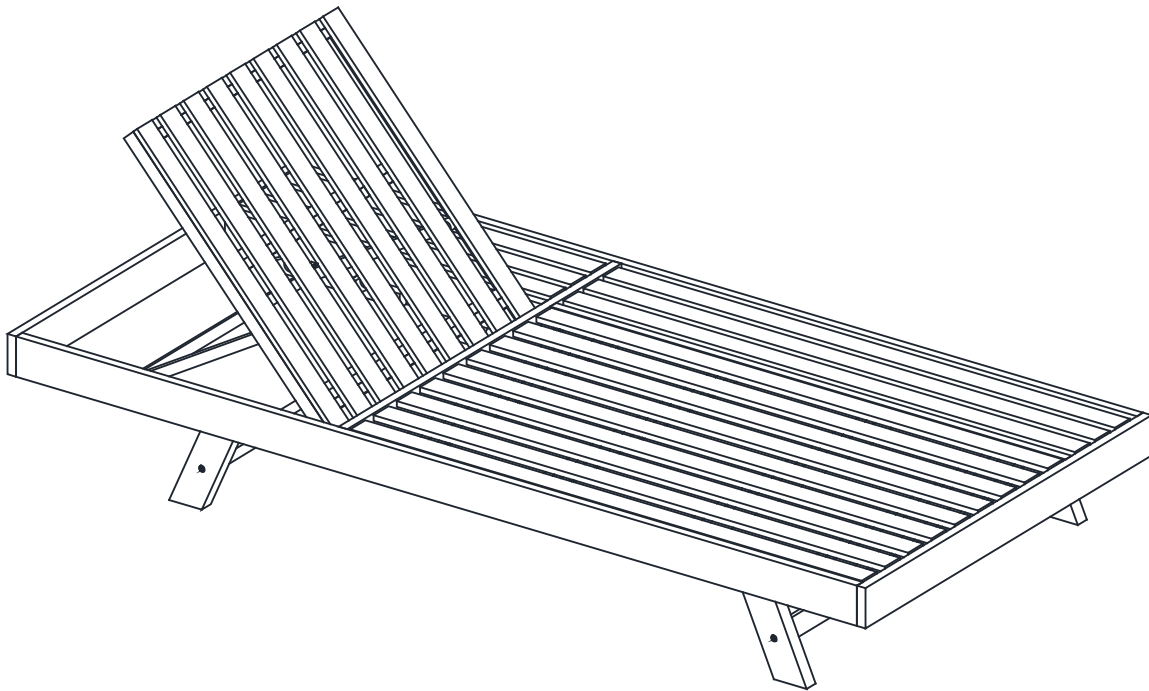

Care & Maintenance

- ⊗  ● Not for commercial use. For residential use only.
- ⊗  ● Do not put hot items directly on furniture surface.
- ⊗  ● Do not clean furniture with harsh cleansers or polish.
- ✓  ● To obtain the longest lifespan of your outdoor products, minimizing exposure to direct sunlight is recommended.
- ⊗  ● Children should not climb or jump on the furniture.
- ⊗  ● Do not write on furniture without a padded barrier to protect the surface.
- ✓  ● To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.
- ⊗  ● Stains may be removed with mild soap solution and damp cloth.
- ✓  ● Keep away from sources of ignition.
- ✓  ● Dust and pick-up spills using a clean, non-colored, lint-free cloth.















- Save all packaging until finished.

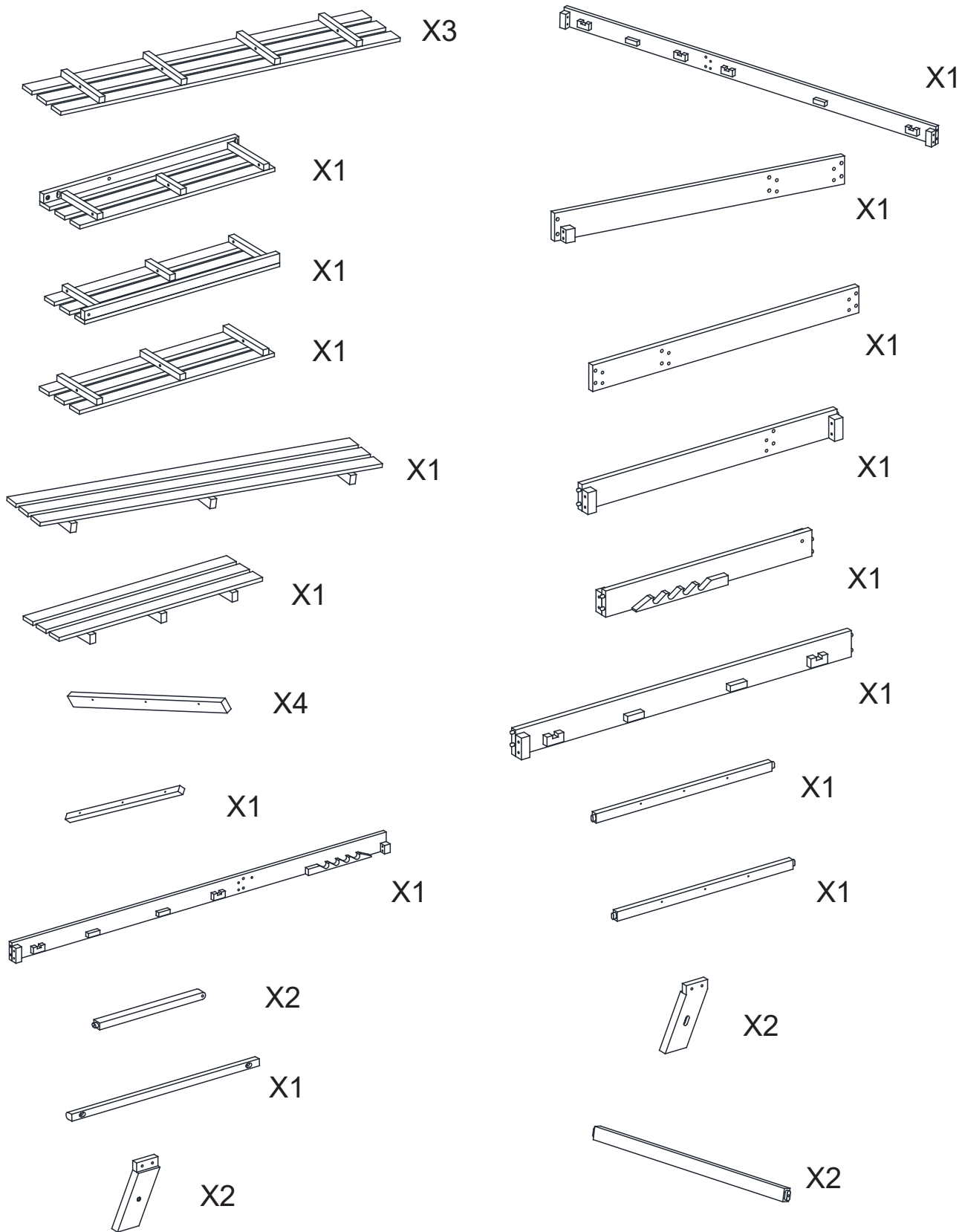
Assembly Steps

OVERVIEW



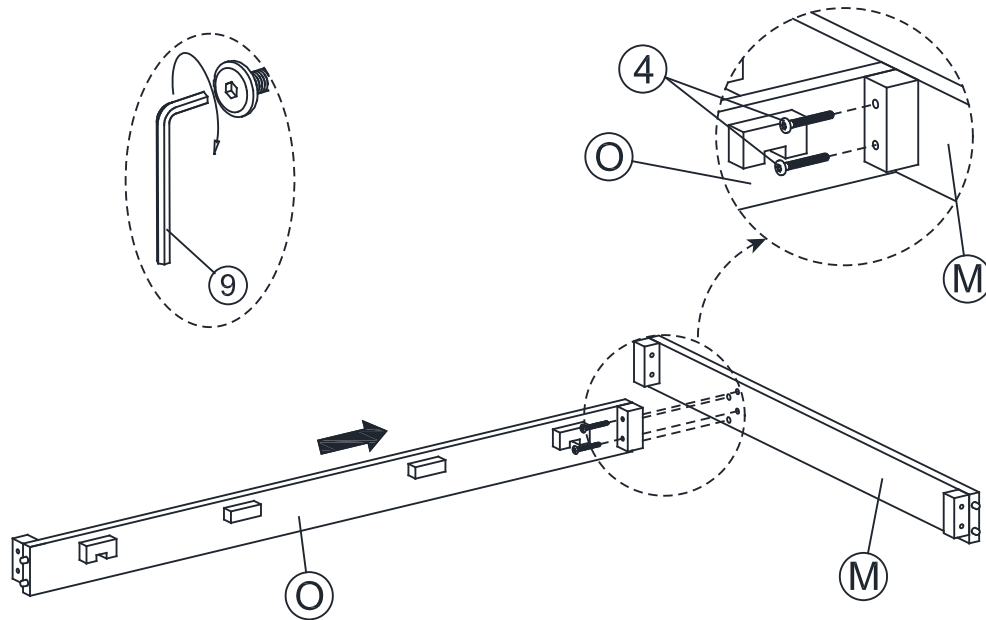
This Chaise Lounge has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Chaise Lounge, we've provided the above picture to put the various parts in perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1



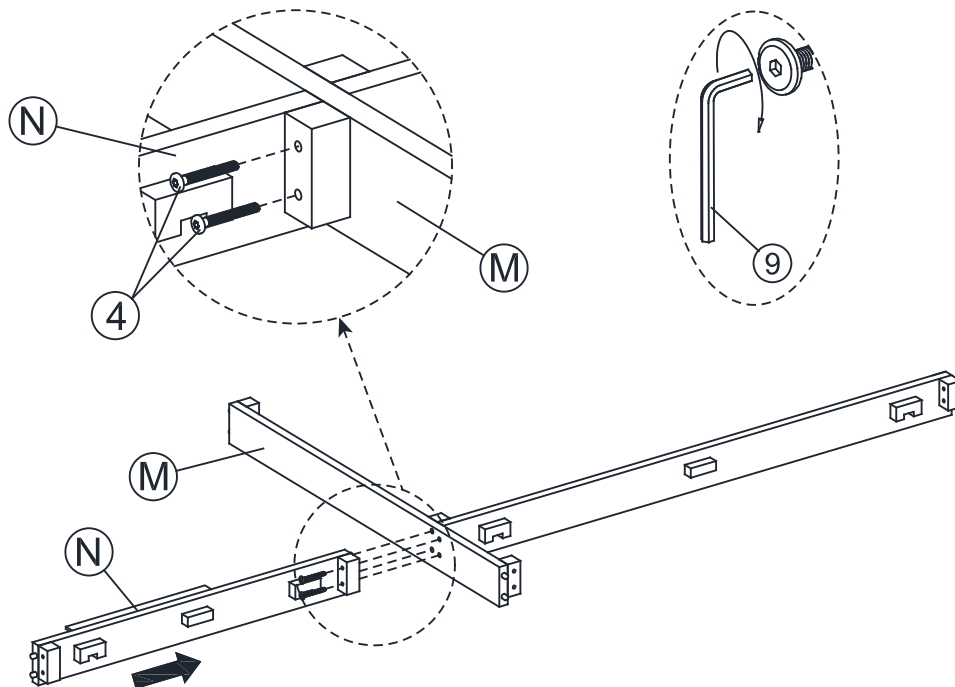
Unpack and place all parts on a clean, non-marring surface.

Step 2



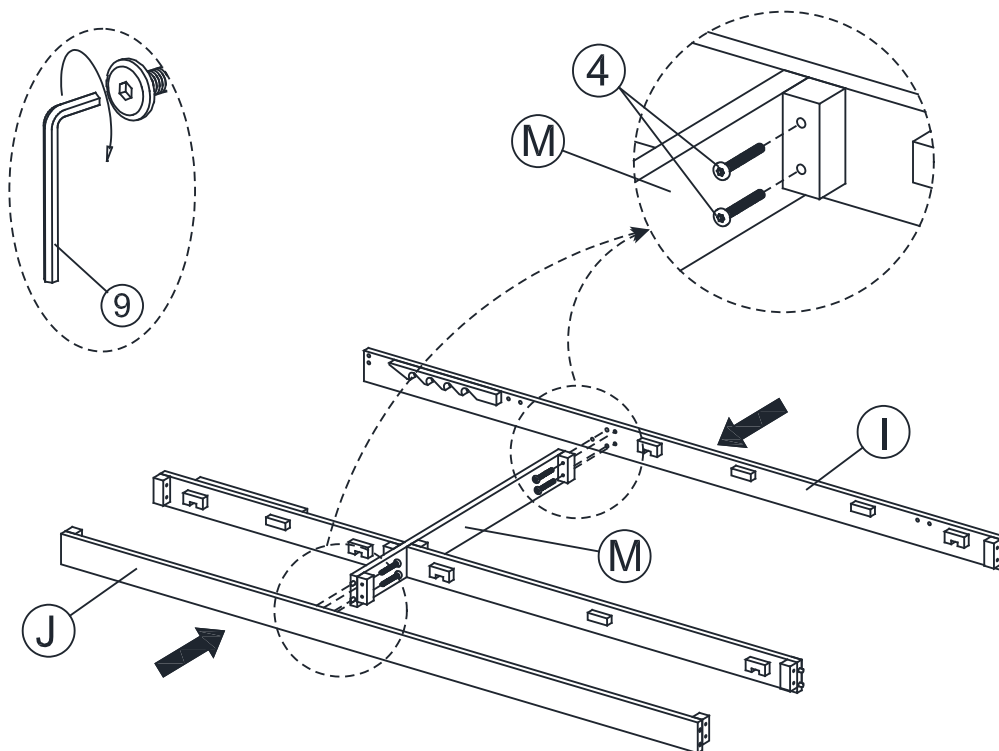
With assistance from your adult partner, place the Middle Bed Support Bar (M) facedown onto a clean, non marring surface, then attach the Middle Bed Bar 2 (O) to the Middle Bed Support Bar (M) using the Bolts ④ and the Allen Wrench ⑨.

Step 3



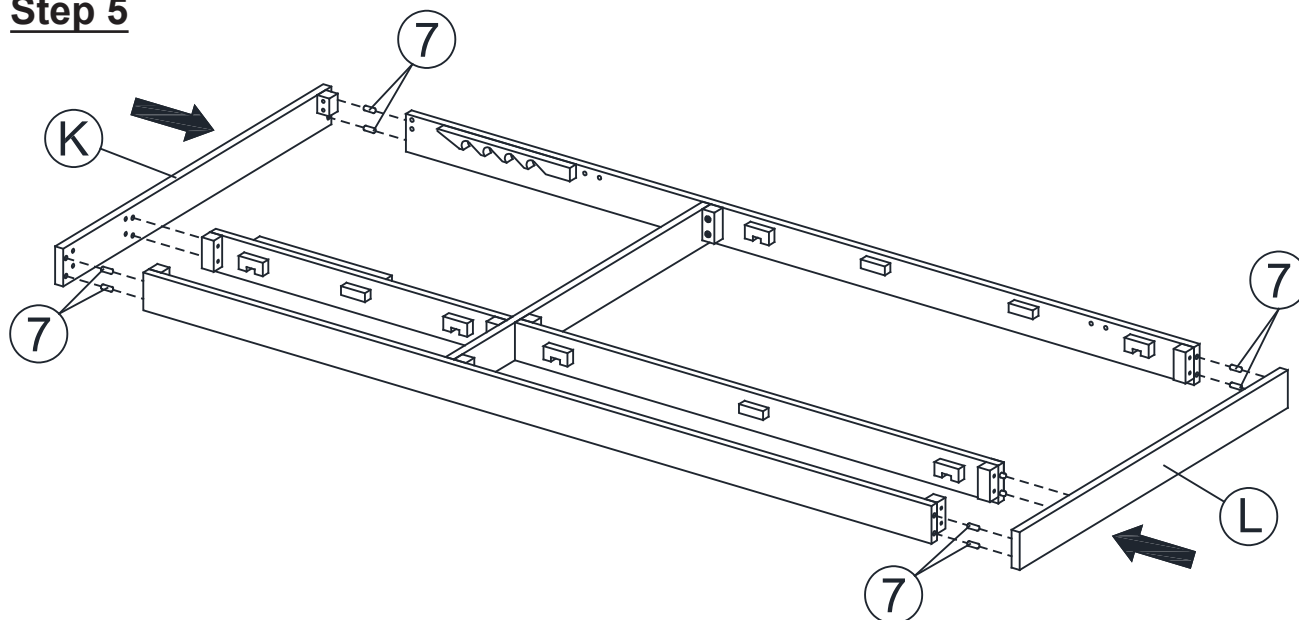
From Step 2, attach Middle Bed Bar 1 (N) to assembled part in Step 2 using Bolt ④ and Allen Wrench ⑨.

Step 4



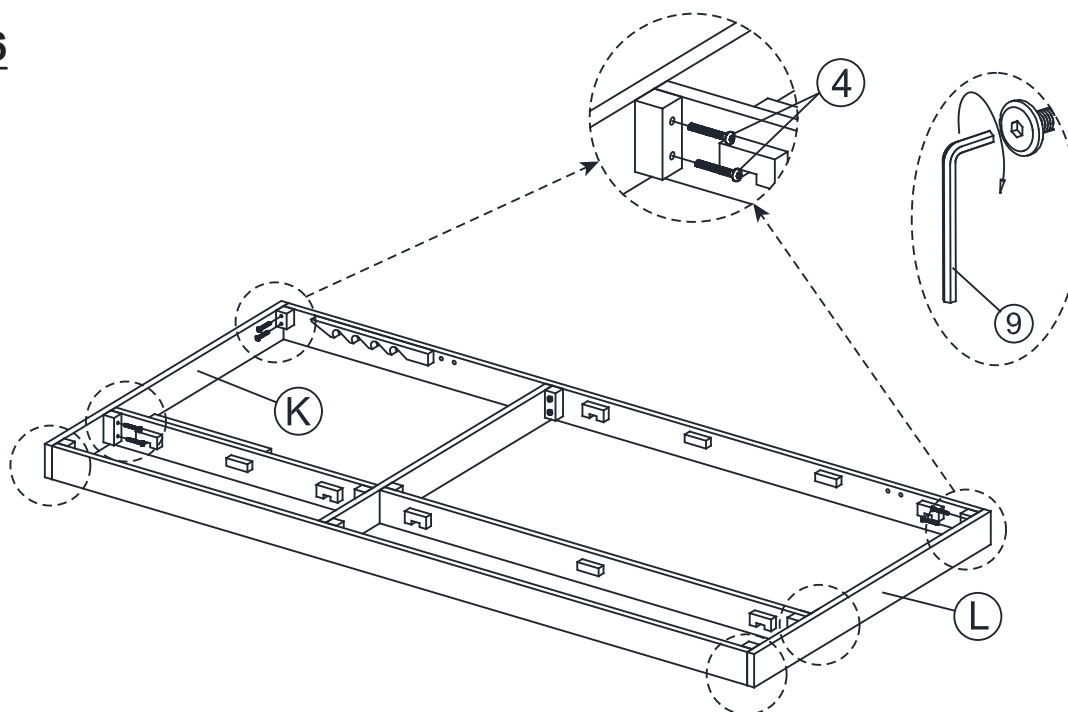
From Step 3, attach Right Side Bed Bar (I) and Left Side Bed Bar (J) to assembled part in Step 3 using Bolt ④ and Alle Wrench ⑨.

Step 5



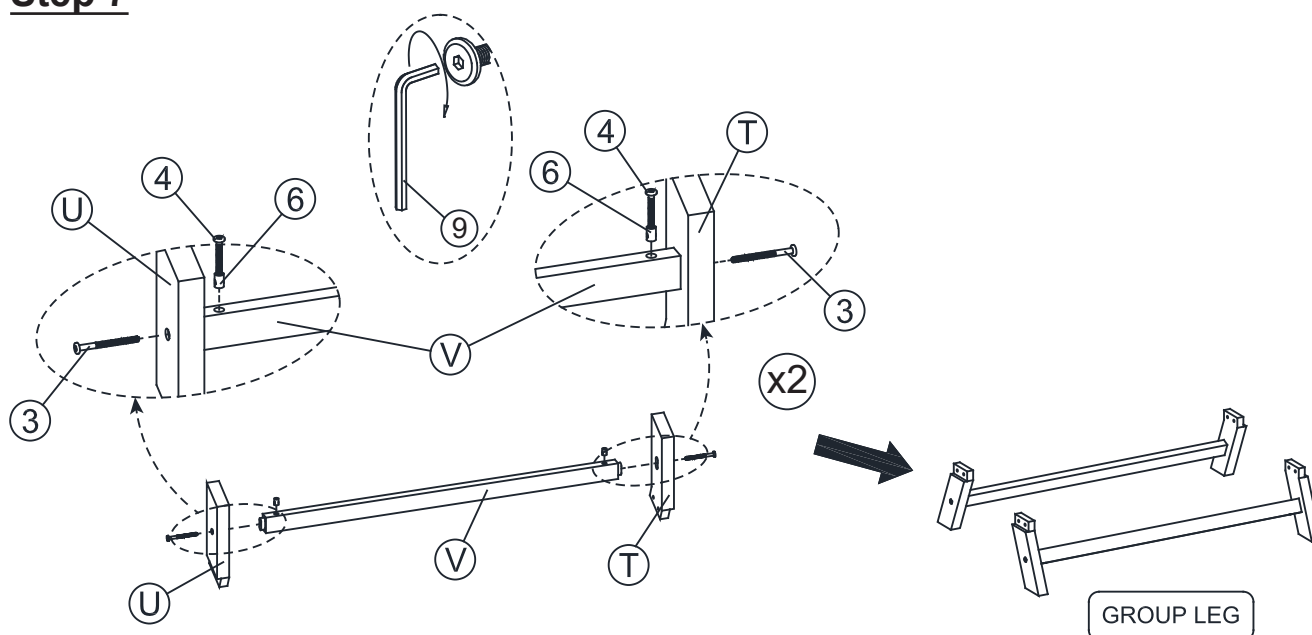
From Step 4, attach Head Bed Support Bar (K) and End Bed Support Bar (L) to assembled part in Step 4 using Insert Nut Wood ⑦ to locate.

Step 6



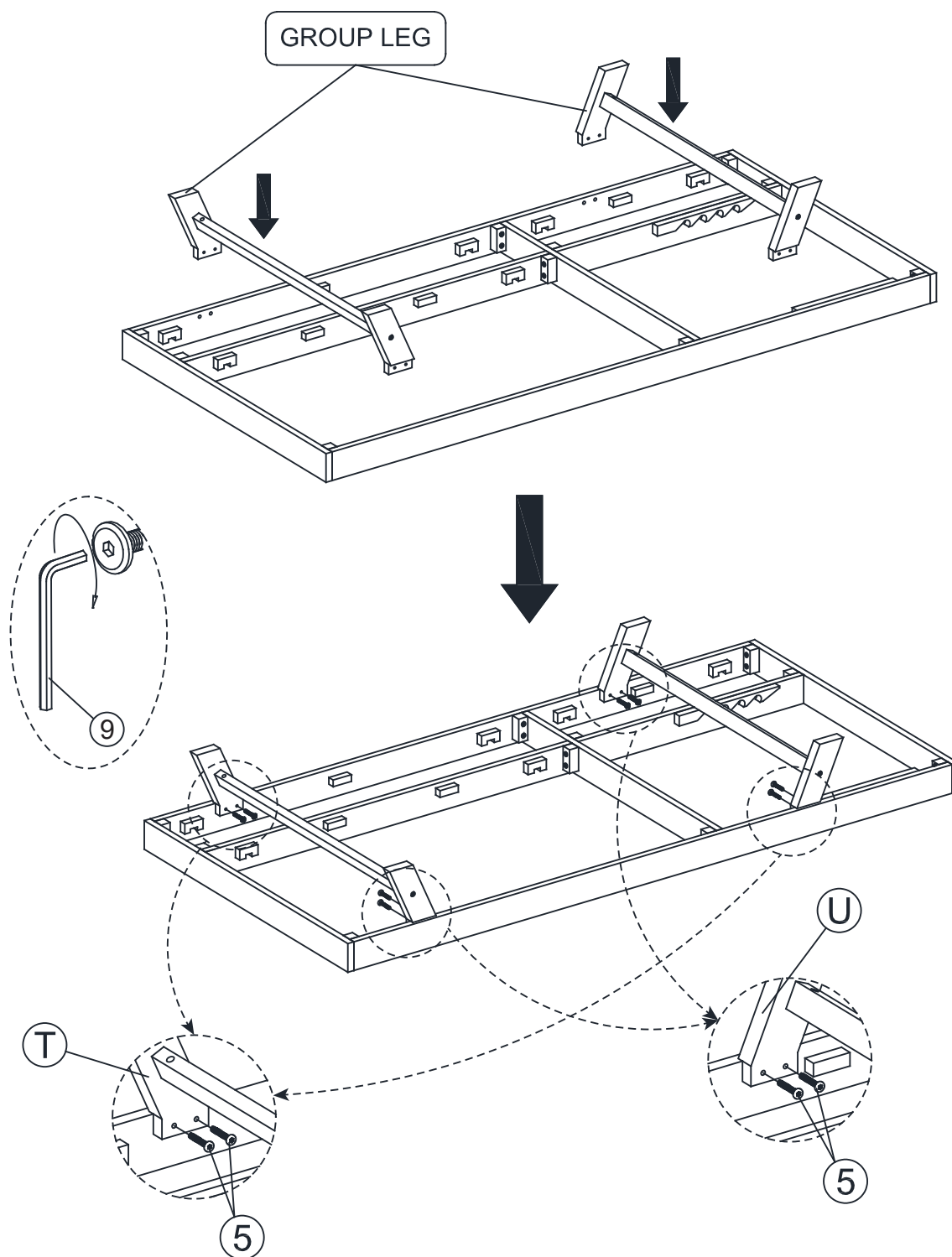
From Step 5, Assembled part in Step 5 using Bolt ④ and Allen Wrench ⑨.

Step 7



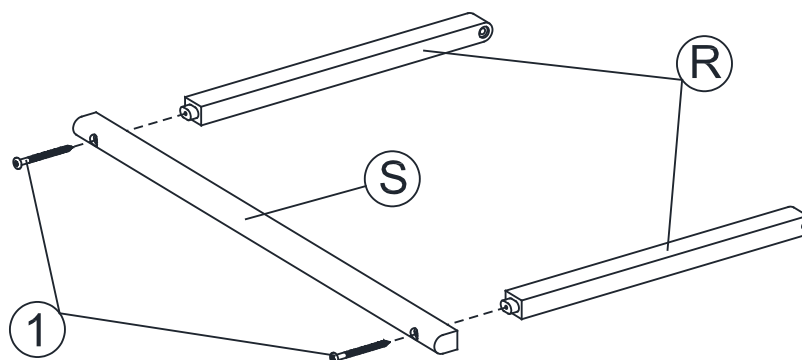
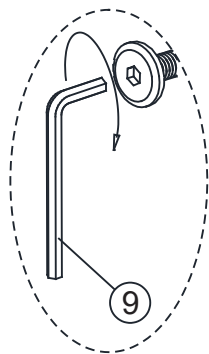
Position the tenon of Leg Support Bar (V) to the housing of Leg 1 (T) and Leg 2 (U). Attach the assembled part using Bolt ③, Bolt ④, Insert Nut ⑥ and Allen Wrench ⑨.

Step 8



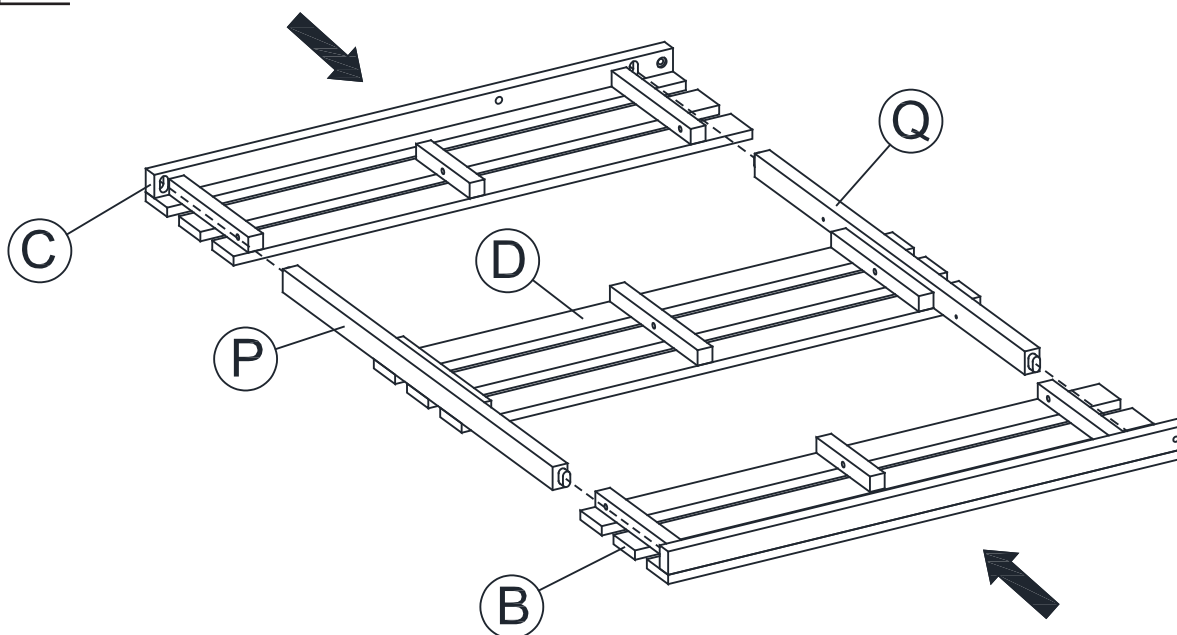
The attach the assembled part in Step 7 to assembled part in Step 6 using Screw ⑤ and Allen Wrench ⑨.

Step 9



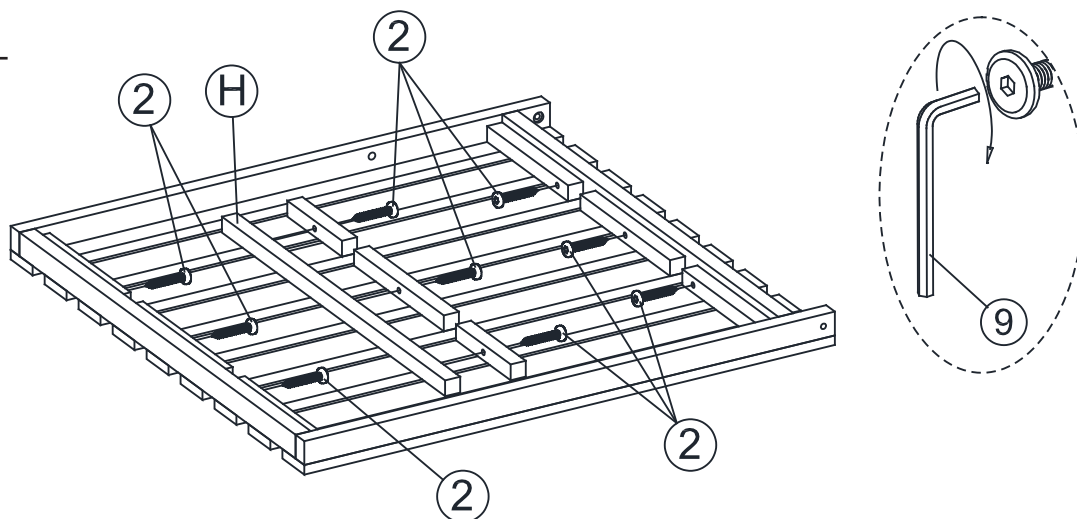
Position the tenon of Vertical Bar (R) to the housing of Horizontal Bar (S). Attach the assembled part in using Screw ① and Allen Wrench ⑨.

Step 10



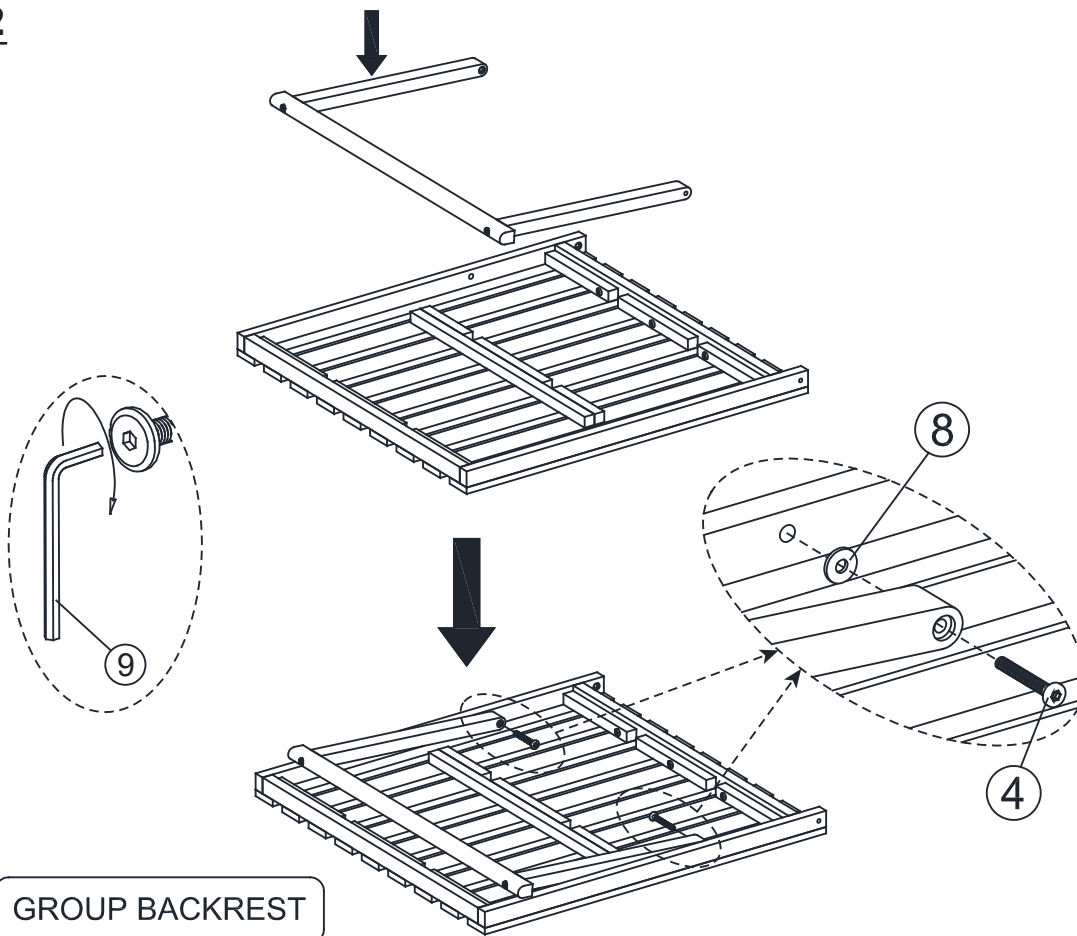
Place Left Backrest Frame (B), Middle Backrest Frame (D) and Right Backrest Frame (C) on a clean, non-marring surface. Position the tenon of Head Backrest Support Bar (P) and End Backrest Support Bar (Q) to the housing of Left Backrest Frame (B) and Right Backrest Frame (C).

Step 11



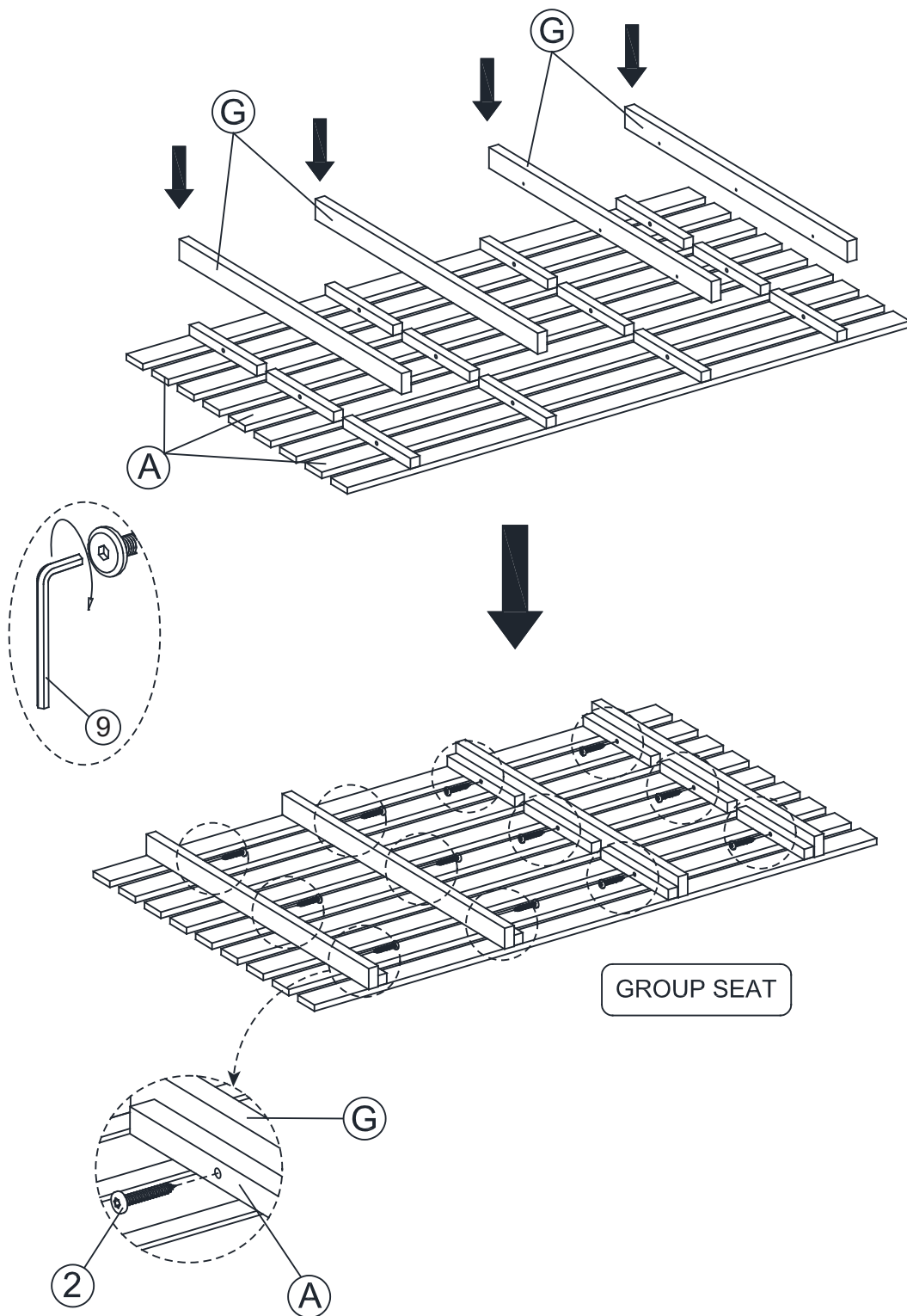
Attach the Middle Support Bar Backrest Frame (H) to assembled part in Step 10 using Screw (2) and Allen Wrench (9).

Step 12



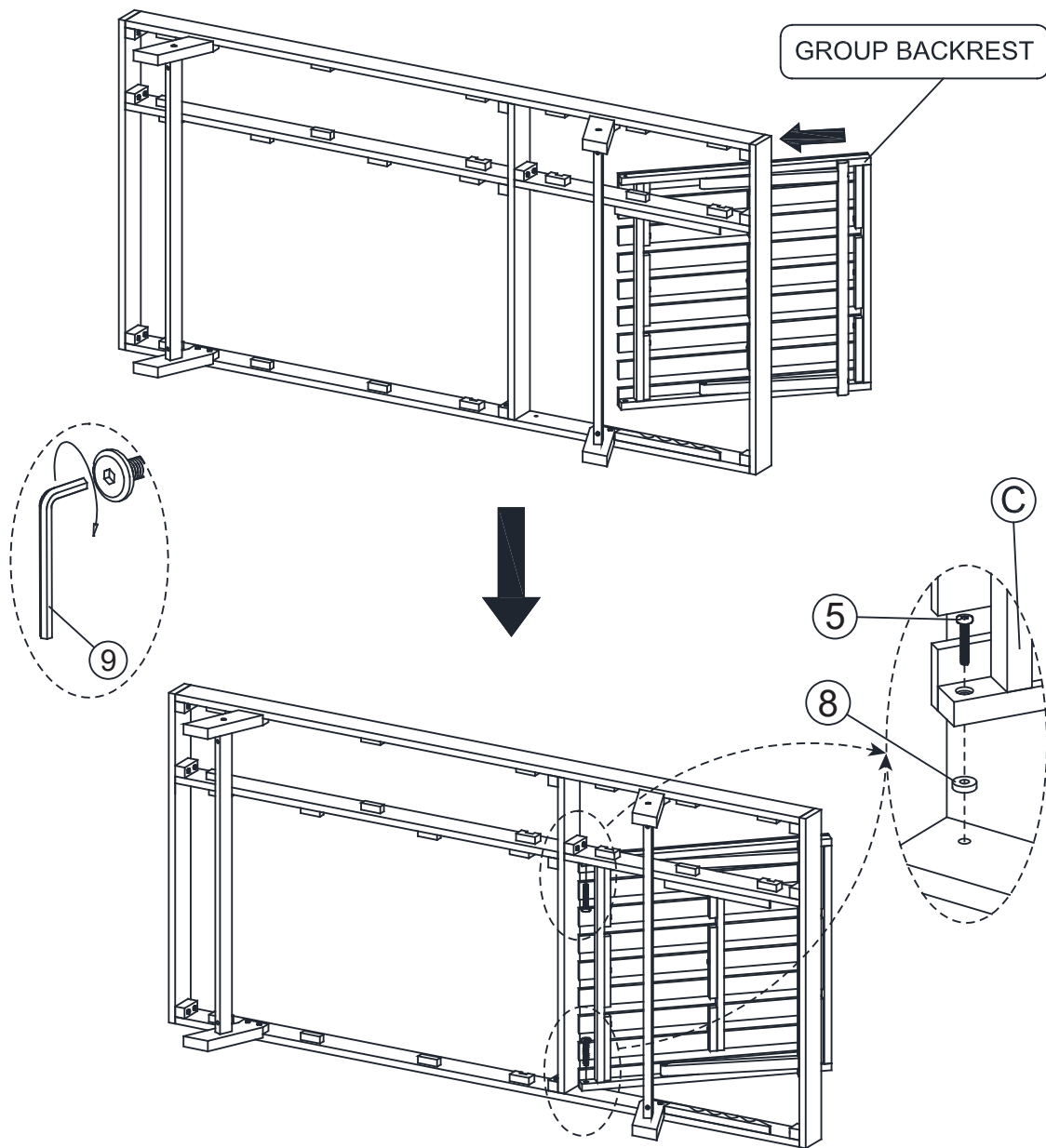
Attach the assembled part in Step 9 to assembled part in Step 11 using Bolt (4), Washer Plastic (8) and Allen Wrench (9).

Step 13



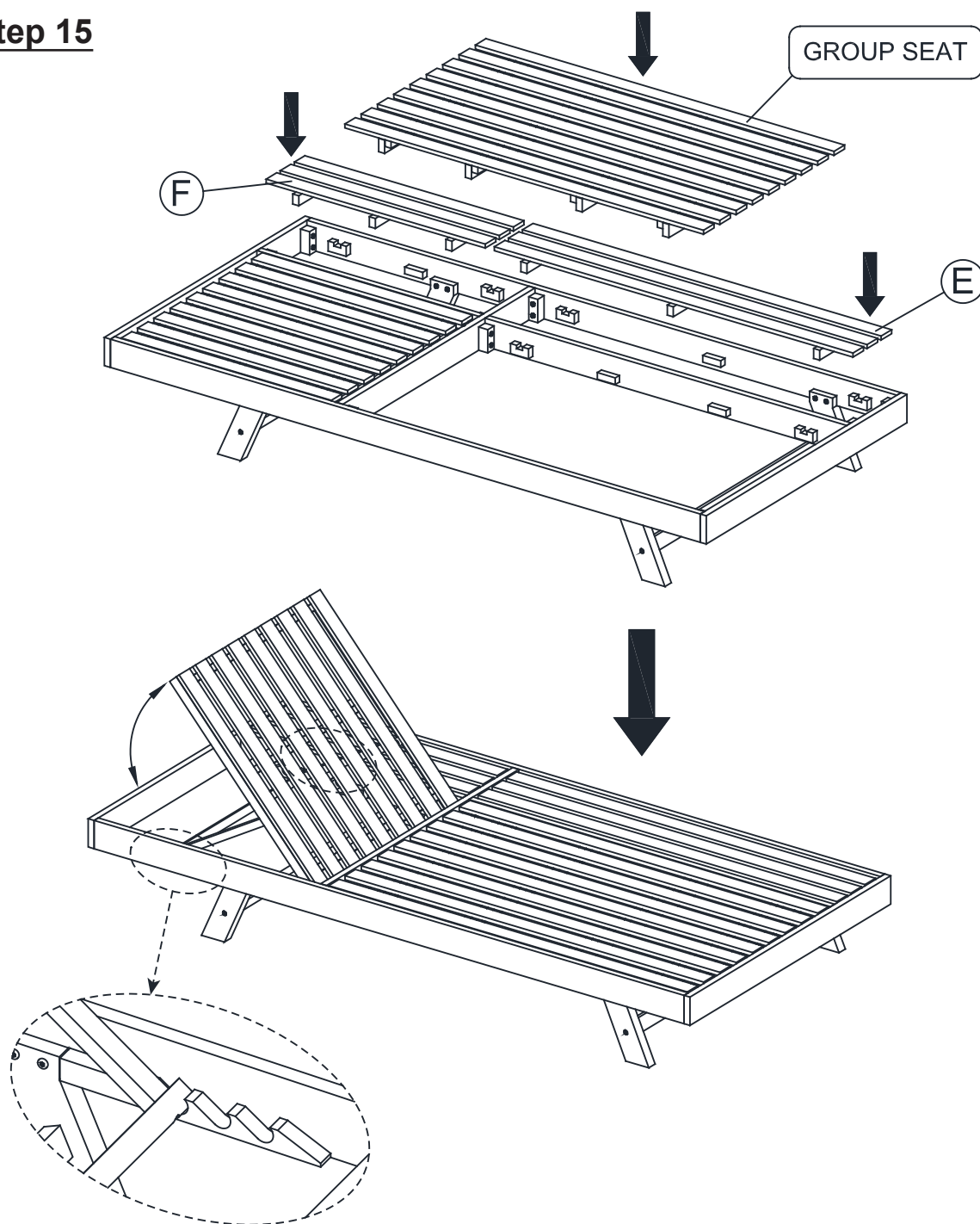
Attach 4 Support Bar Seat Frame (G) to 3 Seat Frame (A) using Screw ② and Allen Wrench ⑨.

Step 14



With the help of your adult partner, flip the assembled part in Step 8, then attach the assembled part in Step 14 to assembled part in Step 8 using Bolt ⑤, Washer Plastic ⑧ and Allen Wrench ⑨.

Step 15



With the help of your adult partner, flip the assembled part in Step 15, then attach Top Table Long (E), Top Table Short (F) and assembled part in Step 14 to assembled part in Step 15 as shown above. Your Chaise Lounge is ready for use.

This Chaise Lounge can only be used on a flat, level surface.

Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals. Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
