Stains may be removed with mild soap solution and damp cloth.




Keep away from sources of ignition.



• Do not assemble on flooring or carpet-




• Assemble on a clean non-marring surface (packing foam)-




Save all packaging until finished-


Assembly Steps



This Chair has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Chair parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.



Unpack and place all parts on a clean, non-marring surface.




With the help of your adult partner, align Front Support Bar (F) and Back Suport Bar (G) into Left Leg Panel (B) as shown above.

Then attach Left Leg Panel (B) to Front Support Bar (F) and Back Support Bar (G) by using 2 Screws (①) with Allen Wrench (③).

DO NOT fully tighten the Screws.

Step 3




With the help of your adult partner, align Backrest Panel (D) and Seat Panel (E) into Left Leg Panel (B) of the assembled part in Step 2 as shown above.

Then attach Left Leg Panel (B) to Backrest Panel (D) by using Screw (1) with Allen Wrench (3) and attach Left Leg Panel (B) to Seat Panel (E) by using Screw (2) with Allen Wrench (3).

DO NOT fully tighten the Screws.






With the help of your adult partner, align Right Leg Panel (A) into the assembled part in Step 3 as shown above.

Step 4.1, attach Right Leg Panel (A) to Backrest Panel (D) and Back Support Bar (G) by using 2 Screws (1) with Allen Wrench (13).

Step 4.2, attach Right Leg Panel (A) to Seat Panel (E) and Front Support Bar (F) by using Screw (①), Screw (②) with Allen Wrench (③).


DO NOT fully tighten the Screws.



With the help of your adult partner, secure Back Support Bar (G) to Seat Panel(E) by using 2 Screws (①) with Allen Wrench (③).

DO NOT fully tighten the Screws.





Inspect it and make sure all parts are adequately connected.

Turn the Chair right side up.

Gently and gracefully, sit onto the Chair.

This will help to align all the parts at all joint areas.

Then get off the Chair and in a sequential manner, gradually tighten all Screws at all joints until evenly connected.

If there are still wobbles, loosen the Screws and execute this same process.

Place the Seat Cushion (C) by affix the Magic Tape Straps on the Seat Panel (E) as shown above.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
