Care & Maintenance



Not for commercial use. For residential use only.



Do not put hot items directly on furniture surface.



Do not clean furniture with harsh cleansers or polish.



To obtain the longest lifespan of your outdoor products, minimizing exposure to direct sunlight is recommended.



Children should not climb or jump on the furniture.



Do not write on furniture without a padded barrier to protect the surface.



To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.



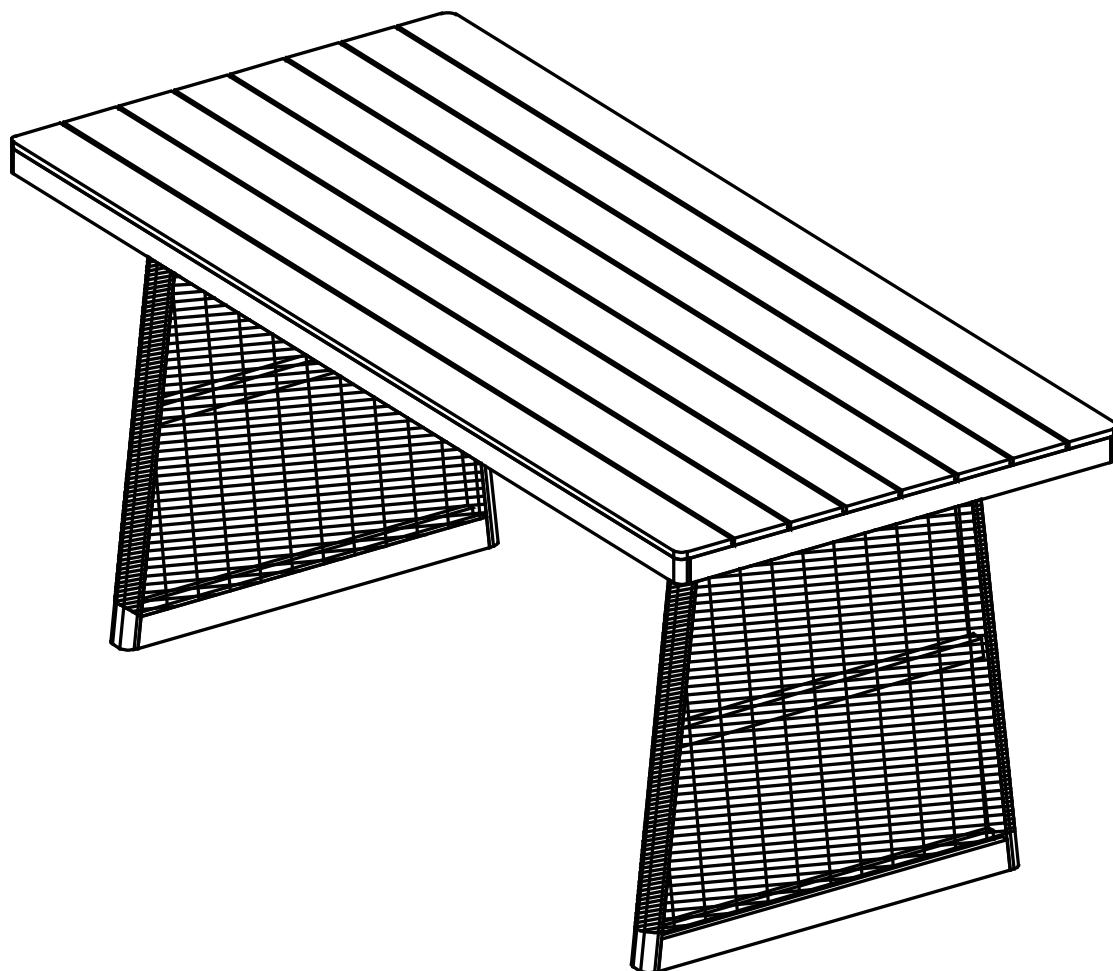
Stains may be removed with mild soap solution and damp cloth.



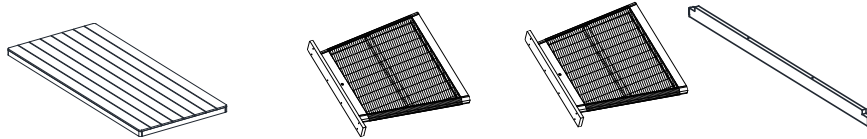

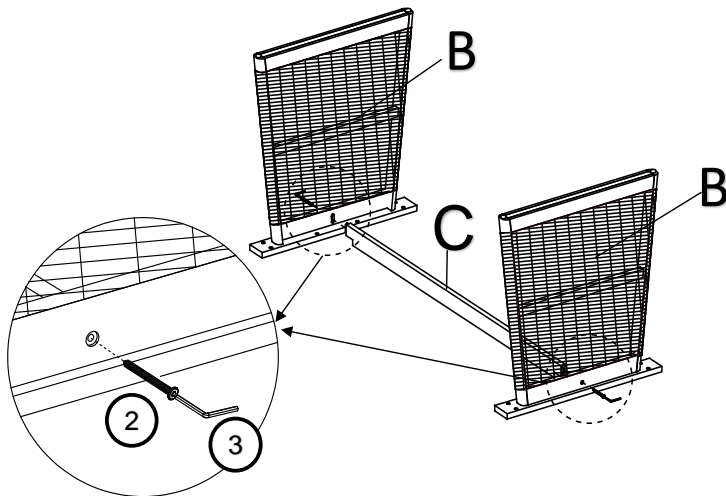
This Table has multiple parts and may require up to 30 minutes to assemble.
To give you an overview of the Table parts, the above picture is to help you put the various parts into perspective.
Please read through the instructions herebelow to familiarise yourself with the parts and steps before assembly.

Step 1



Unpack and place all parts on a clean, non-marring surface.

Step 2

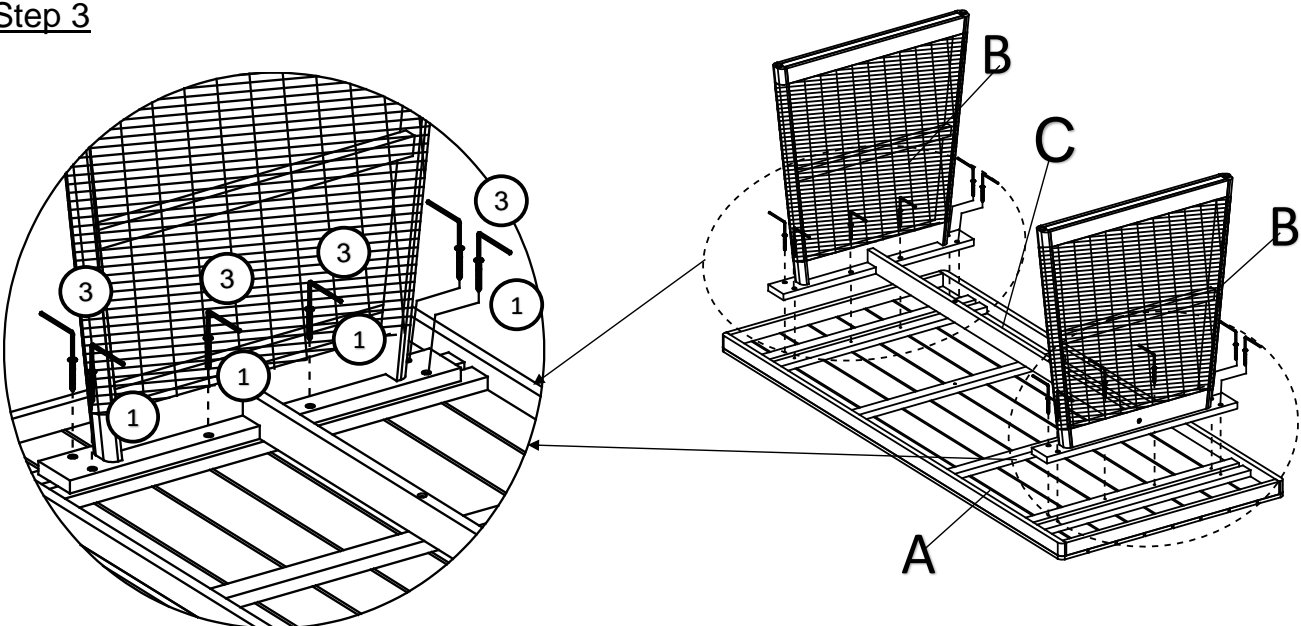


Place the Leg Panel (B) laid down as shown in the picture above onto a clean, soft surface to avoid any scratches or damage to the product. With assistance from your adult partner(s)

Insert dowel on Support Bar (C) into housing on Leg Panel (B). Attach the Support Bar (C) to the Leg panel (B), using 2 (two) Screws (②) and the Allen Wrench (③) as shown above.

DO NOT fully tighten the screws at this time.

Step 3

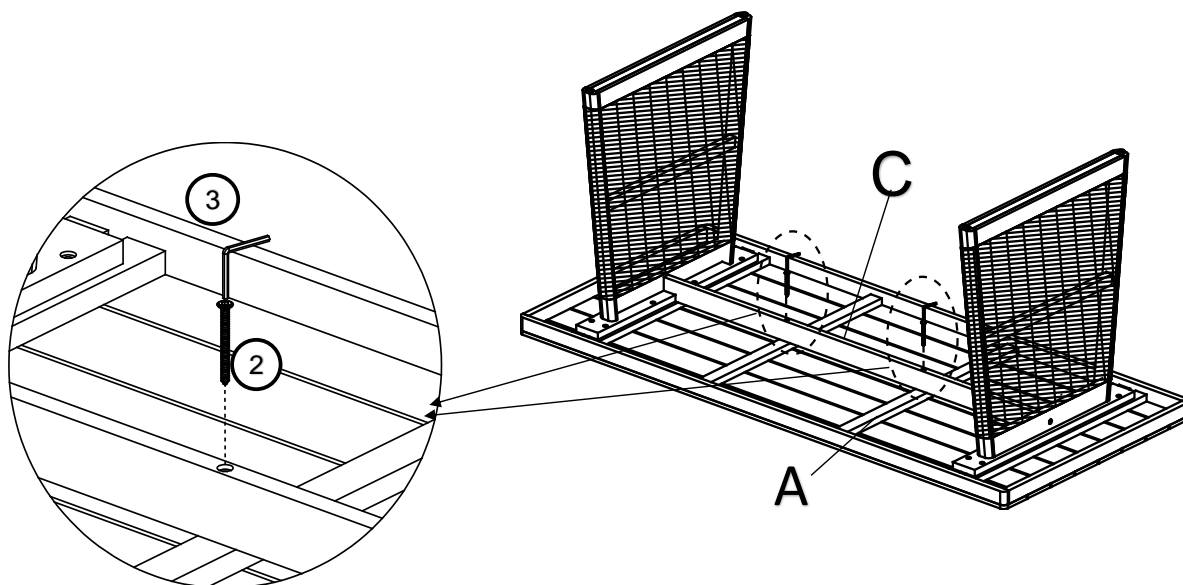


Place the table top (A) laid down as shown in the picture above onto a clean, soft surface to avoid any scratches or damage to the product. With assistance from your adult partner(s)

Insert dowel on leg panel (B) into housing on table top (A). Attach the leg panel (B) to the table top (A), using 12 (twelve) screws (①) and the Allen Wrench (③) as shown above.

DO NOT fully tighten the screws at this time.

Step 4



Flip the Table Top (A) (bottom-side up) and place it on a clean, soft surface to avoid any scratches or damage to the product.

Affix the Support Bar (C) into one of the mounting positions at the centre of the Table Top (A), then secure it using 2 (two) Screws (2) and Allen Wrench (3), as shown above.

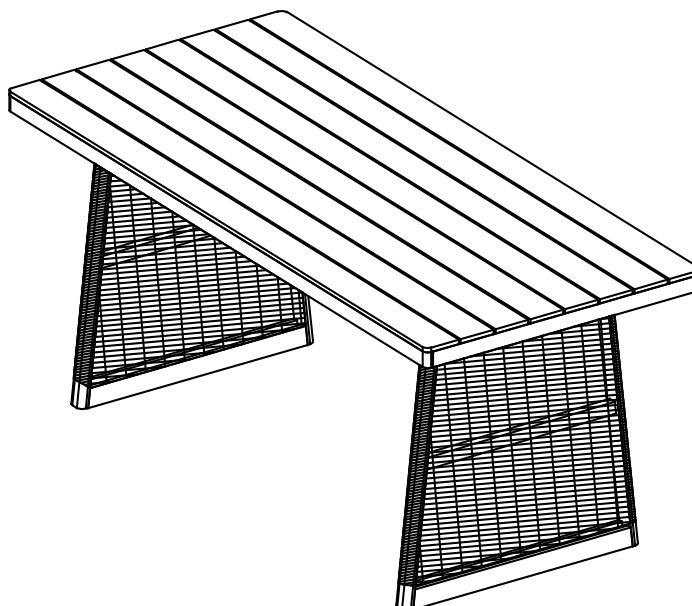
CAUTION: When tightening these Bolts, tighten sequentially.

DO NOT tighten any bolt fully and then move towards the next one.

This would cause the frame to warp.

WARNING!! IF THE TABLE IS NOT STABLE , IT COULD LEAD TO DAMAGING THE PRODUCT.

Step 5



Turn the Table right side up

Ensure all bolts are fully locked into position.

Your Table is ready to be used.

Caution: This Table can only be used on a flat, level surface.

Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
