




STOP!

Step 1:


* Insert Sixteen KD BOLT (1) to the UPPER LEFT PANEL (C), UPPER RIGHT PANEL (D), LOWER LEFT PANEL(I), LOWER RIGHT PANEL(J) and BETWEEN PANEL(B)



Step 2:


* Attach the LOWER LEFT PANEL(I) and LOWER RIGHT PANEL(J) to the BOTTOM PANEL (H) by the Six KD CAM (2) , Six COVER CAP (3) and Four WOOD DOWEL (4) .






Step 3:


- * Slide the LOWER BACK PANEL(L) to the stand.
- * Assemble the DOOR STOPPER(5) to the BETWEEN PANEL (B) by the SCREW (7) .


* Attach the BETWEEN PANEL(B) to the LOWER LEFT PANEL(I) and LOWER RIGHT PANEL(J) by the Six Screw(12), Four WOOD DOWEL (4) and LOCK(13).






Step 5:

* Attach the UPPER LEFT PANEL(C) and UPPER RIGHT PANEL(D) to the FIX SHELF PANEL(F) by the Four KD CAM (2) , Four COVER CAP (3) and Four WOOD DOWEL (4) .






Step 6:






* Attach the UPPER BACK PANEL (K) to the stand by Screw(6).








Step 9:

* Insert Twenty-two PLASTIC WEDGE(10) and Twenty-two SCREW(18) to the UPPER BACK PANEL(K) and LOWER BACK PANEL(L).







Step 10:

* Assemble the HINGE(8) to the LEFT DOOR (M) and RIGHT DOOR (N) with the SCREW (9) .






* Attach the LEFT DOOR (M) and RIGHT DOOR (N) to the stand with SCREW (9) .






* Input the Two UPPER SHELF PANEL(E) and LOWER SHELF PANEL(G)

Step 14:


1st- With your pencil, strike a mark through the center of the hole in the SAFETY STRAP.

2nd- Drill a 3/8" hole on the mark.

3rd- FURNITURE TIPPING RESTRAINT KIT (17) into the hole until it is even with the surface of the wall.

4th- Turn the LONG SCREW through the hole in the SAFETY STRAP and into the WALL ANCHOR.

NOTE: You will need to turn the LONG SCREW multiple turns to completely tighten
