












# Assembly Instructions

Caution : You must read this before you proceed

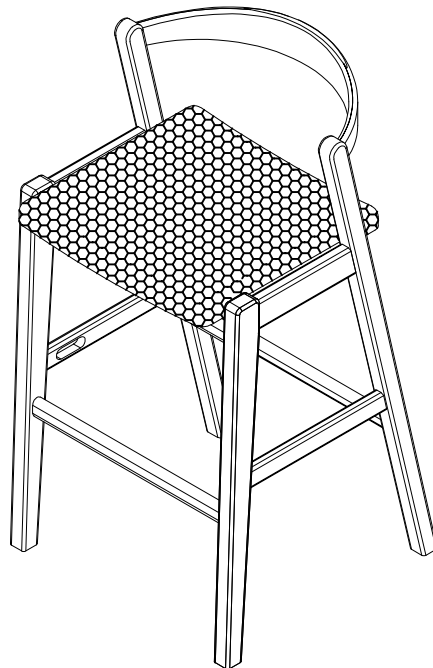
## Care & Maintenance

-  Not for commercial use. For residential use only.
-  Furniture may scratch floors. We recommend using furniture pads to protect your floors.
-  Do not put hot items directly on furniture surface.
-  Do not clean furniture with harsh cleansers or polish.
-  Do not place furniture under direct sunlight.
-  Do not place furniture near heating or cooling vents.
-  Do not write on furniture without a padded barrier to protect the surface.
-  Do not place furniture outside . For indoor use only.
-  Stains may be removed with mild soap solution and damp cloth.
-  Children should not climb or jump on the furniture.
-  Dust and pick-up spills using a clean, non-colored, lint-free cloth.

Please look in Seat frame for hardware packs and legs.





Sets often ship in multiple boxes and may arrive a day or two apart.

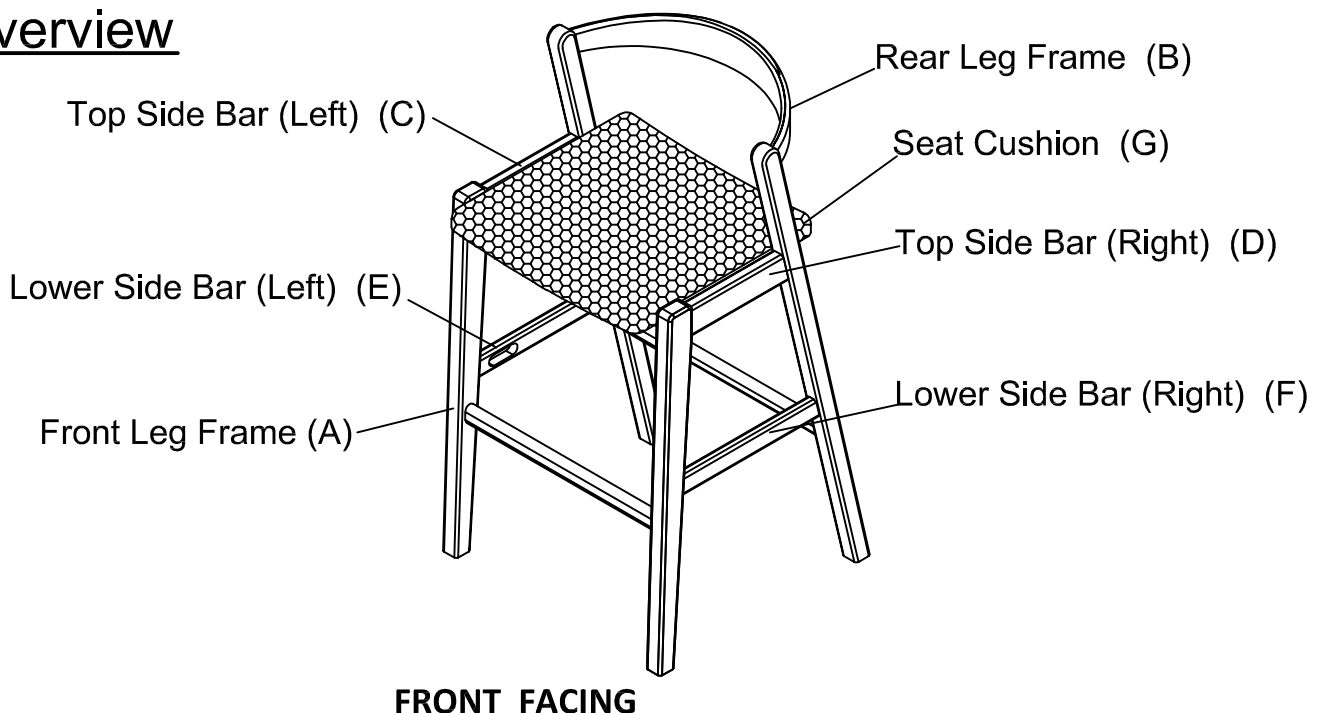
- Assemble on a clean non-marring surface (packing foam)-

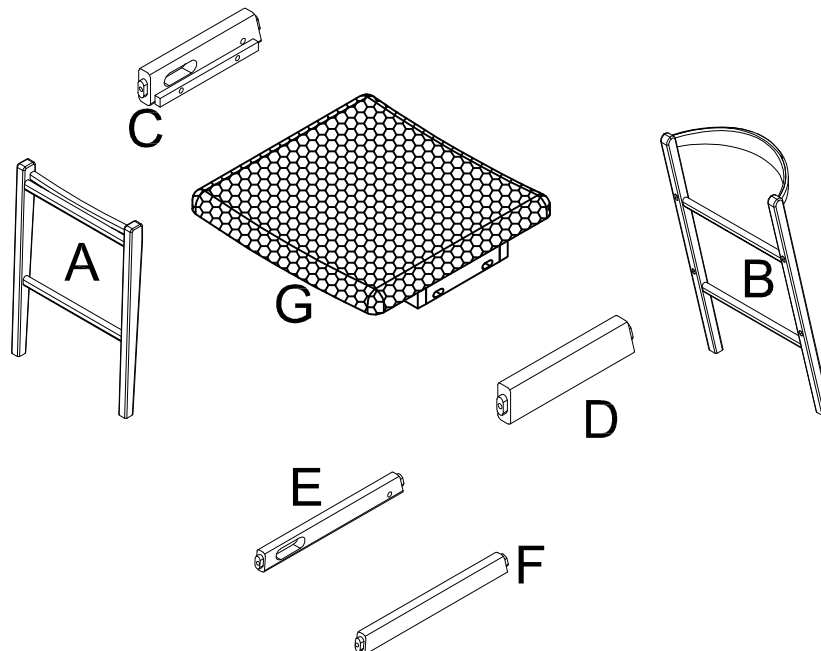
## Assembly Steps

### Overview



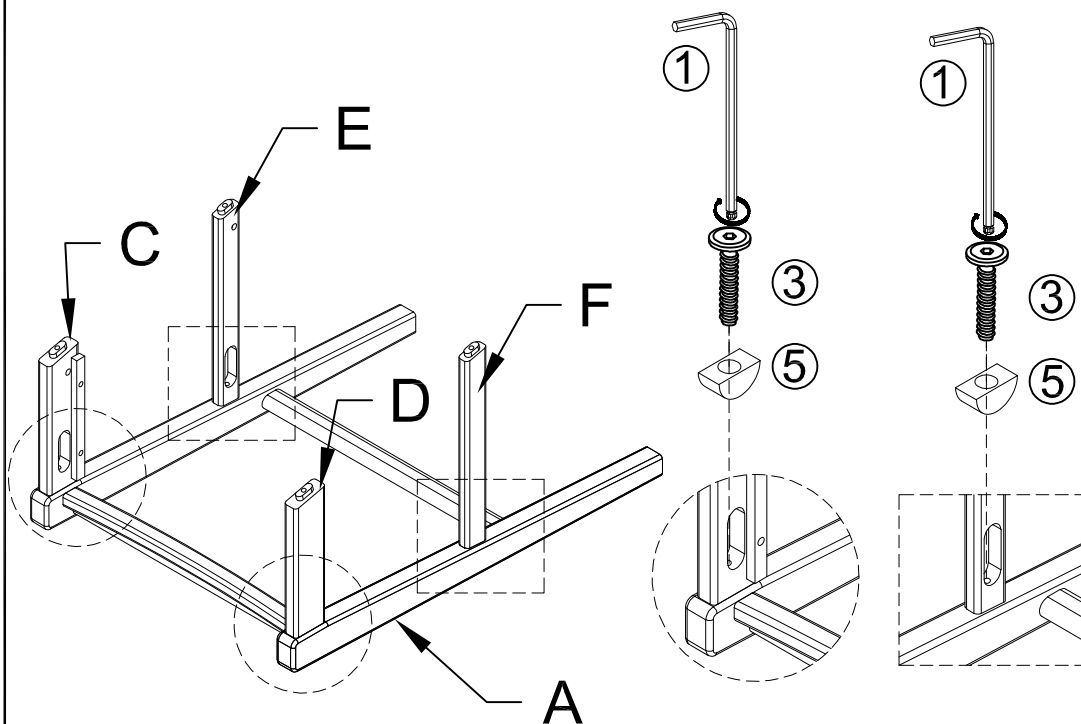
This Bar Stool has multiple parts and may require up to some 30 minutes to assemble. To give you an overview of the chair parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

## Step 1



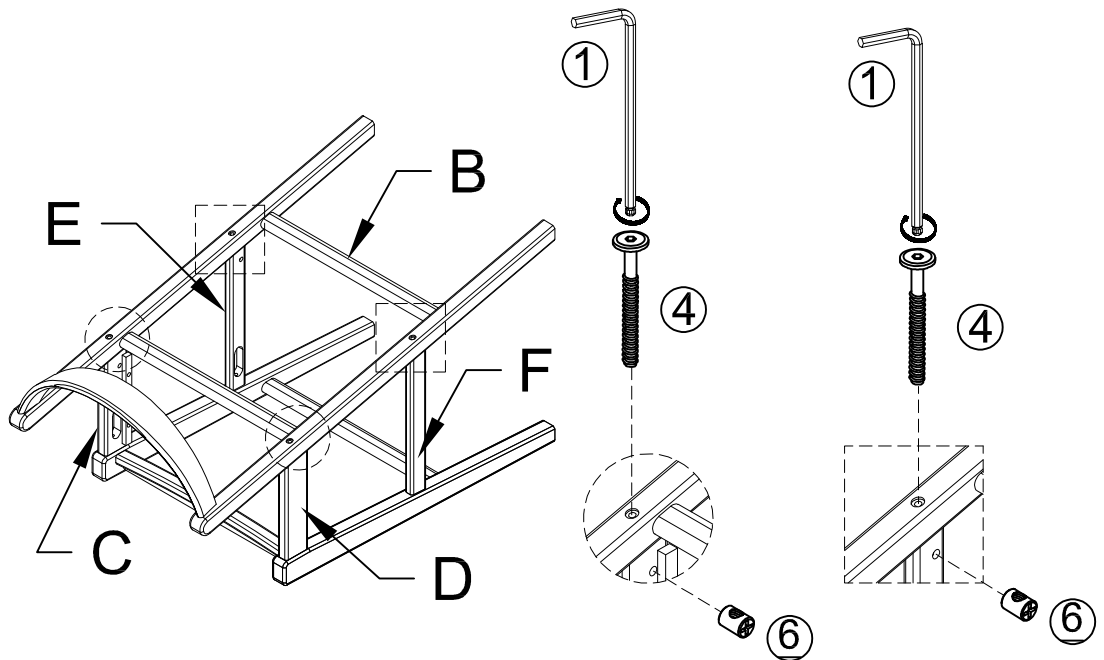
Place all Parts on a clean and flat surface.

## Step 2



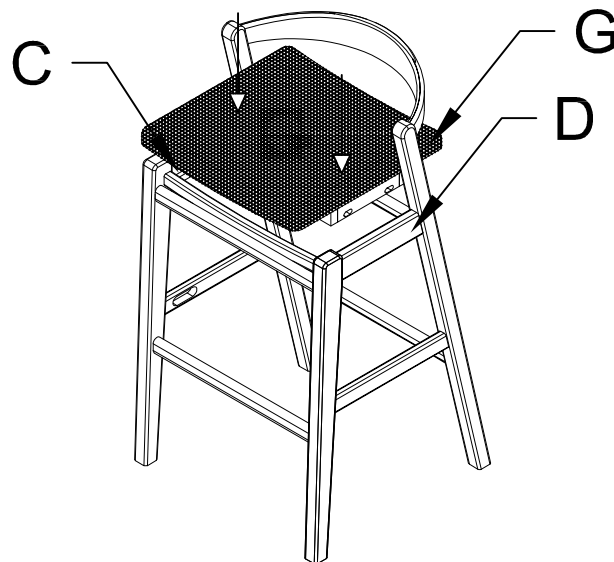
Install the Top side bar (left) (C), Top side bar (right) (D), Lower side bar (left) (E), Lower side bar (right) (F) into the Front Leg Frame (A) using the Allen Wrench (①), Bolts (③), Halfmoon washer (⑤), as pictured above. Tighten the Bolts.

### Step 3



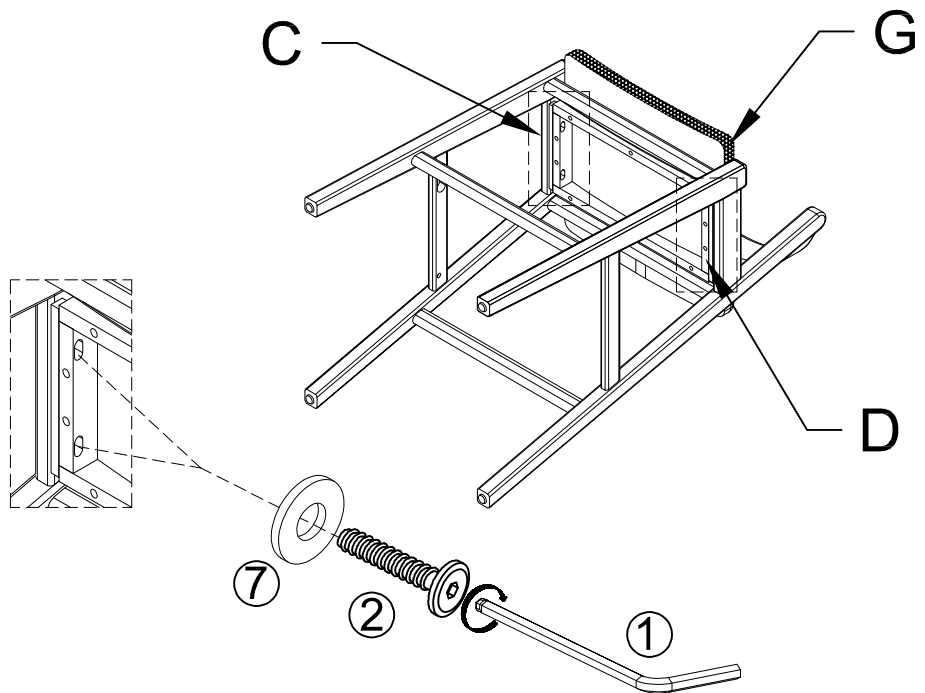
Connect the Rear Leg Frame (B) into the Top side bar (left) (C), Top side bar (right) (D), Lower side bar (left) (E), Lower side bar (right) (F) using the Allen Wrench (①), Bolts (④), Horizontal-Hole bolt (⑥). Tighten the Bolts.

### Step 4



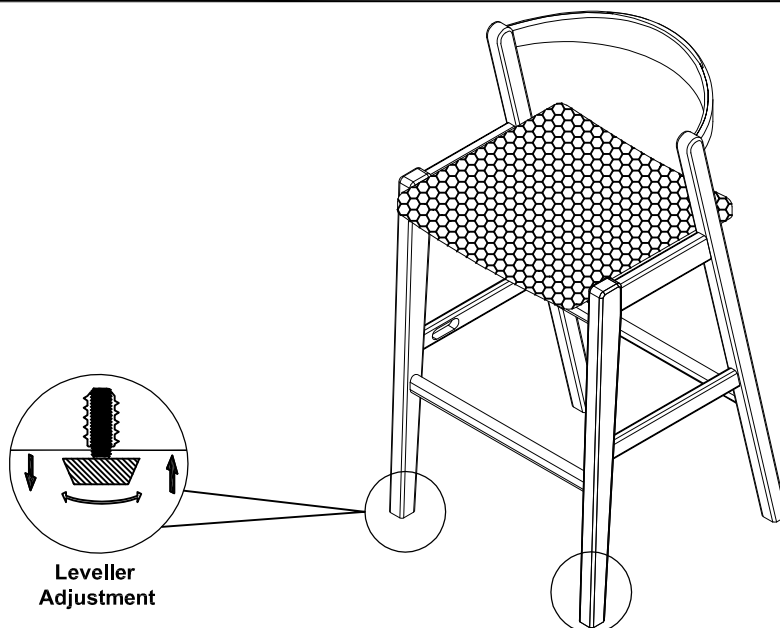
Place the Seat Cushion (G) into the Top side bar (left) (C), Top side bar (right) (D), so that the drilled holes of the Seat Cushion (G) coincide with Top side bar (left) (C), Top side bar (right) (D)

## Step 5



Use the Allen Wrench (①), Bolts (②), Flat washer (⑦) to affix the Seat Cushion with Top side bar (left) (C), Top side bar (right) (D). Tighten the Bolts.

## Step 6



Your Bar Stool is ready for use.  
This Bar Stool can only be used on a flat, level surface.

## Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
