 Stains may be removed with mild soap solution and damp cloth.




Children should not climb or jump on the furniture.

Please look in boxes for hardware packs and legs. Sets often ship in multiple boxes and may arrive a day or two apart.







Assembly Steps




This Chair has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Chair parts, the above picture is provided to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Friendly reminder: Tighten all the screws after all holes are installed.




Open the carton, and place all parts on a clean, non-marring surface.

Take out Seat(B) and Front Leg(C), face down the Seat(B) on the surface. Insert the Front Leg(C) into the hole on the front of Seat. Using Bolt(3), Spring Washer(4), Flat Washer(5) with Allen Wrench(7) to tighten it .




Take out Back Leg(D).Insert the Back Leg(D) into the hole on the back of Seat. Using Bolt(3), Spring Washer(4), Flat Washer(5) with Allen Wrench(7) to lock it. **Do not Fully Tighten all the Bolts.**




Take out Backrest(A), assign the hole of Backrest(A) with Back Leg(D). Using Bolt(①) with Allen Wrench(⑦) to tighten the hole on the top.

Using Bolt(2) with Allen Wrench(7) to tighten the hole in the second row.



Then turn the chair over to reveal the bottom frame. Fully tighten all the bolt of Step 2.





Place the Chair right side up and tested for stability.

Fully Tighten all the bolts.

Your Chair is ready for use.

This CHAIR can only be used on a flat, level surface.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
