 Stains may be removed with mild soap solution and damp cloth.




Children should not climb or jump on the furniture.



Do not assemble on flooring or carpet-




Assemble on a clean non-marring surface (packing foam)-



Assembly Steps




This Ottoman has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the ottoman parts, the above picture is provided to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.




Open the carton, and place all parts on a clean, non-marring surface.

Take out Ottoman(A), face down it on the surface. Unzip the bottom of ottoman to expose the bottom, then insert the hanging Magic Tape into the bottom frame first, don't covering the holes at the bottom.




Insert Bolt(1) into Flat Washer(3)


First, push the screw upward from the bottom of frame, and push the screw upward by hand. Then take out Leg(B), there is a hole of leg(B) in the black circle as shown. Connect the exposed screw at the bottom to this hole, lock the bolt with Allen Wrench(⑤). Do not Fully Tighten all the Bolts.



Take out L-shaped angle iron(4), attach it to the hole of leg, use bolt(2) and Flat Washer(3) with Allen Wrench(5) to lock it as shown. Do not Fully Tighten all the Bolts.



Repeat step 3 to Install the other leg. Then tighten all the bolt.



Zip up the bottom the Seat.

Place the Chair right side up and tested for stability.

Your Ottoman is ready for use. This Ottoman can only be used on a flat, level surface.

Questions & Answers about Proposition 65

• What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

• What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
