- Furniture may scratch floors. We recommend using furniture pads to protect your floors.

- Do not put hot items directly on furniture surface.

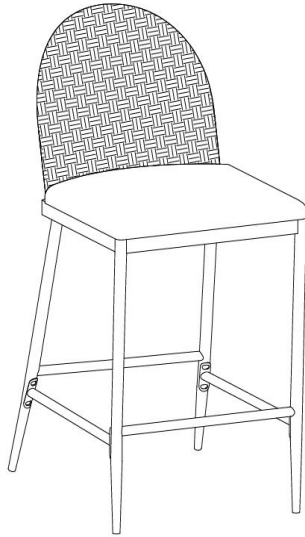


- Dust and pick-up spills using a clean, non-colored, lint-free cloth.

Sets often ship in multiple boxes and may arrive a day or two apart.

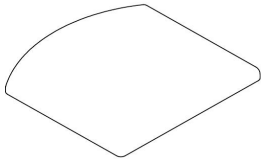

Overview



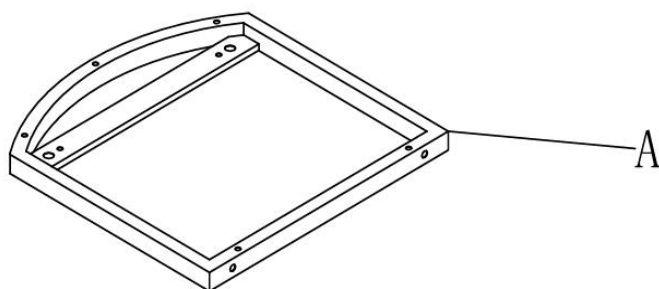
This Counter Stool has multiple parts and may require up to 30 minutes to assemble.

To give you an overview of the Counter Stool parts, the above picture is to help you put the various parts into perspective. Please read through the instructions herebelow to familiarise yourself with the parts and steps before assembly.

Open the carton and place all the parts onto a clean, non-marring surface.

Place Seat Panel Frame (A) on the ground, as shown in picture above.

Placez Cadre de panneau de-sp (A) au sol, comme le montre l'image ci-dessus.

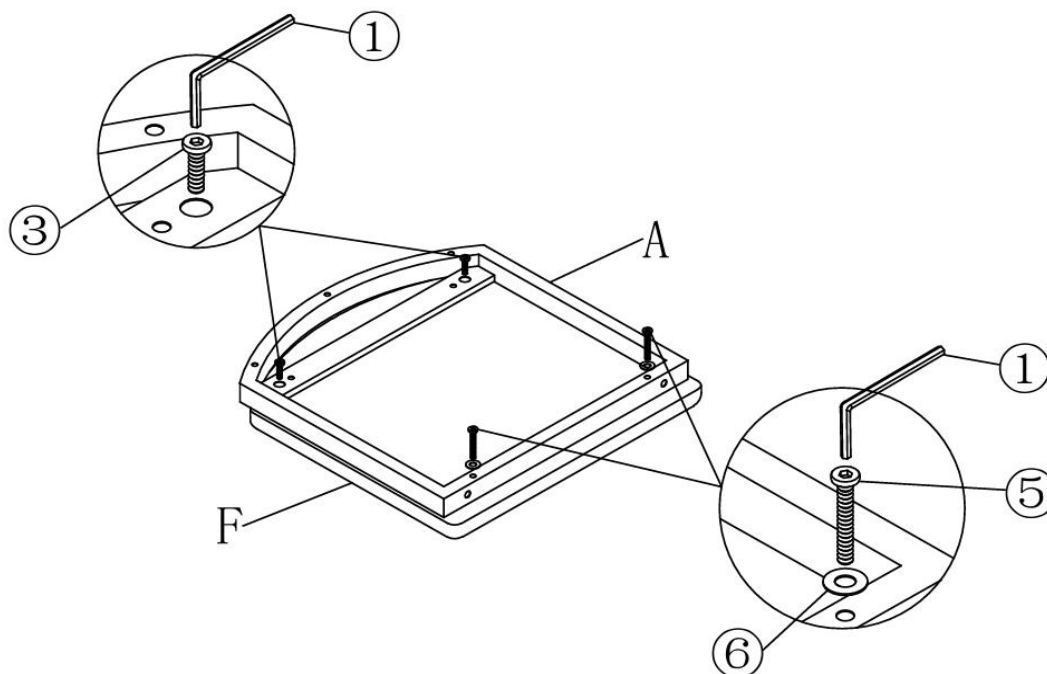

Attach Seat Panel Frame (A) to the Seat Panel (F) using Bolts (③), Bolt (⑤) and Washer (⑥) with Allen Wrench(①).

TIGHTEN ALL THE BOLTS.

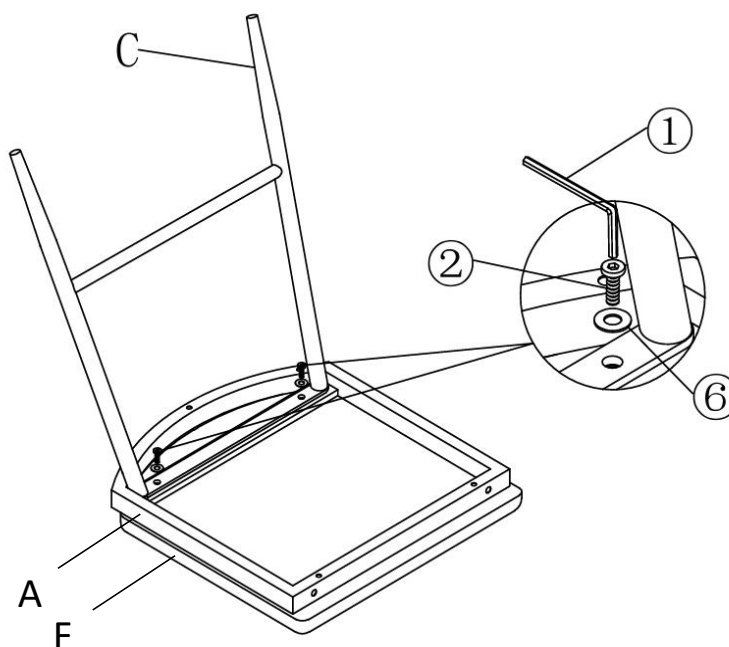

Attach the Hind Leg (C) to the Partially assembled Seat Panel (F) and Seat Panel Frame (A) using Bolts (②) and Washer (⑥) with Allen Wrench(①).

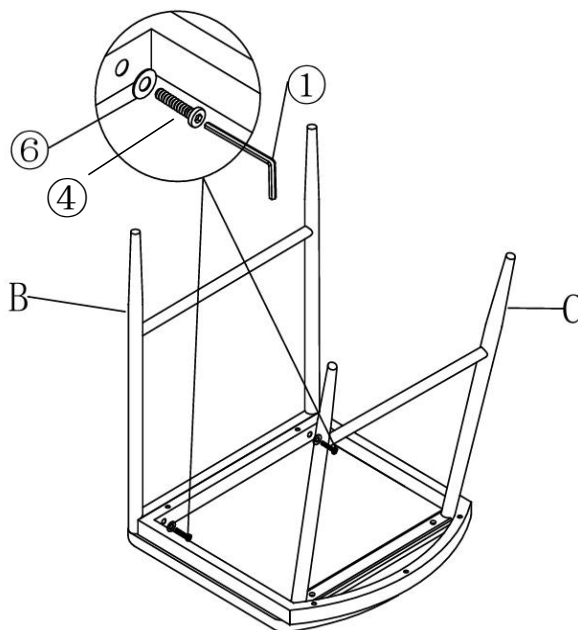

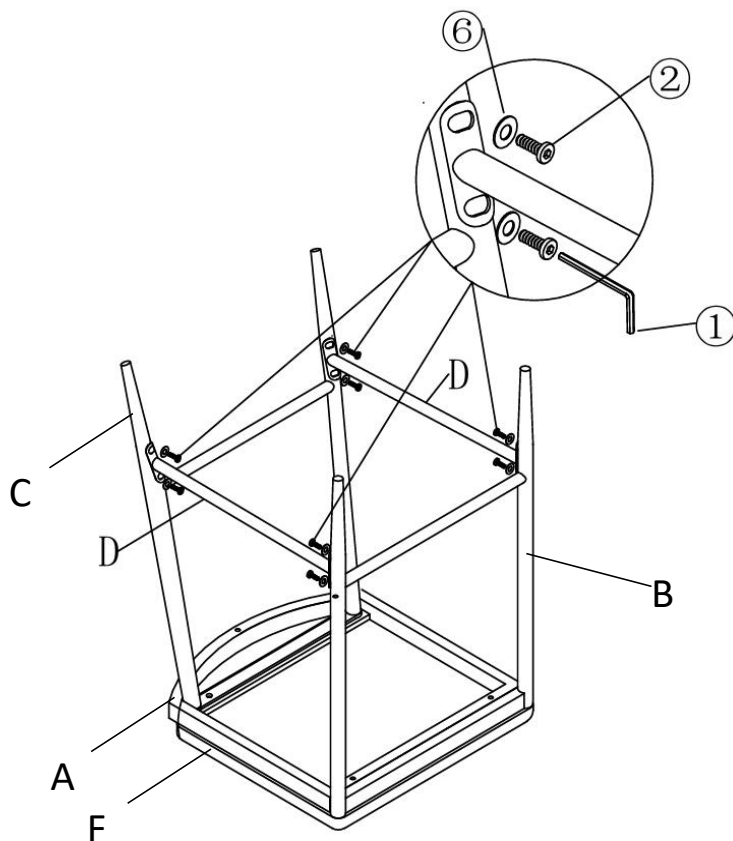

Assemble the Legs Connection Pole (D) using Bolts (②) and Washer (⑥) with Allen Wrench(①) as shown above.

DO NOT FULLY TIGHTEN THE BOLTS.

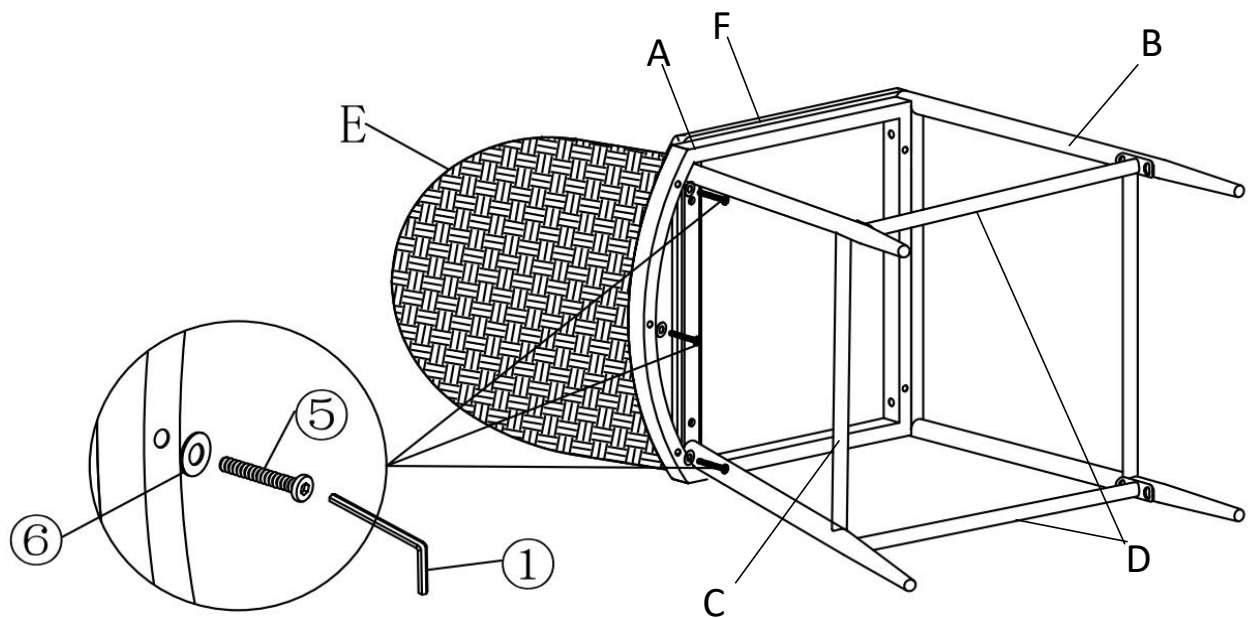

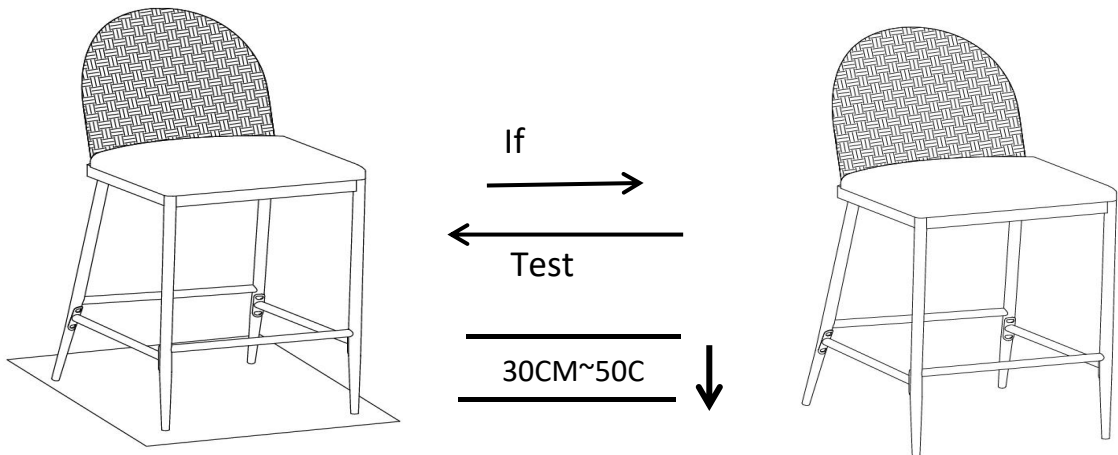


Turn over part of step 2 with the assistant of your adult partner.
Attach the Back Rest (E) to the Seat Panel (C) using Bolts(⑤) and Washer (⑥) with Allen Wrenc(①).
DO NOT FULLY TIGHTEN THE BOLTS.

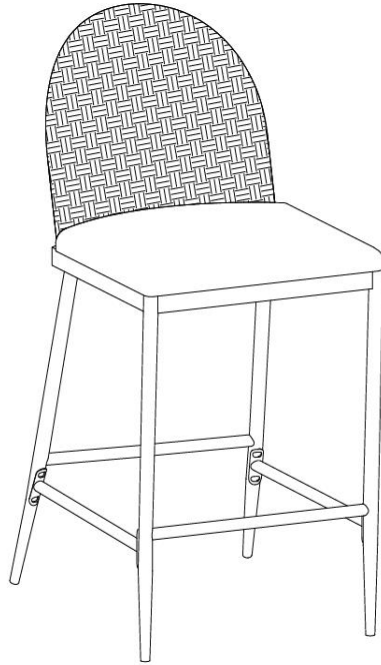
Place the Counter Stool on a **LEVEL SURFACE** to check for wobbles.
If it wobbles, lift the Counter Stool to some 30cm to 50cm in height from the ground.
Keep your feet and toes well away from the drop zone.
Drop the Counter Stool freely and vertically with the four legs, hitting the ground, all at the same time.
This Drop Test will help to ensure that all the bolts and gaps all reach full alignment status.
Test again for evenness on a **LEVEL SURFACE**.
If no wobbles are found, slowly and steadily turn the Counter Stool upside down.
Then, proceed to tighten all bolts in a sequential manner.

CAUTION: When tightening these bolts, tighten sequentially.
DO NOT tighten any screw fully and then towards the next one.
This would cause the frame to warp.

If there is still wobbles, loosen the bolts and execute these same drop tests.

WARNING!! IF Counter Stool IS NOT STABLE, IT COULD LEAD TO DAMAGING THE PRODUCT.

Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm.

These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
