 Do not write on furniture without a padded barrier to protect the surface.



 To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.




 Stains may be removed with mild soap solution and damp cloth.



 Dust and pick-up spills using a clean, non-colored, lintfree cloth.




Assembly Steps

Overview




This <u>Bench</u> has multiple parts and may require up to some <u>30</u> minutes to assemble. To give you an overview of the bench parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1



Lay the Bench Top(A) facedown, onto a clean, non-marring surface.

Step 2




Attach one of Iron Connect Sheet(B) to one of the Bench Legs(C) using Bolts(2) and Washer Flat (1)with Allen Wrench(5).

Pay attention: The right on the iron sheet must be face to bottom of Table top;and back face to Legs.

Repeat this method to assemble the remaining of Bench legs.


Tighten bolts.

Step 3




Turn the pre-assembled Bench Legs(C) and Iron Connect Sheet(B) facedown, onto a clean, non-marring surface.

Step 4




Attach one of pre-assembled Bench Legs(C) and Iron Connect Sheet(B) using Bolts(3) and Washer Flat (4)with Allen Wrench(5). Loosly tighten bolts.

Step 5



Repeat Step 4 to assemble the remaining of Bench legs. **Tighten all bolts.**


Step 6



Stick three piece Eva pad(4) to the bottom of each Legs(C) to avoid scratching the floor.

Stand the Bench up.

Step 7



Your Bench is ready for use.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list? The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.
- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
