Sofa Overall Assembly Drawing

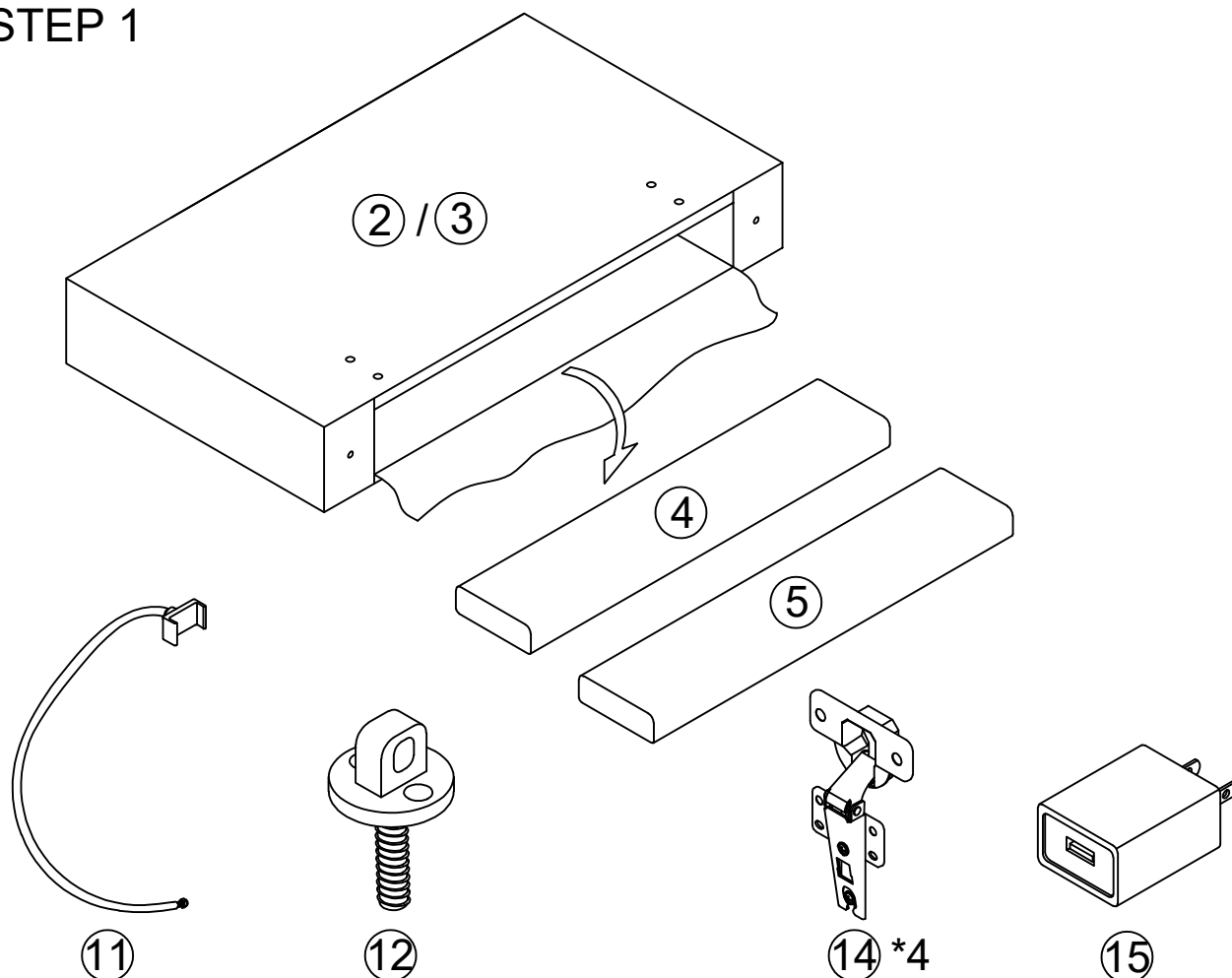
