





Assembly Steps




This Bar Stool has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Bar Stool parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.





Attach the Swivel (D) to Cross Ring (C) using the Washer (③), Bolt (①) with Allen Wrench (④) as shown above.


Do not fully tighten the Bolts.



Place Seat Part (A) face down on a non-marring surface.


Attach the Cross Ring (C) to Seat (A) using the Washer (③) and Bolt (①) with Allen Wrench (④) as shown above.

Do not fully tighten the Bolts.




Attach the Leg (E) to assembled frame using the Washer (③) and Bolt (①) with Allen Wrench (④) as shown above.

Do not fully tighten the Bolts.




Attach the Pedal (B) to Leg (E) using the Bolt (②) with Allen Wrench (④) as shown above.

Inspect the assembly and make sure all parts are adequately connected. Fully Tighten all the Bolts.



Stand the Bar Stool up carefully.
Place the Bar Stool on a LEVEL SURFACE to check for wobbling.
Adjust the levelers on the legs to ensure Bar Stool stability.



Your Bar Stool is ready for use.

The Bar Stool can only be used on a flat, level surface.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle • What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
