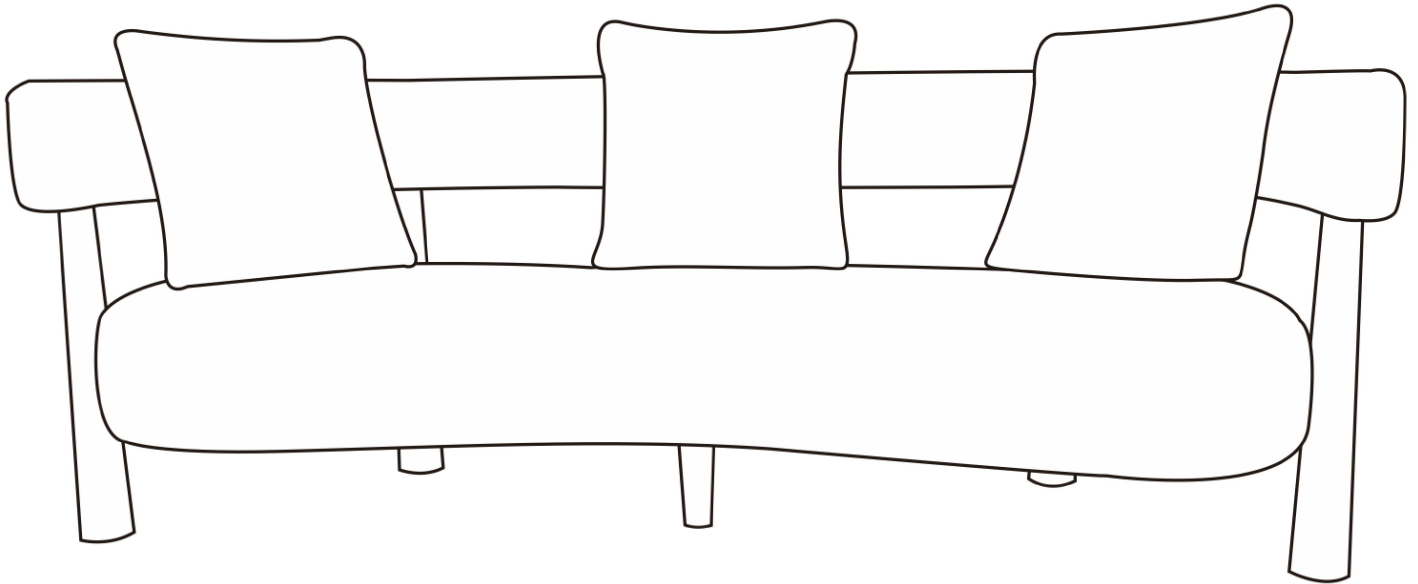

Care & Maintenance




-  Not for commercial use. For residential use only.
-  Furniture may scratch floors. We recommend using furniture pads to protect your floors.
-  Do not put hot items directly on furniture surface.
-  Do not clean furniture with harsh cleansers or polish.
-  Do not place furniture under direct sunlight.
-  Do not place furniture near heating or cooling vents.
-  Do not write on furniture without a padded barrier to protect the surface.
-  Do not place furniture outside . For indoor use only.
-  Stains may be removed with mild soap solution and damp cloth.
-  Children should not climb or jump on the furniture.
-  Dust and pick-up spills using a clean, non-colored, lint-free cloth.




Assembly Steps

Overview



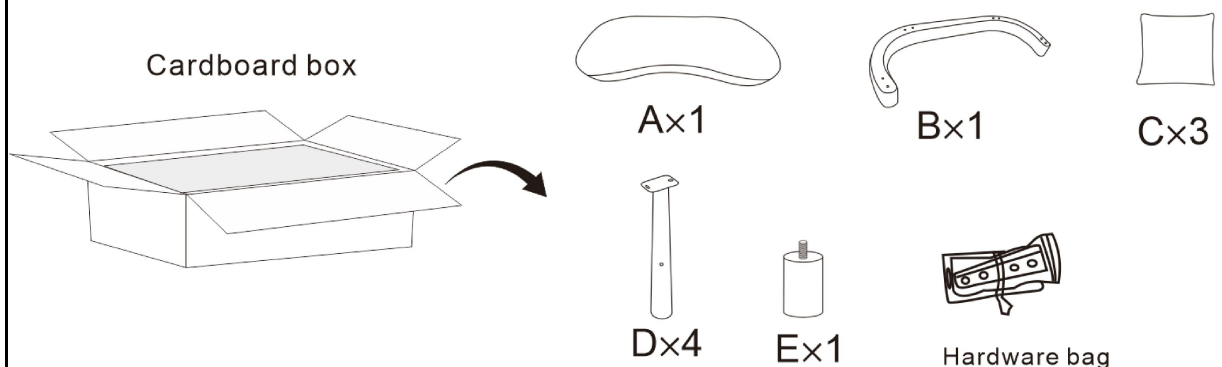
This 3-Seater Sofa has multiple parts and may require up to some 30 minutes to assemble.

To give you an overview of the 3-Seater Sofa parts, the above picture is to help you put the various parts into perspective.

Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

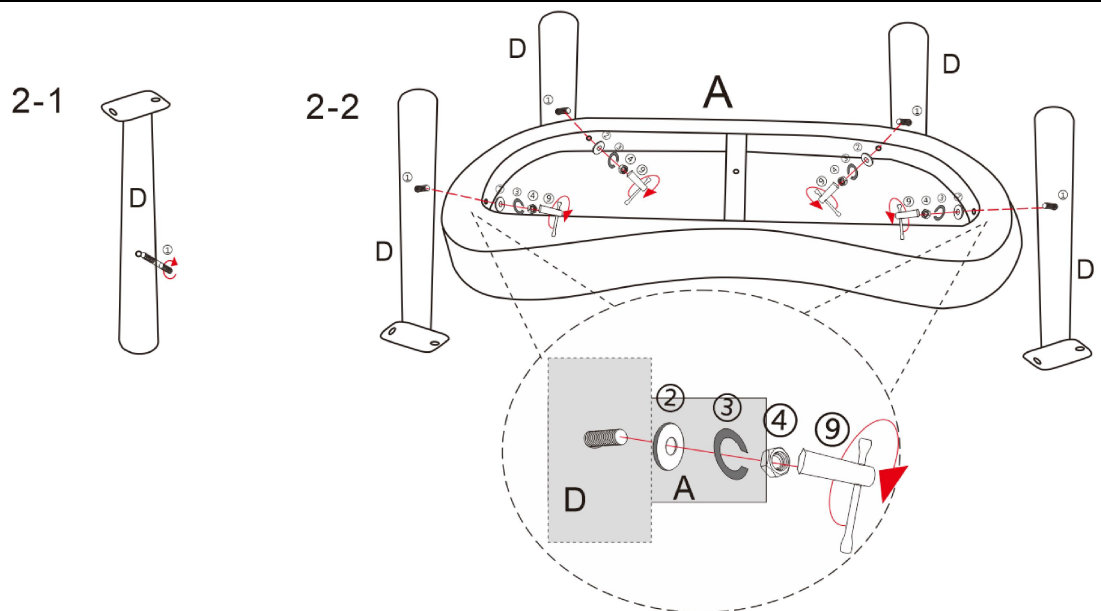
Note: It is recommended that you have an adult partner to assist during the entire assembly process.

Step 1



Remove items Seat Board (A), Backrest (B), Back Cushion (C), Leg (D), Middle Leg (E) and the hardware kit from the cardboard box, and place them on a clean, scratch-free surface.

Step 2

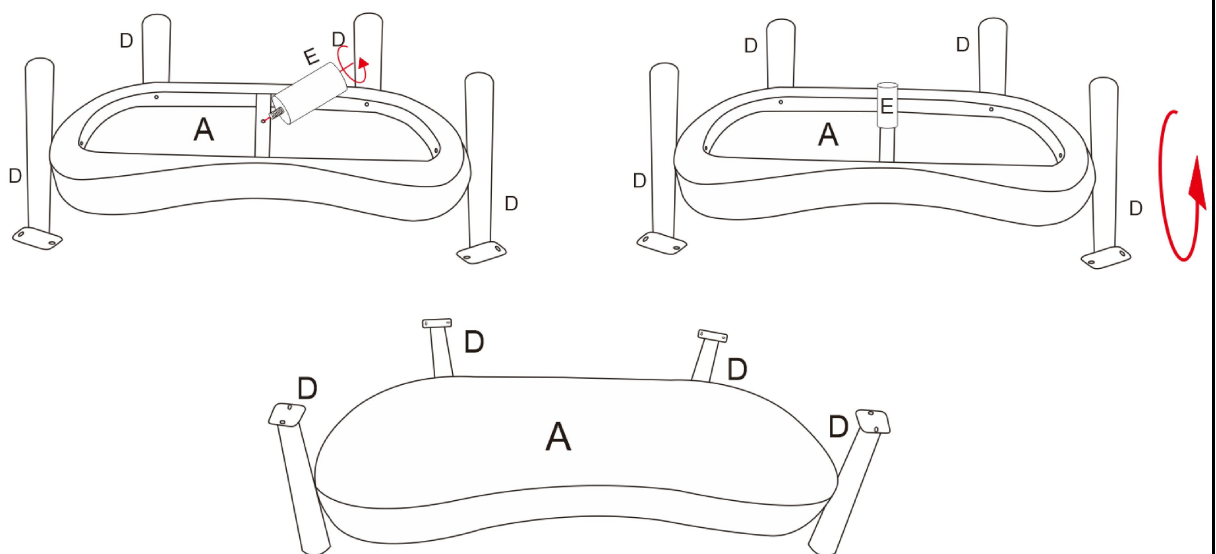


2-1: Screw the Double Headed Screw (①) spiral into the hole in the centre of Leg (D). Repeat this step four times.

2-2: Insert the Leg (D) into the central hole of Seat Board (A), then use Wrenches (⑨) to tighten Gaskets (②), Spring Shims (③), and Nut (④) in sequence. repeating this procedure four times.

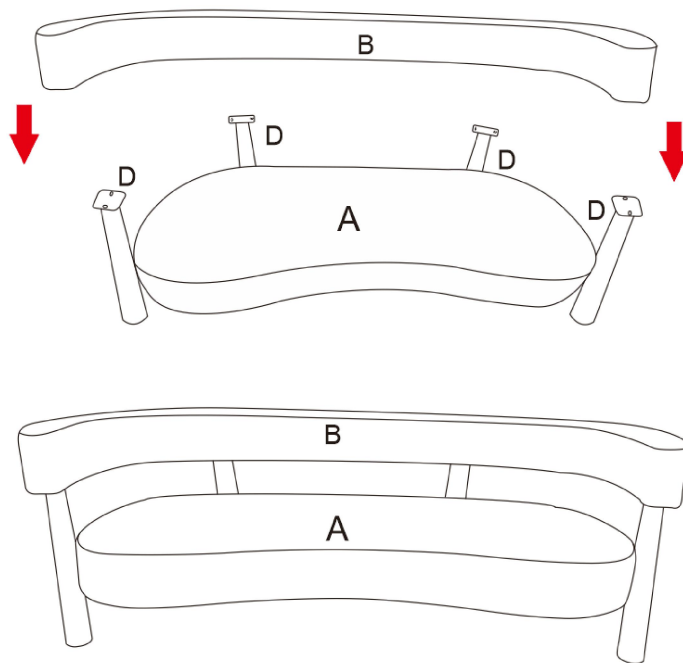
Do not tighten any screws.

Step 3



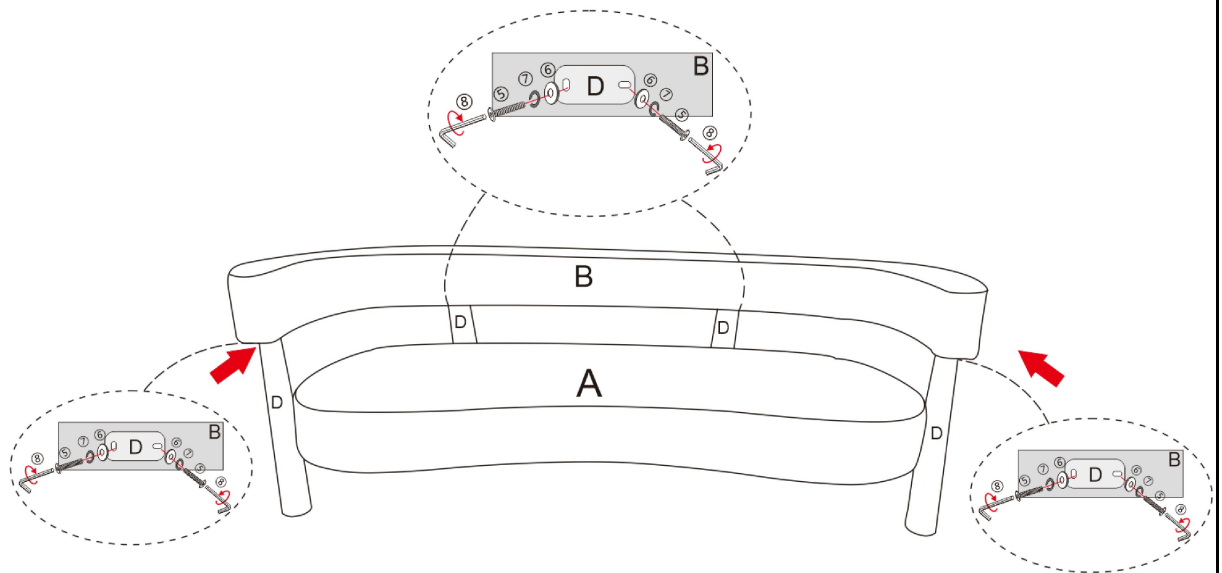
Align Middle Leg (E) with the central hole in Seat Board (A), screw it into the hole, and tighten Middle Leg (E). Then turn Seat Board (A) over to its front side.

Step 4



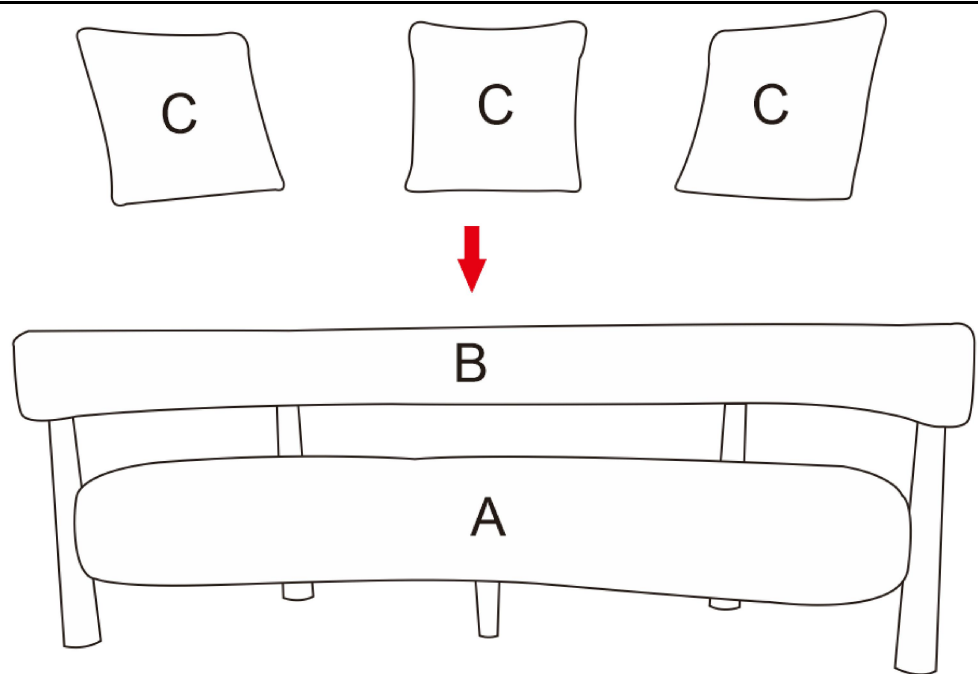
Place Backrest (B) horizontally upon Leg (D), aligning the holes in Backrest (B) with those in Leg (D).

Step 5



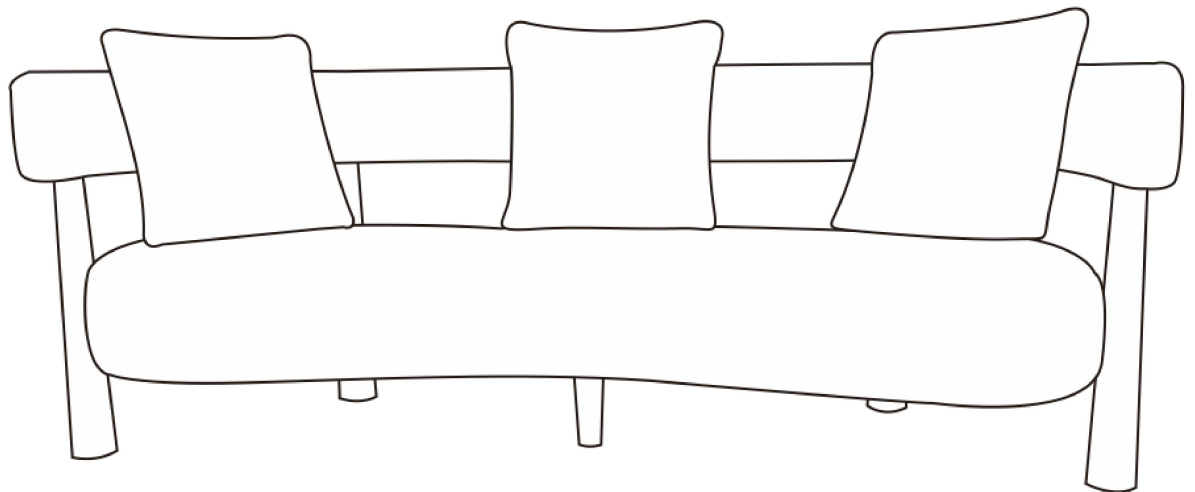
After aligning the holes of Leg (D) with those of Backrest (B), tighten Gaskets (⑥), Spring Shims (⑦) and Single Head Screw (⑤) in sequence from the bottom using Allen Wrench (⑧). This step involves tightening Single Head Screw (⑤) Repeat this procedure eight times.
Finally, tighten all the bolts and screws sequentially.

Step 6



Place Back Cushion (C) on the sofa.

Step 7



Your sofa is ready for use.

This sofa should only be used on flat, level surfaces.

Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
