



Care & Maintenance






- Do not put hot items directly on furniture surface.
- Ø ☐ Do not clean furniture with harsh cleansers or polish.
- ⊘ ∴ Do not place furniture under direct sunlight.
- Do not place furniture near heating or cooling vents.
- Do not write on furniture without a padded barrier to protect the surface.
- Do not place furniture outside . For indoor use only.
- Stains may be removed with mild soap solution and damp cloth.
- Children should not climb or jump on the furniture.





Assembly Steps




This 3-Seater Sofa has multiple parts and may require up to some 30 minutes to assemble.

To give you an overview of the 3-Seater Sofa parts, the above picture is to help you put the various parts into perspective.

Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Note: It is recommended that you have an adult partner to assist during the entire assembly process.




Remove items Right Armrest (A), Left Armrest (B), Righ L-Shaped Iron Pipe (C), Left L-Shaped Iron Pipe (D), Lumbar Support (E) and Seat Cushion (F) along with the hardware kit from the cardboard box and place them on a level, scratch-free surface.



After opening the compression bag (Note: Please do not cut with a knife, so as not to damage to the product), the corners around the cushions if there are wrinkles, you need to wait for about 72 hours, it is recommended that guests pat and knead the corners of the sofa, in order to sponge better recovery.


If you need any help, please take a picture and contact the seller.

Step 2



If you see the folds, Unzip the bottom of the product, Put your hand in, Gently pat and knead to tidy up thecreased sponge, Wait for the sponge to become fulland flat before Zip up the bottom of the product.


Step 3



Align Righ L-Shaped Iron Pipe (C) vertically with the holes on either side of Right Armrest (A), then use Allen Wrench (6) to tighten Single Head Screw (1), Spring Shims (5), and Gaskets (3) in sequence. Repeat this procedure twice.


At this stage, tighten the screws to 70%.

Step 4




Align Left L-Shaped Iron Pipe (D) vertically with the holes on either side of Left Armrest (B), then use Allen Wrench (6) to tighten Single Head Screw (1), Spring Shims (5), and Gaskets (3) in sequence. Repeat this procedure twice.

At this stage, tighten the screws to 70%.




Place component Right Armrest (A) bearing Righ L-Shaped Iron Pipe (C) and component Left Armrest (B) bearing Left L-Shaped Iron Pipe (D) upside down on a horizontal surface. Insert Left L-Shaped Iron Pipe (D) horizontally into the hole in Righ L-Shaped Iron Pipe (C), aligning the two cavities. Using Allen Wrench (⑦), sequentially tighten Single Head Screw (②) and Gaskets (④) into the holes. After all screws have been inserted, tighten all screws fully at this stage.


Finally, tighten all the bolts and screws sequentially.



Place horizontally Right Armrest (A) and Left Armrest (B), then position Seat Cushion (F) atop Left L-Shaped Iron Pipe (D) and Righ L-Shaped Iron Pipe (C).



Place Lumbar Support (E) on the sofa.



Your sofa is ready for use.

This sofa should only be used on flat, level surfaces.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

• What types of chemicals are on the Proposition 65 list? The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
