• Do not place furniture outside . For indoor use only.


• Stains may be removed with mild soap solution and damp cloth.


Assembly Steps




This sofa has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the 3 Seater Sofa parts, the above picture is to help you put the various parts into perspective. Please read through the instructions herebelow to familiarise the parts and steps before assembly.




Take out the Left Armrest (A)&Right Armrest (B) from the Carton"2-1" and place them on a clean,non-marring surface.




Take out the Left Sofa Base(C), Right Sofa Base(D), Left Seat Cushion(E), Right Seat Cushion (F), Backrest (G), Big Pillow(H), Small Pillow(I) and Hardware Box from the Carton"2-2", place it on a clean,




Unpack and place all parts on a clean, non-marring surface.




Flip the Left Sofa Base (C) so that its bottom faces forward, then push the Backrest (G) into the top groove of the base as shown in the figure above. Align the holes of both components, and finally secure them together using Long Screws (1), Spring Washers (2), and Flat Washers (3). Use the same method to install the Right Sofa Base (D) and Backrest (G). After installation, do not reposition the bases and proceed to the next step.



Push the Left Armrest (A) against the side of the base so that it is flush with the bottom of the Left Sofa Base (C), as shown in the figure above. Align the holes of both components, and finally secure them together using Long Screws (1), Spring Washers (2), and Flat Washers (3). Use the same method to install the Right Sofa Base (D) and Right Armrest (B). After installation, do not reposition the bases and proceed to the next step.




Install the Sofa Leg(J) in the hole of the Armrest(A,B) and Sofa Base(C,D),After installation, reposition the Sofa Bases(C,D) and proceed to the next step.




Lift the Right Side of the Left Semi-Finished Product and Lower It as Shown in the Figure to Connect Its Hardware with the Hardware of the Right Semi-Finished Product, Thereby Completing the Installation.

Step 6



Remove the seal from the Left Sofa Base (C) 's adhesive tape as shown in the above figure, Then place the Left Seat Cushion (E) (Which Has fully recovered after 72 hours) tightly against the Armrest and Backrest onto the Left Sofa Base (C). finally, Install the Right Seat Cushion (F) using the same method.

Step 7



Retrieve the Big Pillow (H) and Small Pillow (I), and Arrange Them According to Your Preference or as Shown in the Figure to Complete the Final Installation.

Questions & Answers about Proposition 65

• What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of

drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987. What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust. What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
