Children should not climb or jump on the furniture.




 Dust and pick-up spills using a clean, non-colored, lint-free cloth.







Assembly Steps




This Counter Stool has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Counter Stool parts, the above picture is provided to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Friendly reminder: Tighten all the screws after all holes are installed.



Open the carton, and place all parts on a clean, non-marring surface. Attach the Left Front Leg(D) and Right Front Leg(E) to the Frame(C), using the Bolts(1), Spring Washers(6) and Flat Washers(7) with Allen Wrench(1).

Do Not Fully Tighten the Bolts.




Attach the Left Back Leg(F) and Right Back Leg(G) to Seat Frame (C) as shown above.

- 2.1) Insert the Cam Locks((8)) into the holes of Seat Frame(C).
- 2.2) Insert the Bolts(3) into the holes as shown with Allen Wrench(11) to lock them.

Note: If the Bolt(3) cannot be turned, that means the Cam Lock(8) is not aligned; you can use the Allen Wrench(1) to turn the nut.


Do Not Fully Tighten the Bolts.



Take out Front Crossbar(H), Back Crossbar(I), Left Crossbar and Right Crossbar(J).

Insert Front Crossbar(H) and Back Crossbar(I) into the legs as shown. Insert Left Crossbar(J) and Right Crossbar(J) into the legs as shown.

Step 4




Turn the Frame from Step 3 over.

Take out Backrest Back Board(B).

Peel off the magic tape and roll it towards the middle.

Then place the Board(B) as shown.


Please pay attention to the direction of the arrow posted on the Board when placing it, with the larger end facing downwards.



Attach the Backrest Back Board(B) to the back legs, using Bolt(4) with Allen Wrench(1).


Fully Tighten the Bolts.

Then cover the Board.



Turn the Counter Stool over again.
Use Bolt(⑤) with Screwdriver (⑨) to tighten it as shown.

Then Fully Tighten all the Bolts.




Place the Seat (A) face down on a surface.

Attach the assembled frame to the Seat(A) with the holes aligned, using Bolts(②) with the Allen Wrench(①).

Note: When installing the backrest, pull it forward firmly, assemble the front holes first, then the side holes.

Fully Tighten the Bolts.



Place the Counter Stool right side up and tested for stability.

Your Counter Stool is ready for use.

This Counter Stool can only be used on a flat, level surface.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
