Children should not climb or jump on the furniture.



 Do not write on furniture without a padded barrier to protect the surface.



 To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.



 Stains may be removed with mild soap solution and damp cloth.



 Dust and pick-up spills using a clean, non-colored, lint-free cloth.

Sets often ship in multiple boxes and may arrive a day or two apart.



Do not assemble on flooring or carpet-




Assemble on a clean non-marring surface (packing foam)-





#### Assembly Steps



This Umbrella Base has multiple parts and may require up to 10 minutes to assemble. To give you an overview of the Umbrella Base parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.


## Step 1



Open the carton, and place all parts on a clean, non-marring surface.


Turn the umbrella base over, and remove the Plastic Plug (B).

### Step 2



Pour sand into the hole of the umbrella base until it is full. Then cover the hole with Plastic Plug (B).


## Step 3



With the assistant of your adult partners, stand the umbrella base upright.

Insert the Adapters (C) into the hole as shown.

#### Step 4



Your umbrella base is ready for use.

### **Operation Instruction**

#### For Umbrella Pole with 32mm diameter:

Put all adapters into the base, then insert your 32mm umbrella pole. Tighten the rotary knob on the base securely to your umbrella pole

#### For Umbrella Pole with 38mm diameter:

Pull out the 32mm adapters, and then insert your 38mm umbrella pole. Tighten the rotary knob on the base securely to your umbrella pole.

This Umbrella Base only be used on a flat, level surface.

#### For Umbrella Pole with 48mm diameter:

Pull out the 32mm and 38mm adapters, leave the 48mm adapter in place, and then insert your 48mm umbrella pole.

Tighten the rotary knob on the base securely to your umbrella pole.

The Umbrella Base is ready for use.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals. Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list? The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.
- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
