 Stains may be removed with mild soap solution and damp cloth.




Children should not climb or jump on the furniture.





Assembly Steps




This Counter Stool has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Counter Stool, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.



Attach the Upper Rail(D) and Side Rail(E) to the Back with legs(B) with the Bolts (1), Spring Washers (3) and Washers (4), and Allen Wrench (5) as shown in the figure above.

Note:Do not fully tighten the Bolts in this step.




Attach the Upper Rail(D) and Side Rail (E) to the Metal Leg Frame (C) with the Bolts (1), and Spring Washers (3) and Washers (4), and Allen Wrench (⑤) as shown in the figure above.

Note:Do not fully tighten the Bolts in this step.


Step 3



Position the Seat(A) (bottom-up) as shown above, then using Bolts(2). and Spring Washers (3) and Washers (4), with the Allen Wrench (5) affix the Seat(A)to the Back with legs(B) and Metal Leg Frame(C). Note:Once the assembly is completed, proceed to tighten all bolts sequentially.



Adjust the Pre-installed Levelers at the bottom of the Metal Leg Frame (C) and Back with legs(B) until the Counter Stool is level with the ground.



Your Counter Stool is ready for use.

This Counter Stool can only be used on a flat, level surface.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of

drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list? The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.
- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
