Do not put hot items directly on furniture surface.



Do not clean furniture with harsh cleansers or polish.



 To obtain the longest lifespan of your outdoor products, minimizing exposure to direct sunlight is recommended.



Children should not climb or jump on the furniture.



 Do not write on furniture without a padded barrier to protect the surface.



 To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.




 Stains may be removed with mild soap solution and damp cloth.


Keep your child/children at bay during the assembly process.

#### **Assembly Preparation**

### Before Beginning Assembly:





Read instructions, cover to cover.



Have 2 adults on hand for assembly.



Do not assemble on flooring or carpet.




Assemble on a clean non-marring surface (packing foam).




Save all packaging until finished.


#### **Assembly Steps**



This Table has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Table parts, the above picture is to help you put the various parts into perspective. Please read through the instructions here below to familiarise yourself with the parts and steps before assembly.




Unpack and place all parts on a clean, non-marring surface.



Place the Table Top (A) and the Table Top (B) facedown onto a clean, non-marring surface.

First, attach the Table Top (A) into the Table Top (B), using Screw (1), and the Allen Wrench (6), as shown above.


Do not fully tighten the Bolts.



Attach the Table Support Bar (C) into the Table Top (A) and the Table Top (B), using Bolt (2), and the Allen Wrench (6). as shown above.

Repeat the same process with the remainingTable Support Bar (C).


#### Do not fully tighten the Bolts.



Insert the Legs (D) into the mounting positions on the Step 3, then secure them using Washers (4), Spring Washers (5), Bolts (3), and the Allen Wrench (6) as shown above.

Repeat the same process with the remaining Legs (D).

Do not fully tighten the Bolts.



Turn the Table right side up, with assistance from your adult partner.

Exert pressure floorwards, onto the Table with both your hands.

This pressure will help the Legs and Table Top reach full alignment status.

Check for wobbles on a LEVEL surface.

If no wobbles are found proceed to tighten the Bolts in a sequential manner, until evenly secured.

When tightening the Bolts tighten sequentially.

Do no tighten any Bolt fully and then move on towards the next one.

If there are still wobbles after tightening, loosen the Bolts and execute the same above process.

Your Table is ready for use.

This Table can only be used on a flat, level surface.

#### **Questions & Answers about Proposition 65**

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list? The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.
- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
