Care & Maintenance



- Not for commercial use. For residential use only.



- Do not put hot items directly on furniture surface.



- Do not clean furniture with harsh cleansers or polish.



- To obtain the longest lifespan of your outdoor products, minimizing exposure to direct sunlight is recommended.



- Children should not climb or jump on the furniture.



- Do not write on furniture without a padded barrier to protect the surface.



- To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.



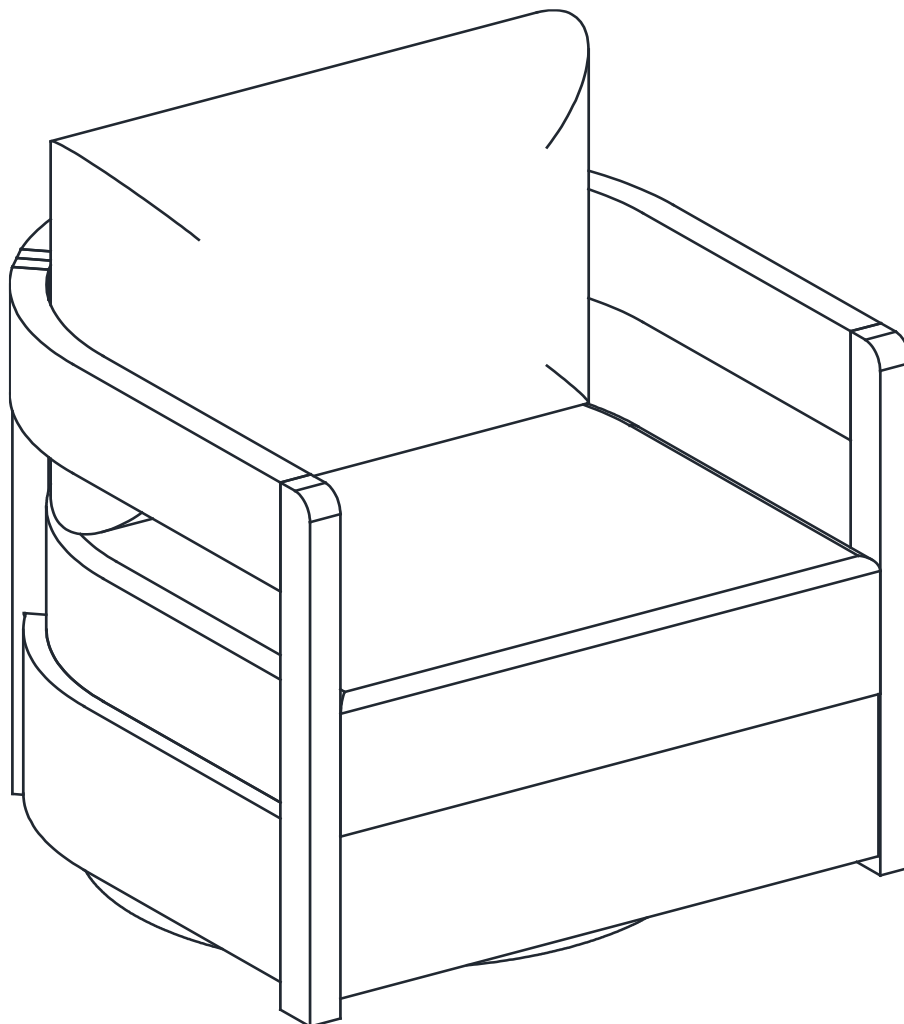
- Stains may be removed with mild soap solution and damp cloth.





Keep your child / children at bay Swivel Chair the assembly process.

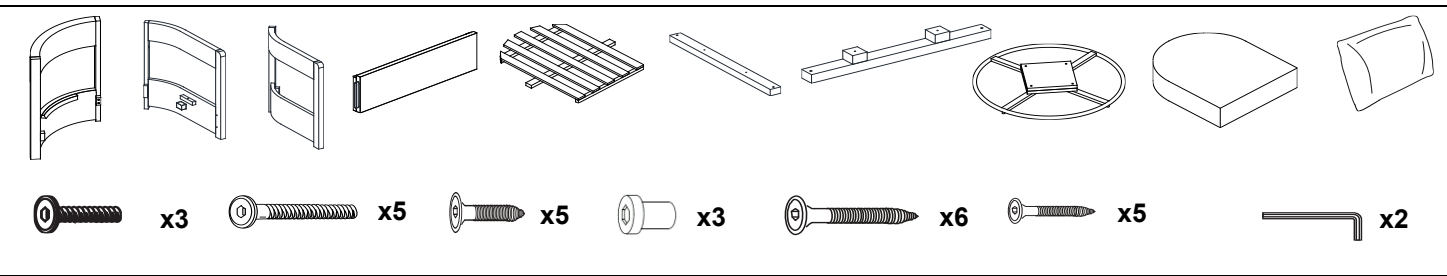

Assembly Preparation

Before Beginning Assembly:



Read instructions, cover to cover-

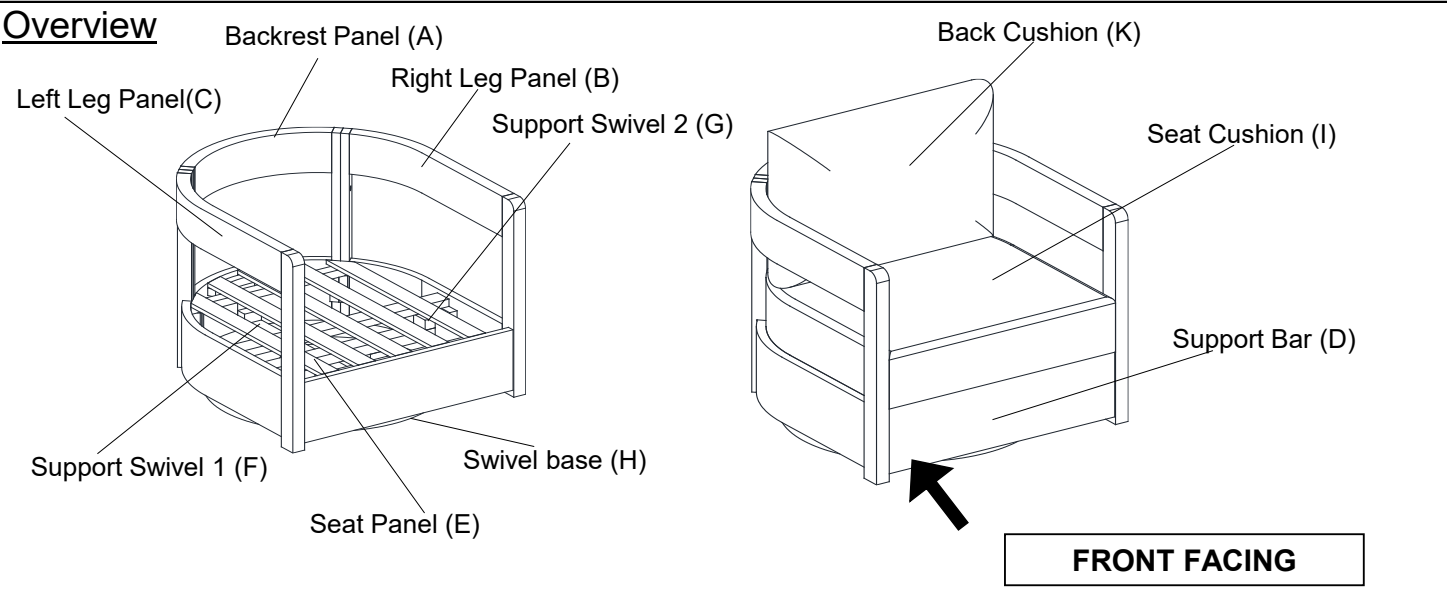
Have 2 adults on hand for assembly-

Do not assemble on flooring or carpet-

Assemble on a clean non-marring surface (packing foam)-

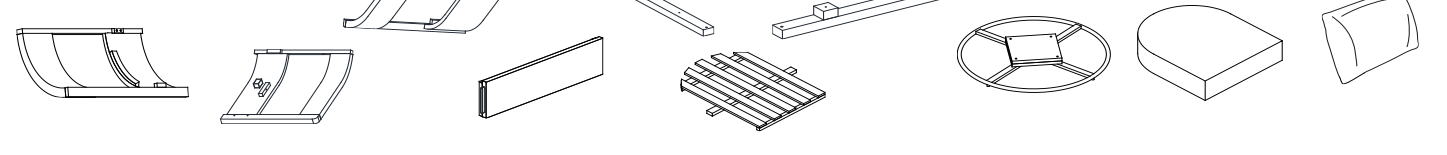
Save all packaging until finished-

Assembly Steps



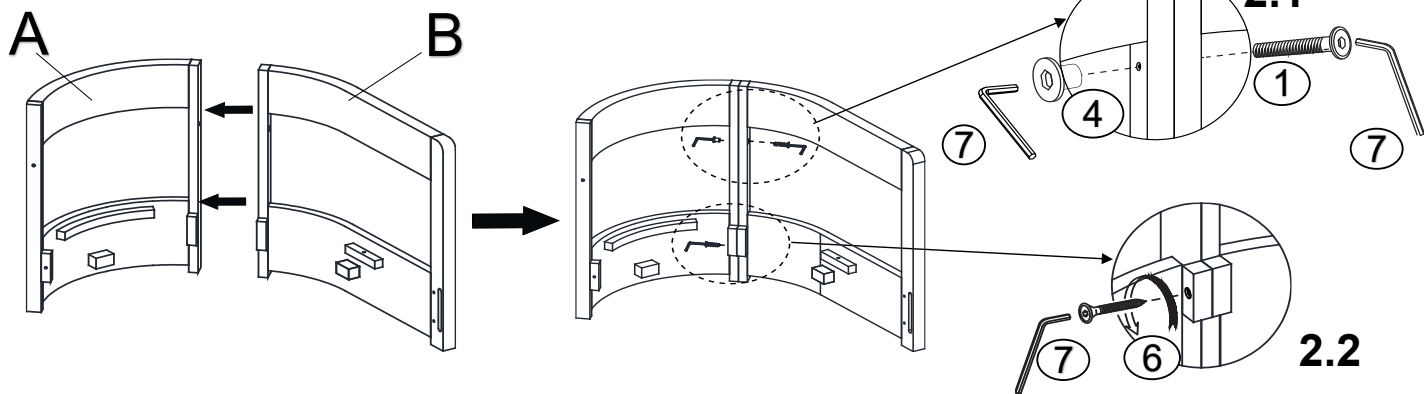
This Swivel Chair has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Swivel Chair parts, the above picture is provided to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1



Unpack and place all parts on a clean, non-marring surface.

Step 2



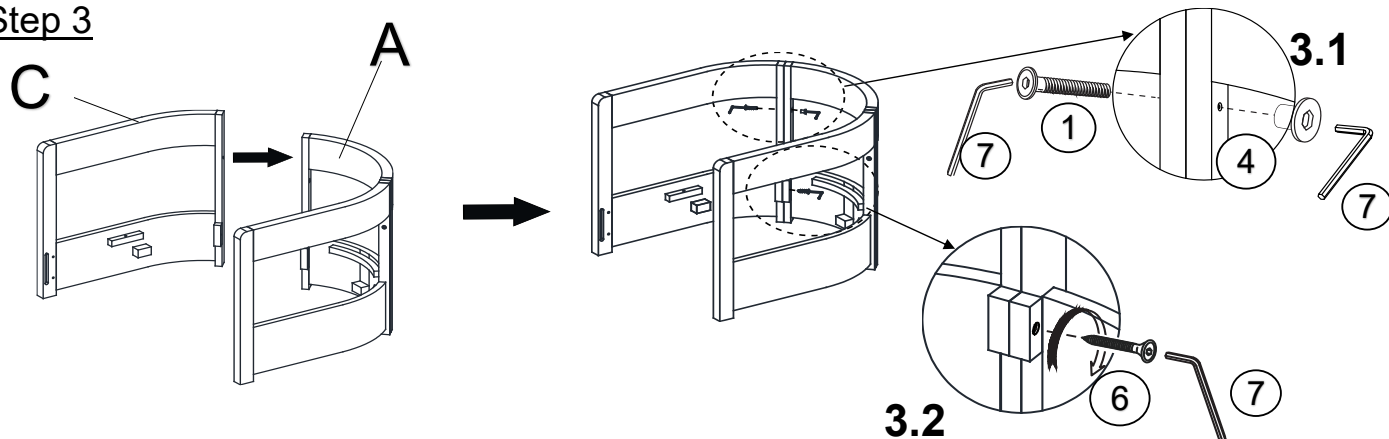
Place the Backrest Panel (A) upright as shown in the picture above onto a clean, soft surface to avoid any scratches or damages to the product. With assistance from your adult partner(s):

2.1 Attach the Right Leg Panel (B) to the Backrest Panel (A) by using Bolts (①), Sleeve Nuts (④) and the Allen Wrench (⑦) as shown above.

2.2 Attach the Right Leg Panel (B) to the Backrest Panel (A) by using Screws (⑥) and the Allen Wrench (⑦) as shown above.

Do not fully tighten the Bolts and Screws at this time.

Step 3



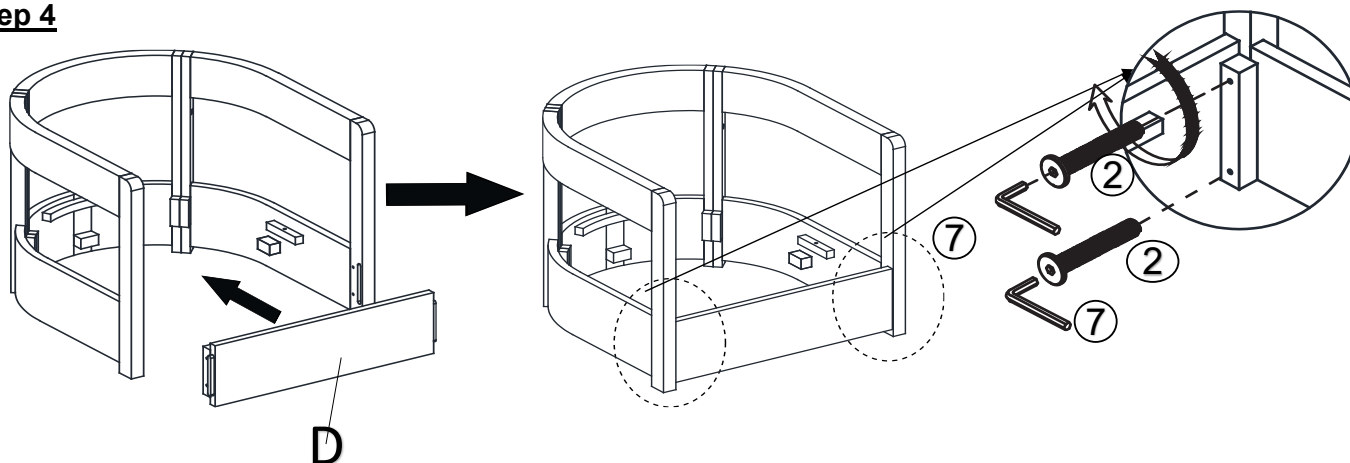
With assistance from your adult partner(s):

3.1 Attach the Left Leg Panel (C) to the assembled in step 2 by using Bolts (①), Sleeve Nuts (④) and the Allen Wrench (⑦) as shown above.

3.2 Attach the Left Leg Panel (C) to the assembled in step 2 by using Screws (⑥) and the Allen Wrench (⑦) as shown above.

Do not fully tighten the Bolts and Screws at this time

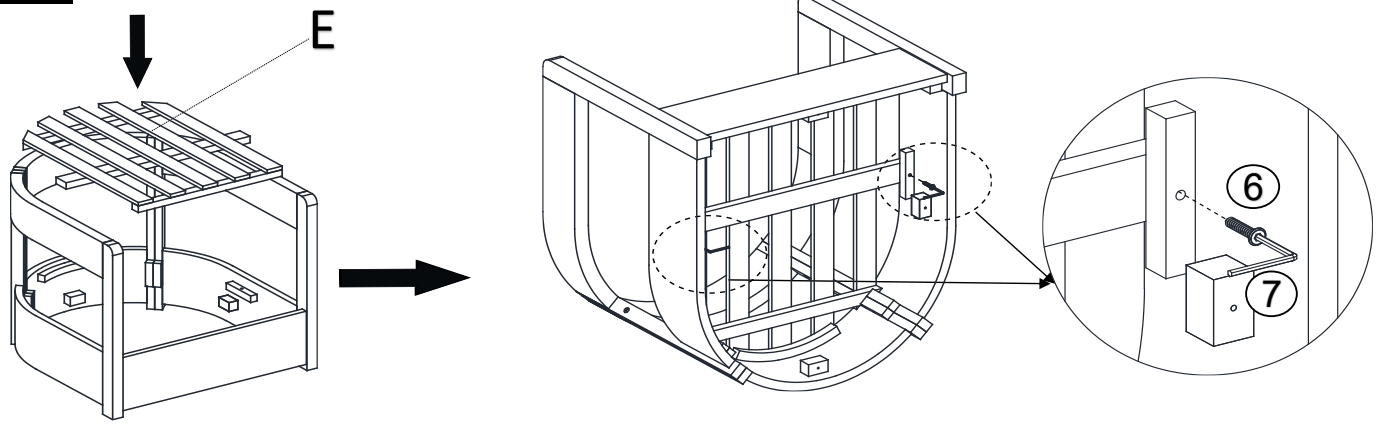
Step 4



Attach the Support Bar (D) to the assembled part in step 3 by using Bolts (②) and the Allen Wrench (⑦) as shown above.

Do not fully tighten the Bolts at this time

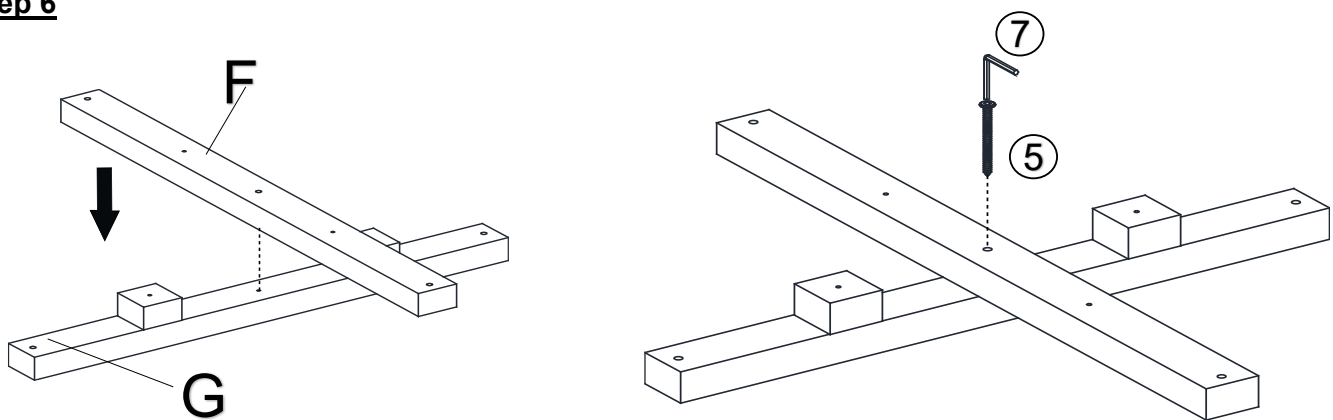
Step 5



Place the Seat Panel (E) and the assembled part in Step 4 as shown in picture above.
Attach the Seat Panel (E) to the assembled part in Step 4 by using Screws (⑥) and the Allen Wrench (⑦).
Note: Insert the Screws (③) from the inside to the outside of the Seat Panel (E)

Do not fully tighten the Bolts at this time

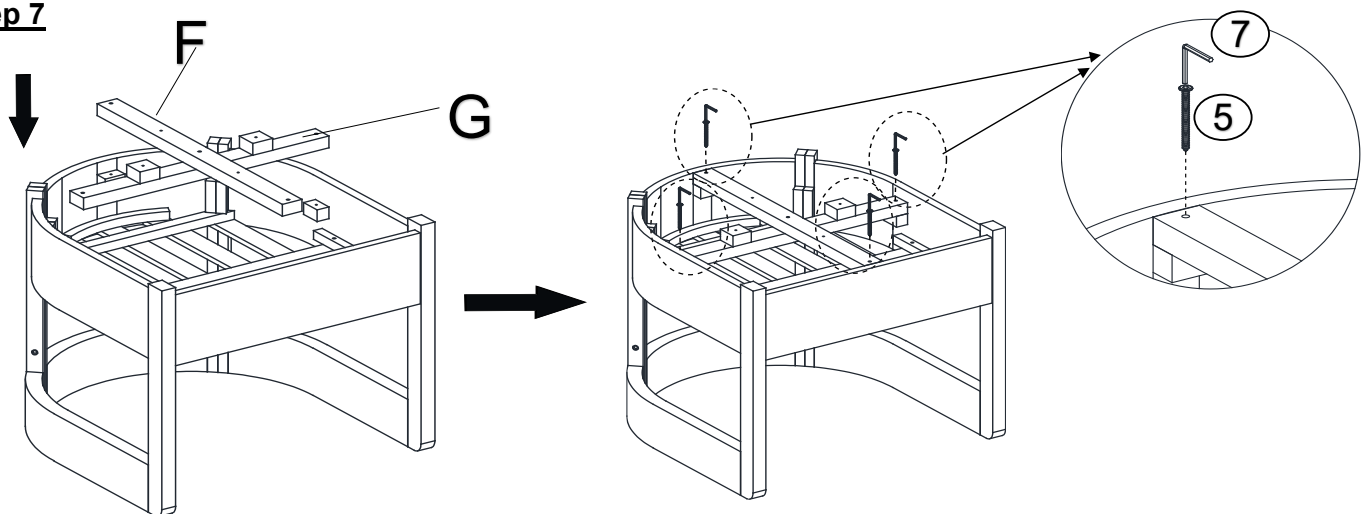
Step 6



Place the Support Swivel 2 (G) and the Support Swivel 1 (F) as shown in picture above.
Attach the Support Swivel 1 (F) to the Support Swivel 2 (G) by using Screws (⑤) and the Allen Wrench (⑦).

Do not fully tighten the Screws at this time

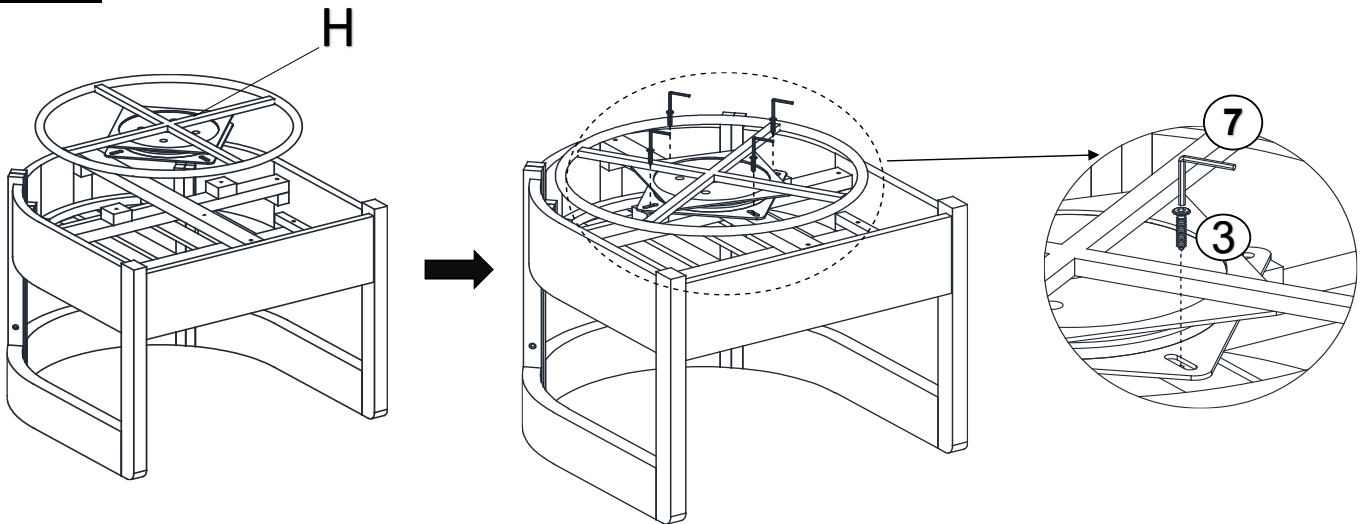
Step 7



Upside down the assembled part in Step 5 and attach assembled part in Step 6 to the assembled part in Step 5 by using Screws (⑤) and the Allen Wrench (⑦).

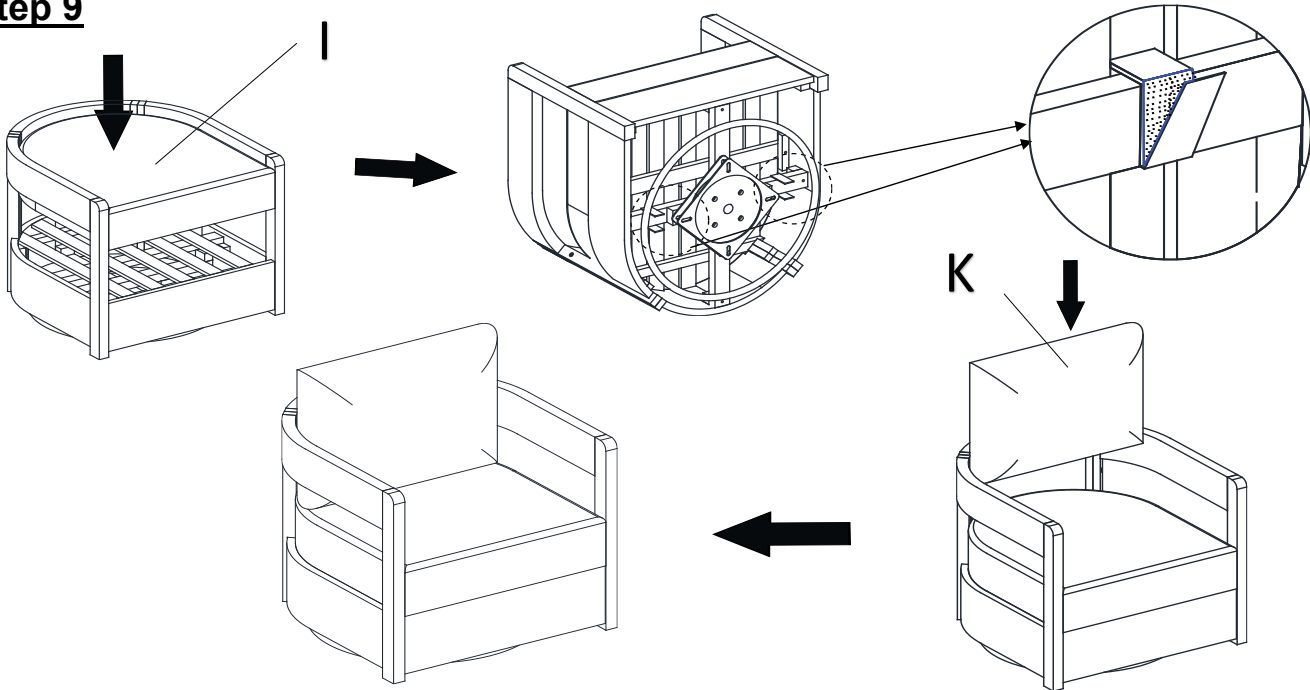
Do not fully tighten the Screws at this time

Step 8



Attach the Swivel Base (H) to the assembled part in Step 7 by using Screws (③) and the Allen Wrench (⑦).
Do not fully tighten the Screws at this time

Step 9



Upside down the assembled part in Step 8 and place the Seat Cushion (I) and the Back Cushion (K) onto the Chair, then affix the "magic tape straps" around the Chair as shown above.

With assistance from your adult partners, turn the Swivel Chair back to normal flat ground.
Inspect it and make sure all parts are adequately connected.
In a sequential manner, tighten all Screws and Bolts at all joints.

CAUTION: When tightening these screws and bolts, tighten sequentially.

DO NOT tighten any screws or bolts fully and then move towards the next one. This could cause the frame to warp.

WARNING!! IF THE SWIVEL CHAIR IS NOT STABLE , IT COULD LEAD TO DAMAGING THE PRODUCT.
Your Swivel Chair is ready to be used.

This Swivel Chair can only be used on a flat, level surface.

Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
