

## Care & Maintenance

- 🚫  • Not for commercial use. For residential use only.
- ✓  • Furniture may scratch floors. We recommend using furniture pads to protect your floors.
- 🚫  • Do not put hot items directly on furniture surface.
- 🚫  • Do not clean furniture with harsh cleansers or polish.
- 🚫  • Do not place furniture under direct sunlight.
- 🚫  • Do not place furniture near heating or cooling vents.
- 🚫  • Do not write on furniture without a padded barrier to protect the surface.
- 🚫  • Do not place furniture outside . For indoor use only.
- 🚫  • Stains may be removed with mild soap solution and damp cloth.
- 🚫  • Children should not climb or jump on the furniture.
  
- ✓  • Dust and pick-up spills using a clean, non-colored, lint-free cloth.





Please look for the hardware bag and legs in the seat frame.




## Assembly Steps

## Overview




This sofa has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Loveseat parts, the above picture is to help you put the various parts into perspective. Please read through the instructions here below to familiarise the parts and steps before assembly.

### Step 1




Unpack and place all parts on a clean, non-marring surface

## Step 2




Place the wooden base (A) and armrest (B) (C) vertically on the ground. Place the wooden base and the lower part of the Left armrest (B) against each other, and tighten the bolt (①), spring washer (②), and washer (③) with an Allen key (④). Repeat this process for the right side (A, C) in the same manner as shown in the figure.

## Step 3




Install the Middle Leg (G) in the holes in the center of the wooden base (A) and the Middle Leg(G)can be screw-adjusted for height.

#### Step 4



Use the pins on the side of (B)(C) to hold the backrest (D) in place, as shown in the picture, and additionally attach the magic tape on the backrest to the armrests (B,C)and the wooden base(A).

#### Step 5



Place the Seat Cushion (E) and the Backrest Cushion (F) onto the sofa as shown above.

## Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.


- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.

... Wait **72h**

After opening the compression bag (Note: Please do not cut with a knife, so as not to damage to the product), the corners around the cushions if there are wrinkles, you need to wait for about 72 hours, it is recommended that guests pat and knead the corners of the sofa, in order to sponge better recovery. If needed, contact the seller to provide a video of patting and finishing the sofa.
