

Care & Maintenance

- 🚫  ● Not for commercial use. For residential use only.
- ✓  ● Furniture may scratch floors. We recommend using furniture pads to protect your floors.
- 🚫  ● Do not put hot items directly on furniture surface.
- 🚫  ● Do not clean furniture with harsh cleansers or polish.
- 🚫  ● Do not place furniture under direct sunlight.
- 🚫  ● Do not place furniture near heating or cooling vents.
- 🚫  ● Do not write on furniture without a padded barrier to protect the surface.
- 🚫  ● Do not place furniture outside . For indoor use only.
- 🚫  ● Stains may be removed with mild soap solution and damp cloth.
- 🚫  ● Children should not climb or jump on the furniture.
- ✓  ● Dust and pick-up spills using a clean, non-colored, lint-free cloth.



③	A standard hex head bolt with a threaded shank and a flat washer.	Bolt (M6X20mm)	5
④	A cam lock mechanism used for quick assembly.	Cam Lock	7
⑤	A standard Allen wrench (hex key).	Allen Wrench	1
⑥	A metal connector piece with two mounting holes.	Iron sheet Connector	2
⑦	A circular screw hole cover.	Screw Hole Cover	7

Assembly Preparation

Before Beginning Assembly:



- Read instructions, cover to cover-



- Have 2 adults on hand for assembly-



- Do not assemble on flooring or carpet-




- Assemble on a clean non-marring surface (packing foam)-

Assembly Steps


Overview



This Chair has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Chair parts, the above picture is provided to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Friendly reminder: Tighten all the screws after all holes are installed.

Step 1




Open the carton, and place all parts on a clean, non-marring surface.

Take out Seat Cushion(B) and Front Leg(C).

Attach Legs(C) to the Seat(B) as shown, insert Cam Lock(④) into the hole of leg. After inserting it, align the exterior of the Cam Lock(④) to a horizontal slotted (flat-head) orientation.

Then insert Bolt(①) into the holes of both side of Leg(C) with Allen Wrench to tighten it.


Step 2



Take out Left Back Leg(D) and Right Back Leg(E).

Attach Legs(D) and Leg(E) to the Seat(B) as shown, insert Cam Lock(④) into the hole of leg (Check the diagram for left/right orientation to avoid installing the legs in reverse.) After inserting it, align the exterior of the Cam Lock(④) to a horizontal slotted (flat-head) orientation. Then insert Bolt(①) into the holes of both side of Leg(C) with Allen Wrench(⑤) to tighten it.


Step 3



Take out Iron Sheet Connector(⑥)

Align the **outer** row of holes on the iron sheets with the top of the legs, using Bolt(②) with Allen Wrench(⑤) to tighten it.


Step 4



Take out Backrest(A)

Align the holes on the handrail with the **inner** row of holes on the iron sheet connector. Then insert Bolt(③) into the holes under the handrail as shown with Allen Wrench(⑤) to tighten it.




Step 5



Take out Screw Hole Cover(7).

Cover all exposed holes around the chair with Screw Hole Covers.

Step 6



Place the Chair right side up and tested for stability.

Fully Tighten all the bolts.

Adjust the levelers on the legs to ensure chair stability.

Your Chair is ready for use.

This CHAIR can only be used on a flat, level surface.

Questions & Answers about Proposition 65

- **What is Proposition 65?**

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- **What types of chemicals are on the Proposition 65 list?**

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- **What does a warning mean?**

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
