



Identification:

Product shall be marked with the manufacturer's name or registered trademark or, in the case of private labelling, the name of the customer for whom the fixture was manufactured. Markings shall be permanent, legible, and visible after installation. Fixtures that do not comply with one or more of the dimensional requirements shall be marked with an "N" to indicate the non-standard nature of the fixture. Bathtubs that use field-installed flanges shall have a non-permanent label stating "Do not install this fixture against a wall unless the appropriate flange is first installed". (The equivalent French wording is "Ne pas fixer cet appareil au mur a moins que la bride approprie n'ait ete prealablement installee"). The product shall also bear the CUUPC® certification mark.


Characteristics:

Plastic bathtubs with or without walls and with right or left hand or center outlets to be installed in accordance with the manufacturer's instructions affixed to the unit and the requirements of the latest edition of the Uniform Plumbing Code®. Bathtubs without factory applied nailing flanges are listed as drop-in units only (except for free-standing bathtubs), and are not to be installed against the wall. Bathtubs intended for installation against a wall shall incorporate an integral, factory applied or field applied nailing flange in accordance with CSA B45.5/IAPMO Z124. Whirlpool piping is not included in this listing. To be installed with other IAPMO R&T listed pipe and fittings.

Products listed on this certificate have been tested by an IAPMO R&T recognized laboratory. This recognition has been granted based upon the laboratory's compliance to the applicable requirements of ISO/IEC 17025.
