
- **Assemble on a clean non-marring surface (packing foam)-**


Assembly Preparation

Overview




This end table has multiple parts and may require up to some 15 minutes to assemble. To give you an overview of the end table parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1




Attach table leg(B) to table top (A).

Step 2




Screw adjustable leveling glide(①) to table leg(B).

Step 3




Attach anti-tip strap() to the pre-drilled holes behind the end table with short screw () and washer().

Step 4



Place end table against to the wall. Mark positions and drill holes on the wall for the expansion plug. Drive expansion plug (4) into the drilled holes. Attach anti-tip strap(3) to expansion plug (4) with long screw(5) and washer().

Step 5



The end table is ready to use.

”Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust. ”
