
Care & Maintenance

- ∅  • Not for commercial use. For residential use only.
- ✓  • Furniture may scratch floors. We recommend using furniture pads to protect your floors.
- ∅  • Do not put hot items directly on furniture surface.
- ∅  • Do not clean furniture with harsh cleansers or polish.
- ∅  • Do not place furniture under direct sunlight.
- ∅  • Do not place furniture near heating or cooling vents.
- ∅  • Do not write on furniture without a padded barrier to protect the surface.
- ∅  • Do not place furniture outside . For indoor use only.
- ∅  • Stains may be removed with mild soap solution and damp cloth.
- ∅  • Children should not climb or jump on the furniture.

- ✓  • Dust and pick-up spills using a clean, non-colored, lint-free cloth.

Please look in red bag in the corner of the cardboard box for hardware packs and legs.





- Do not assemble on flooring or carpet-




- Assemble on a clean non-marring surface (packing foam)-



- Save all packaging until finished-


Assembly Steps

Overview




This 3 SEATER SOFA has multiple parts and may require up to some 30 minutes to assemble. To give you an overview of the 3 SEATER SOFA parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly. Note: It is recommended that you have an adult partner to assist during the entire assembly process.

Step 1




Position the Seat Base(A) and Backrest(B),Left Armrest(C),Right Armrest(D),Left Seat Cushion(E),Right Seat Cushion(F),Back Cushion(G)on a clean,non-marring surface, as shown.
Do not place on surface that can scratch or damage the upholstery.
Take the middle leg and hardware from the carton

Step 2



Align the mortise hole of the Left Armrest (C) with the tenon of the Seat Base (A) and install it with Bol(①), Spring Washer(③), and Washer(②) to secure it firmly.
Repeat this step to install the other right hand Armrest(D).

Step 3




Place the backrest panel as shown in the picture.

Connect the Seat Base (A) to the Backrest (B) using the Bolts (①), Washers (②) and spring Washers (③) shown in the above picture and an 5#Allen Wrench (⑧), then connect the backrest to the Armrest(CD) using Bolts (④), Washers (⑤) and Spring Washers (⑥) and an 4#Allen Wrench (⑦).
Tighten the Bolts fully in a sequential manner.

DO NOT fully tighten a Bolt in one go and then move on to the next.

Rather, In a sequential manner, gradually tighten each Bolt until all Bolts are evenly secured.


Step 4



Mount the Middle Leg (H) to the Seat Base (A).

Then insert the threaded rod into the threaded position of the base. Turn by rotating the leg clockwise

Step 5



Turn the sofa unit over and then place the Seat Cushion (E,F) and the Back Cushion (G).

Your 3 SEATER SOFA is ready for use.

This Rattan Double Sofa can only be used on a flat, level surface.

Questions & Answers about Proposition 65

- **What is Proposition 65?**

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- **What types of chemicals are on the Proposition 65 list?**

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- **What does a warning mean?**

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
