Before Beginning Assembly:



The Table top is placed on a soft floor, the bottom side facing up to ensure no scratches on the product. The detailed assembly steps are sequentially in accordance with the illustration.

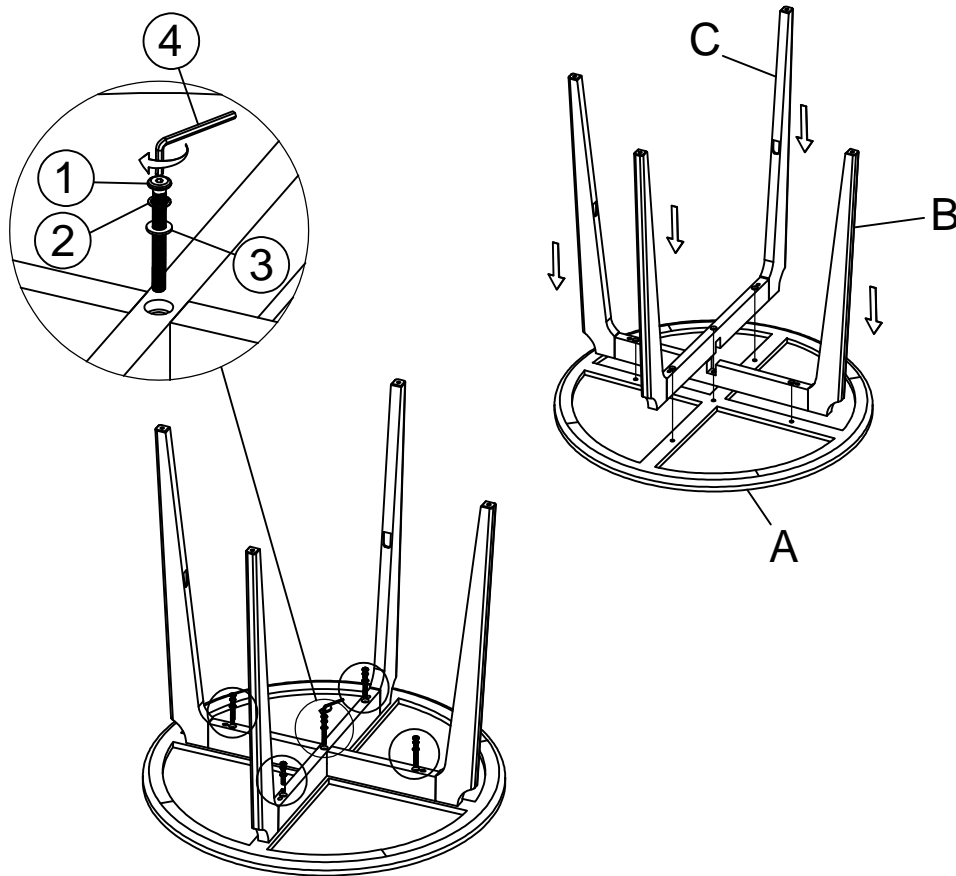
Overview



This Table has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Chair parts, the above picture is provided to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Assemble the table leg frame (B) first, then tighten it with 2 bolts (1). Assemble the leg frame (C) later so that the center notch fits properly. Use 3 bolts (1) to tighten it with a hexagon wrench 4.

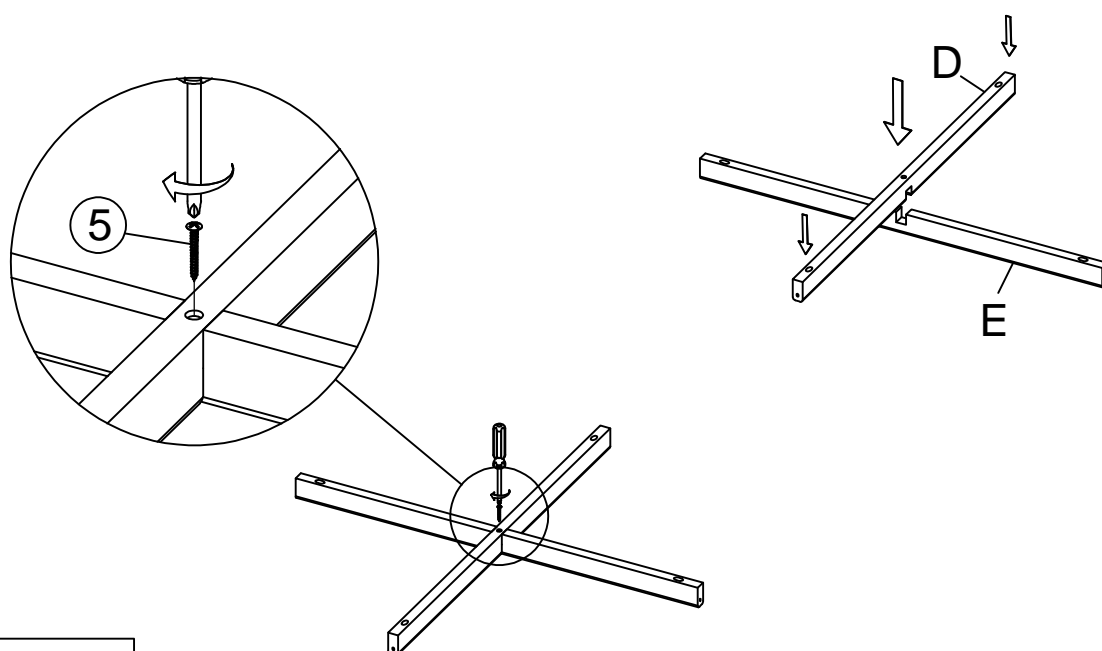

Assemble stretcher (D) into stretcher (E) so that the missing part in the middle matches, use screw (5) to tighten.

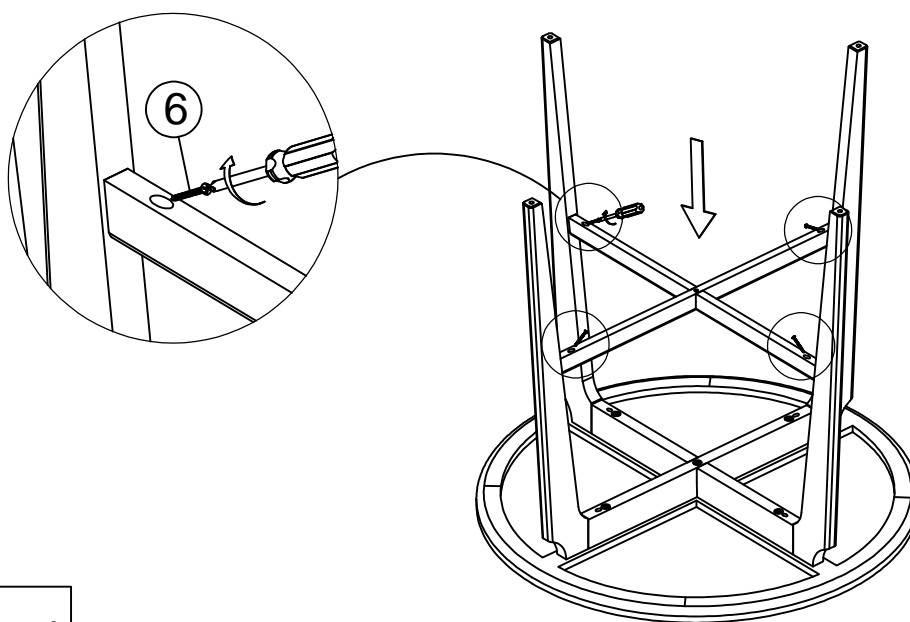

Assemble the stretcher assembly in step 2 onto the table leg, making sure the stretcher head fits into the recessed part in the middle of the leg with the screw hole facing up, and tighten it with the screwdriver (6).

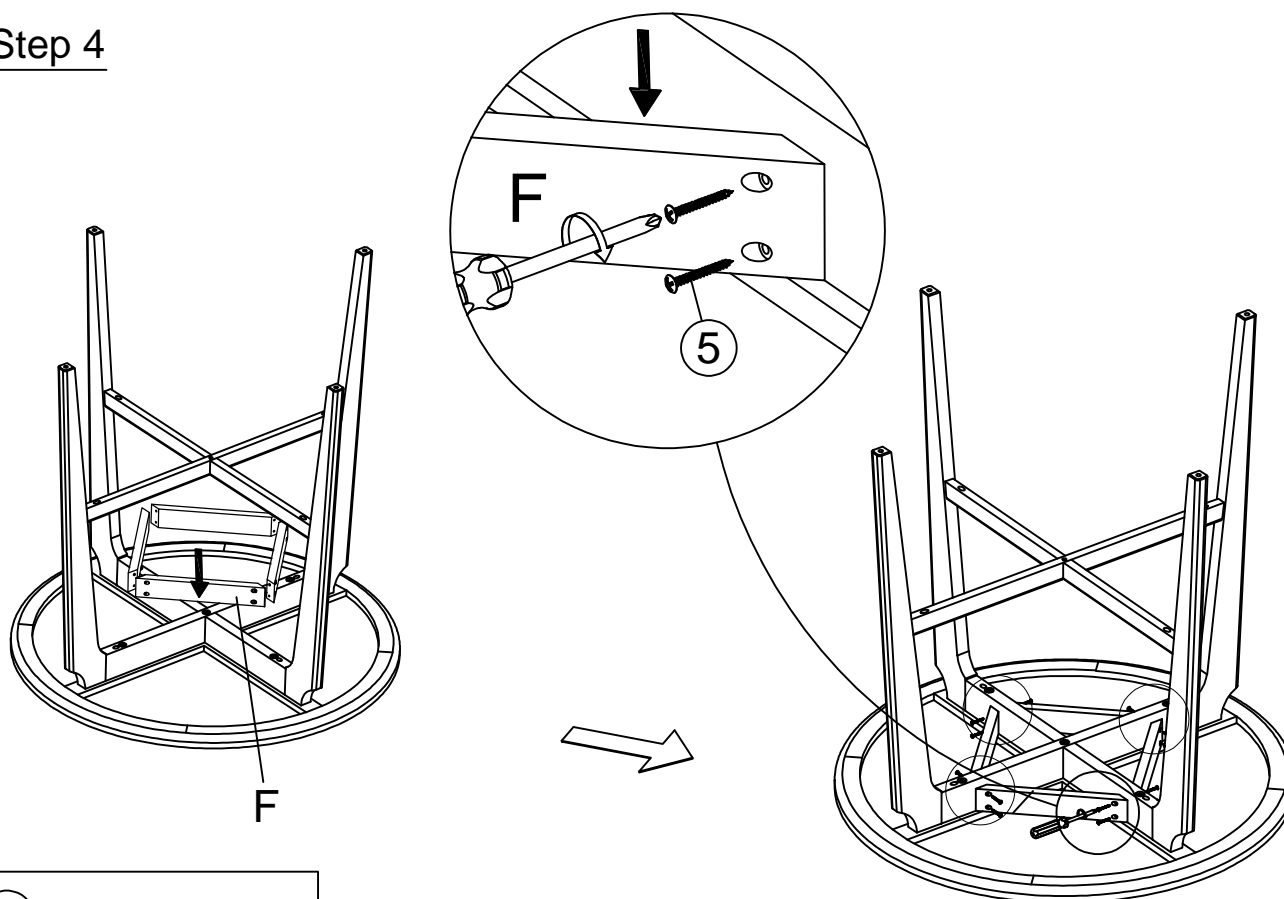

Assemble 4 reinforcing stretchers (F) so that the stretcher bevel fits tightly against the foot stretcher, and tighten with screws (6).

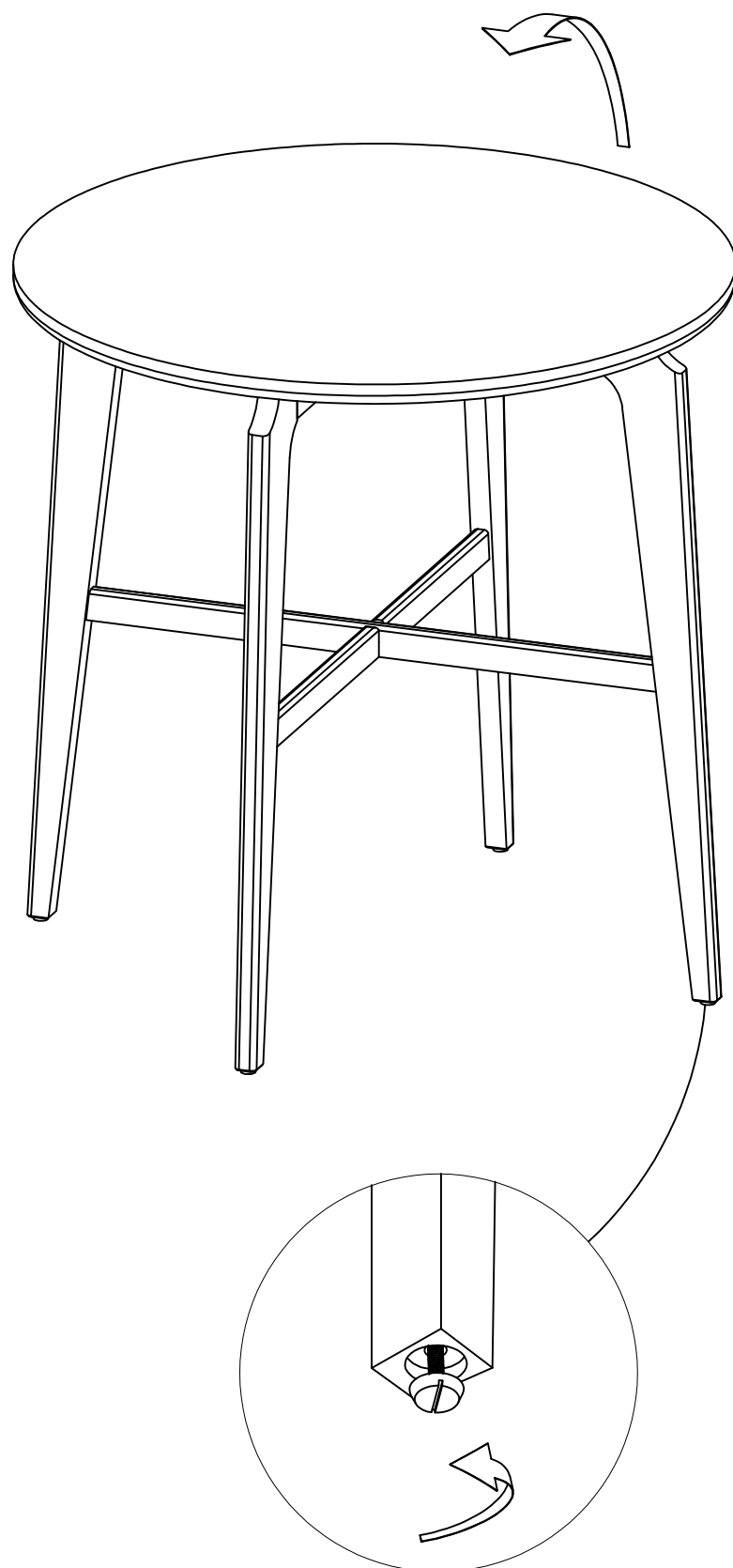

Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
