



Assembly Steps



This Barstool has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Barstool parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.


Step 1



Open the carton and place all the parts onto a clean, non-marring surface.

Step1.1 Tilt the Seat(A)with the arm and backrest floor facing, as shown in above picture. step1.2 Caution: During the assembly process, DO NOT place finger into gap of the Chiar Seat and the Chair Leg Frame.

Step 2




Turn down the Seat (A)&Chair Leg Frame(B) as the picture shown above.

Attach Chair Leg Frame(B) &Seat(A) using Bolts(2) and Washers(3) with Allen Key(1) as the picture show.


Dot not fully tigthen the Bolts.

Step 3



Place the Barstool on a LEVEL SURFACE to check for wobbles. If it wobbles, lift the Barstool some 20cm to 30cm high from the ground. Keep your feet and toes well away from the drop zone. Drop the Loveseat freely and vertically with all four legs, hitting the ground, at the sametime. This Drop Test will help to ensure that all the Bolts and gaps reach full alignment status. Test again for evenness on a LEVEL SURFACE. If no wobbles are found, slowly and steadily, place the Barstool facedown. Then, proceed to tighten all Bolts in a sequential manner. When tightening the Bolts, tighten sequentially. DO NOT tighten any Bolt fully and then move on towards the next one. This could cause the frame to warp. If there are still wobbles, loosen the Bolts and execute the same drop test. If the Barstool is not stable, it could lead to damage to the product.

Step 4



Place the Seat cushion (C) on the Barstool.

The Barstool is ready for use.

The Bastool can only be used on a flat, level surface.


