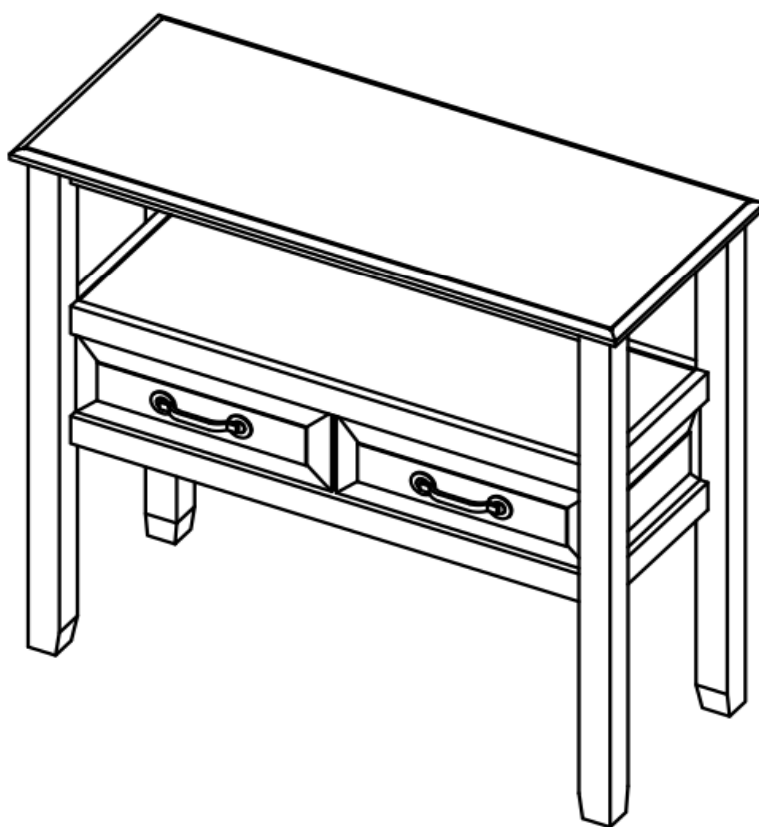


Instruction of Cabinet Restraint Device (CRD)

Caution: You must read this before you proceed.





CAUTION : This Cabinet is NOT a TOY.

Keep your child / children at bay during the assembly process.

For moving the Cabinet and to prevent damage to the Cabinet, two people may be needed to execute this action.

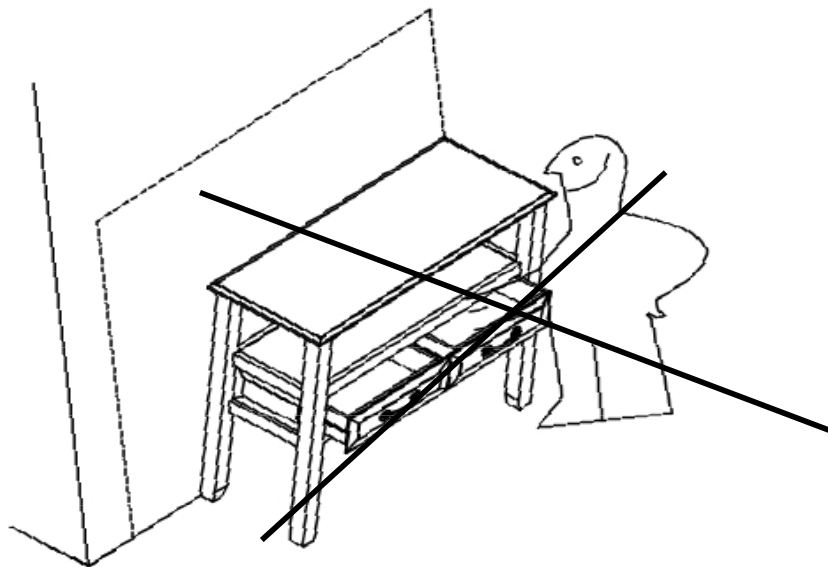
Hardware

①		1.6 cm Screw	2
②		5 cm Screw	2
③		Metal Bracket	4
④		Cabinet Restraint Strap	2



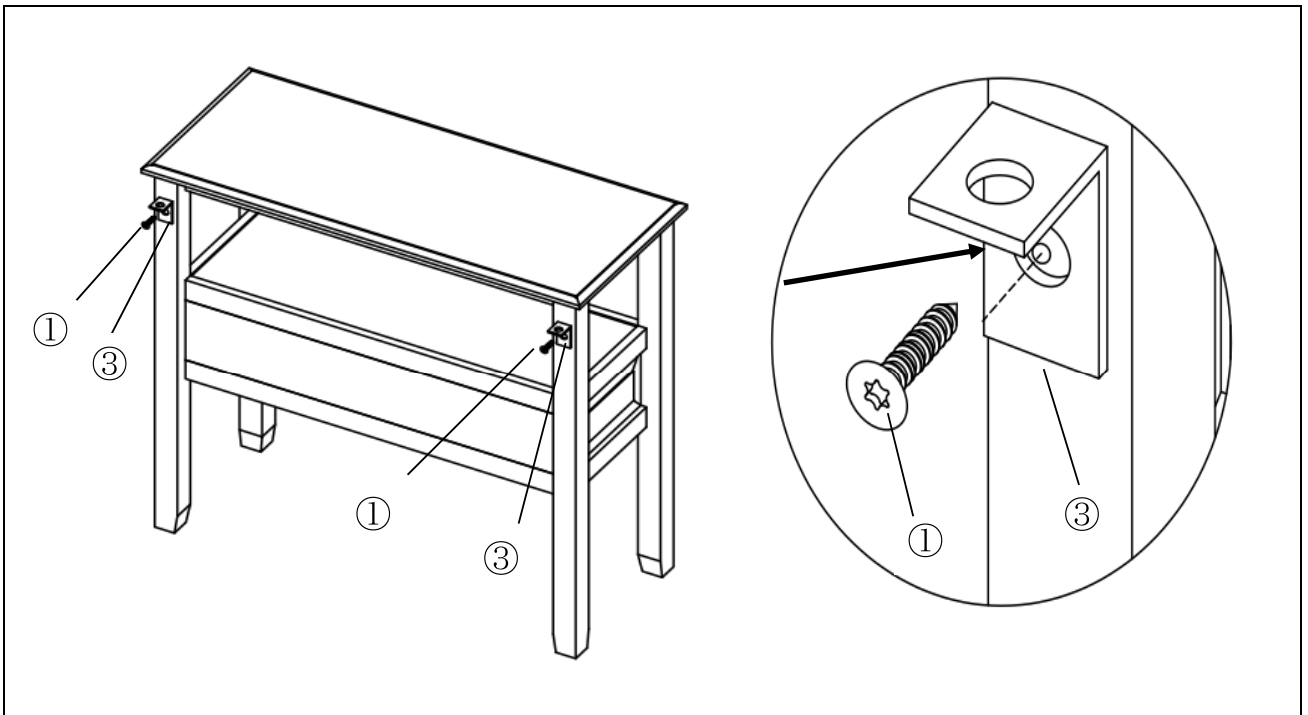
WARNING

Serious or fatal crushing injuries can occur from tipping furniture.
To help prevent tip-over: **ALWAYS** secure this furniture to the wall using
Cabinet Restraint Device.
See product instructions for more ways to help prevent furniture tip-over.

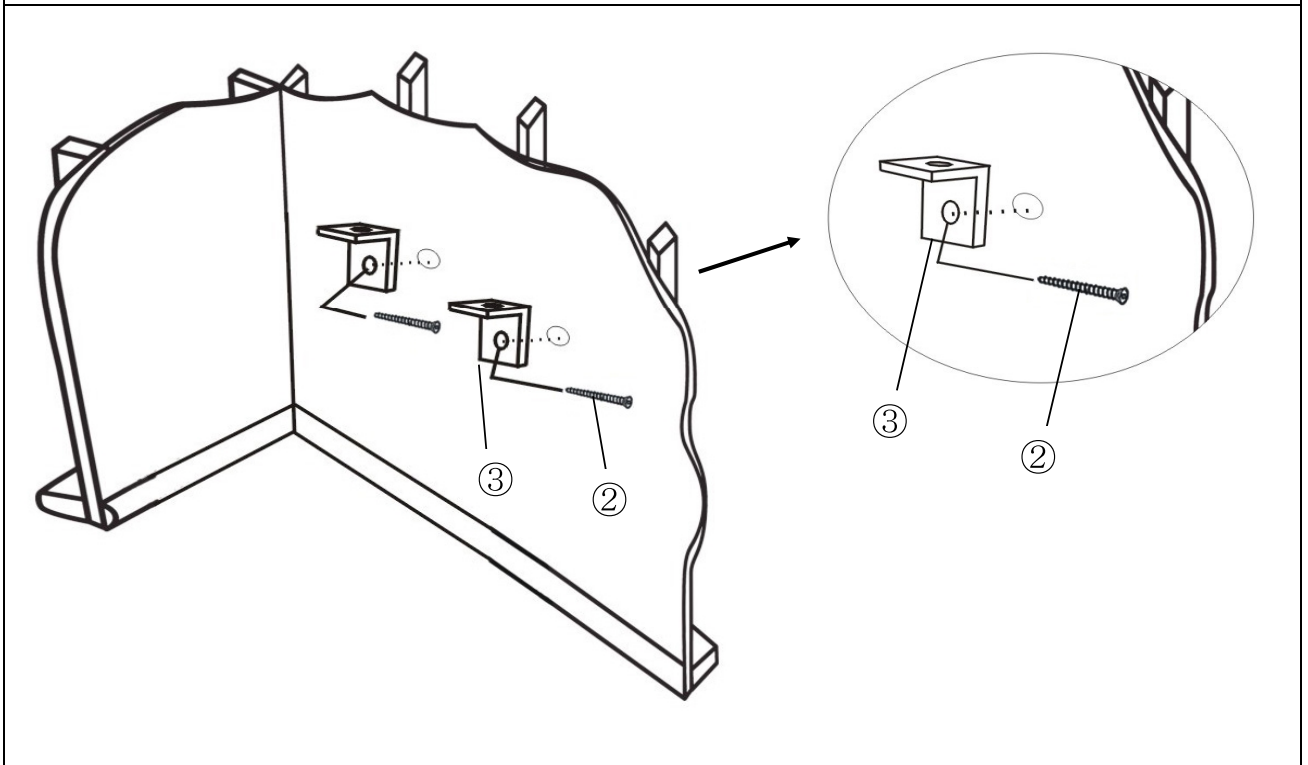


Usage For Cabinet Restraint Device :

For Cabinet against wall, fix 2pcs Metal Brackets(③) on wall and 2pcs Metal Brackets(③) on product, use Cabinet Restraint Strap(④) to connect the Metal Bracket(③) on wall and product. Find details as below:



A: Firstly, turn back the Cabinet outwards as shown above.
 Then fix one Metal Bracket (③) on the leg of Cabinet by the 1.6cm Self Tapping Screws (①) . The distance between the left edge of the leg and bracket is 0.3inch. The distance between the right edge of the leg and bracket is 0.3inch
 Repeat this step to fix another Metal Bracket (③) on product, as shown above.



B : Find out the screw holes on the wall.

First, mark the point at same height on the wall as L-shaped Metal Bracket (③) on product. You can find these same points in two ways as below:

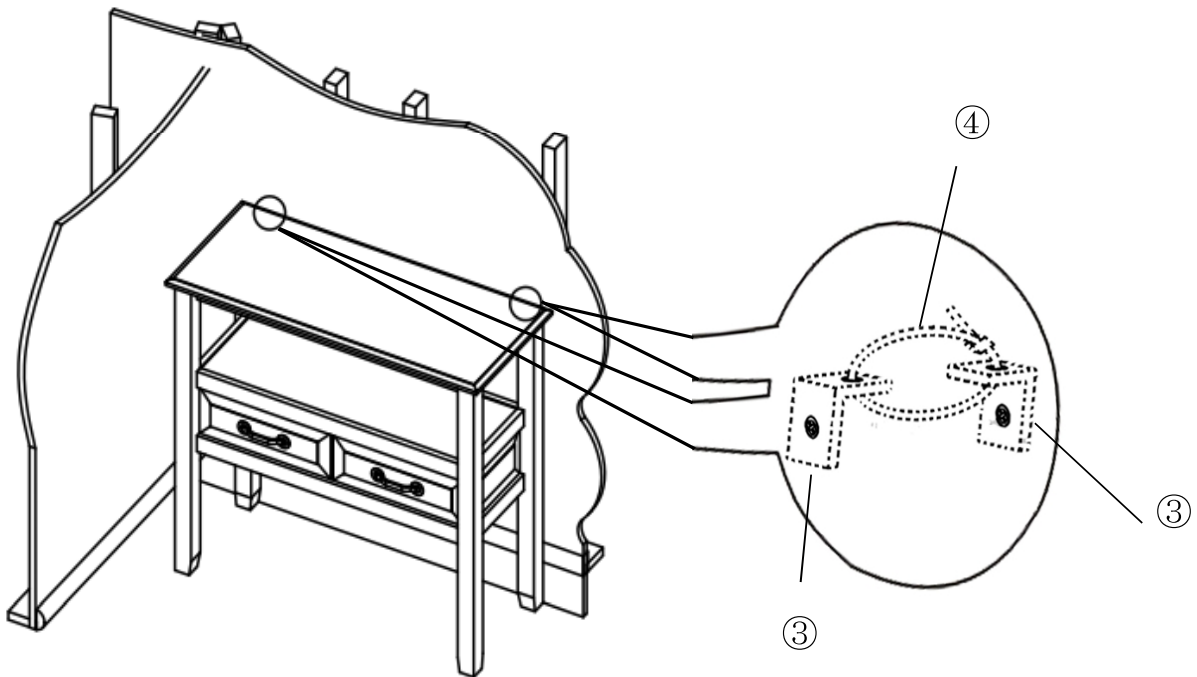
1.Move the Cabinet back to the wall ,make these points on the wall and product are at same height

2.Measure the height of the Metal Bracket and the wall by ruler ,keep them are accurately and same height.

(Caution:The Cabinet Restraint Strap(④) between Metal Brackets on product and wall should be within 3.5" .)

Then fix one L-shaped Metal Bracket on the mark on wall by the 5cm Self Tapping Screws(②).











Repeat this step to fix another Metal Bracket (③) on wall, as shown above.



C: Move the Cabinet against the wall. Then pull the Cabinet Restraint Strap(④) through two Metal Brackets(③) one by one, lock tight the Cabinet Restraint Strap(④), as shown above.

Cabinet Restraint Device is installed and Cabinet is ready for use.

Care & Maintenance

-  Do not put hot items directly on furniture surface
 -  Do not clean furniture with harsh cleansers or polish.
 -  Do not place furniture under direct sunlight.
 -  Do not place furniture near heating or cooling vents.
 -  Do not write on furniture without a padded barrier to protect the surface.
 -  Do not place furniture outside . For indoor use only .
 -  Not for commercial use. For residential use only .
 -  Stains may be removed with mild soap solution and damp cloth.
 -  Children should not climb or jump on the furniture.

-  Dust and pick-up spills using a clean, non-colored, lint-free cloth .

What is Proposition 65?

Proposition 65 is a California law that requires warning labels on products that may contain one of more than 800-plus chemicals or ingredients that the California Office of Environmental Health Hazard Assessment (OEHHA) has deemed to cause cancer or other reproductive toxicity. Chemicals and elements on this list include wood dust, brass, and other everyday substances, which can be found in very common household items, such as: lamps, tableware, jewelry, crystal glasses, electric cords, beauty products, automobiles, and furniture.

Why Did I Find a Proposition 65 Warning on My Home Goods Product?

We include Proposition 65 warnings on all of our products because there is always a chance that one of the 800-plus common chemicals and ingredients listed under this law could potentially be on our furniture or packing materials. We risk large fines under this law, if we don't include this warning.

Should I worry?

We realize you may be worried finding this warning on our products, but we want to reassure you that the hazardous exposure limits for any of these chemicals have never been found on furniture products that we've shipped to our customers. Additionally, this warning label is very common and can be found on almost every piece of furniture sold in the state of California.

Just How Common Are Proposition 65 Warnings?

Proposition 65 warnings have become so common in California that it is hard to take a trip to a local bank, grocery store, or restaurant without finding at least one warning. In fact, even the Disney Land Resort has a Proposition 65 warning:
