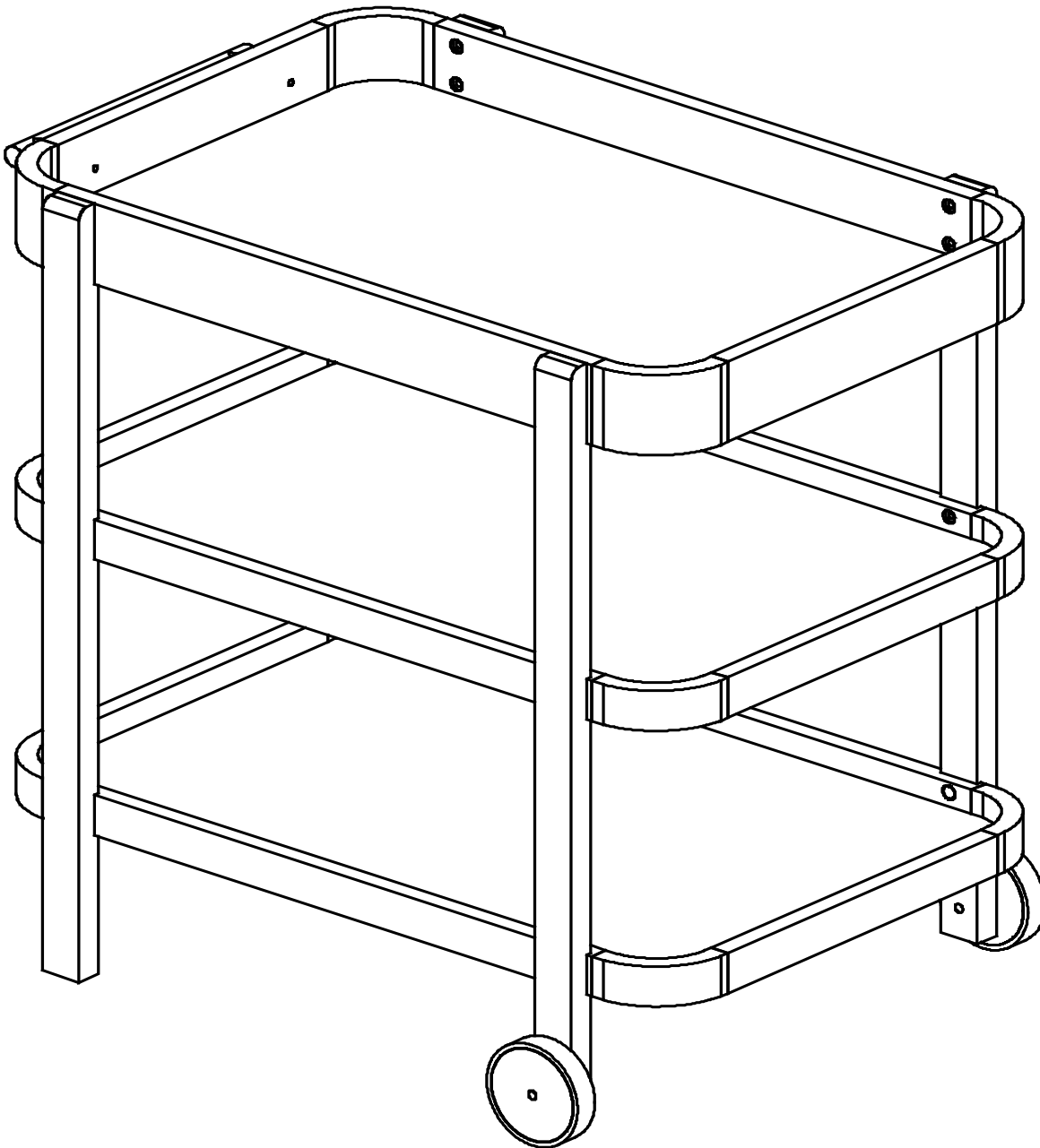


# Assembly Instructions








Caution: This Barcart is NOT a TOY.








Keep your child/children at bay during the assembly process.

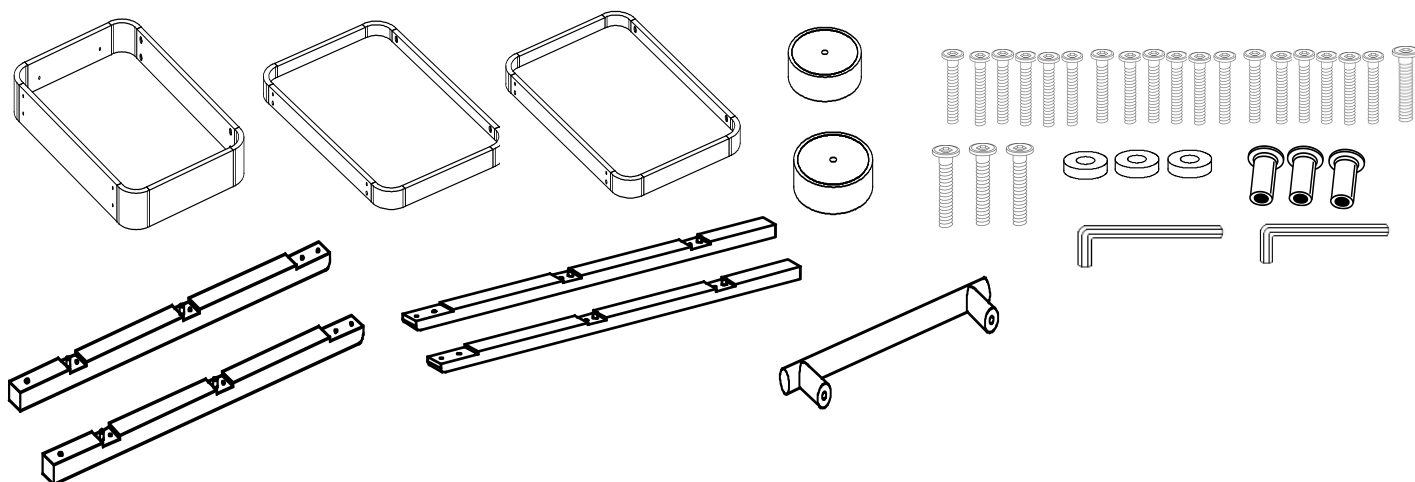

## Before Beginning Assembly:

☒ Do not assemble on flooring or carpet.



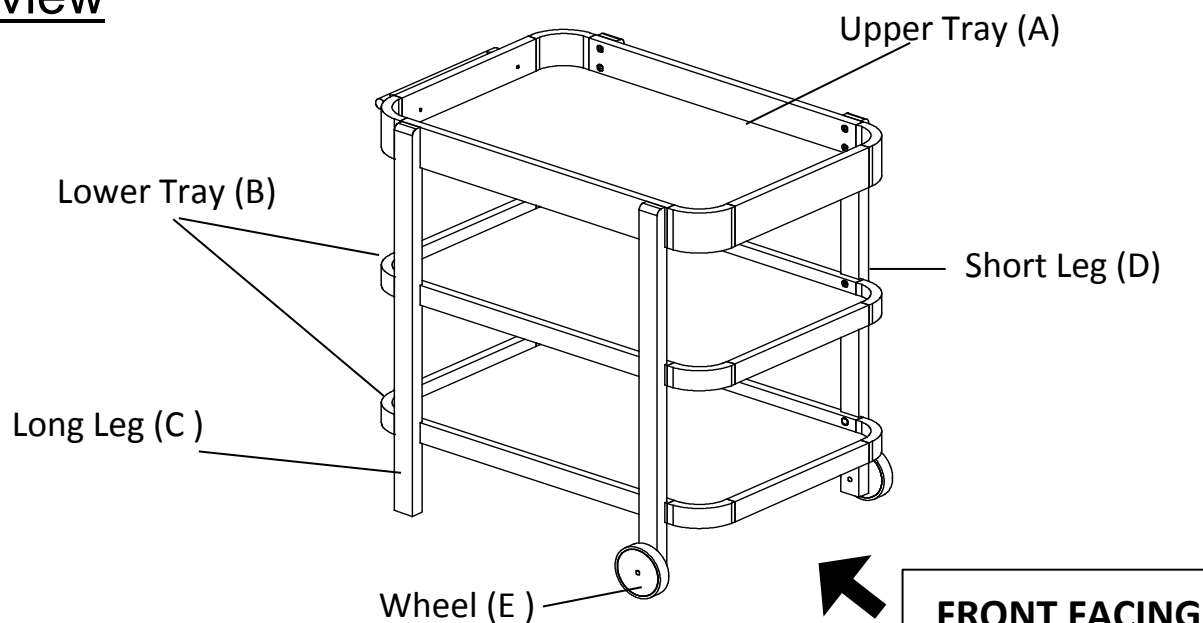
☒ Assemble on a clean non-marring surface (packing foam).



☒ Save all packaging until finished.

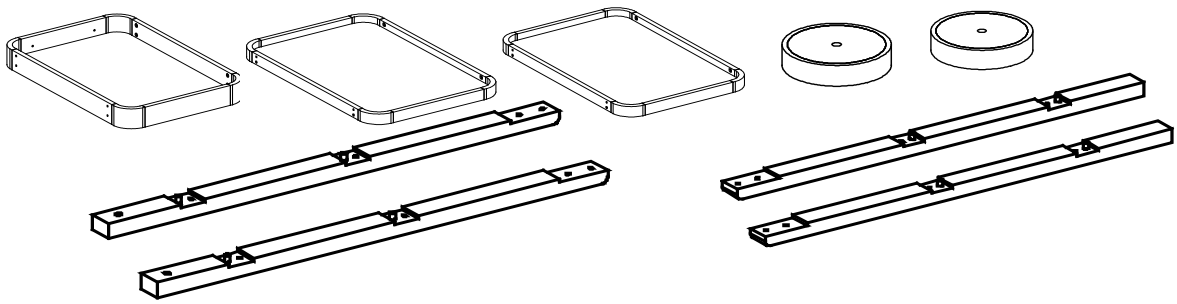
# Assembly Steps

## Overview



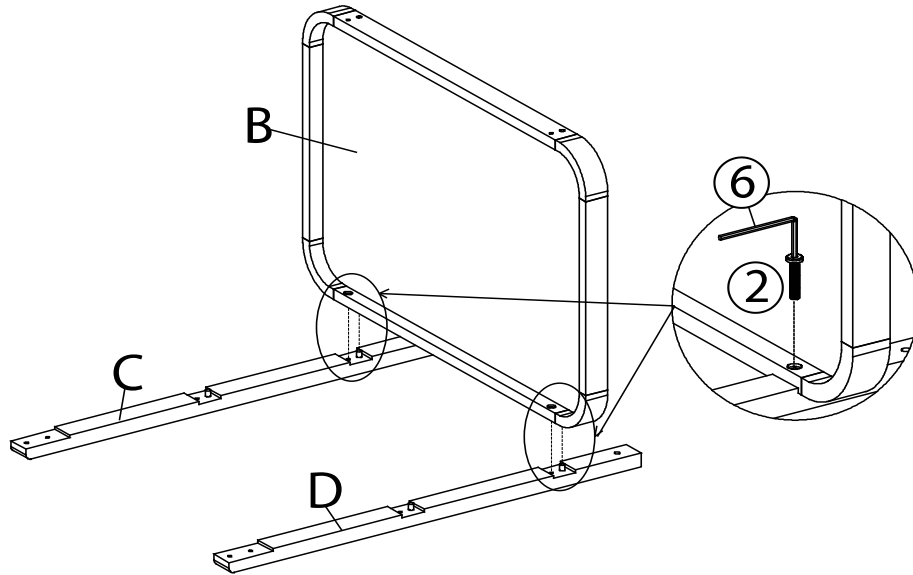
This Barcart has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Right Barcart parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

## Step 1



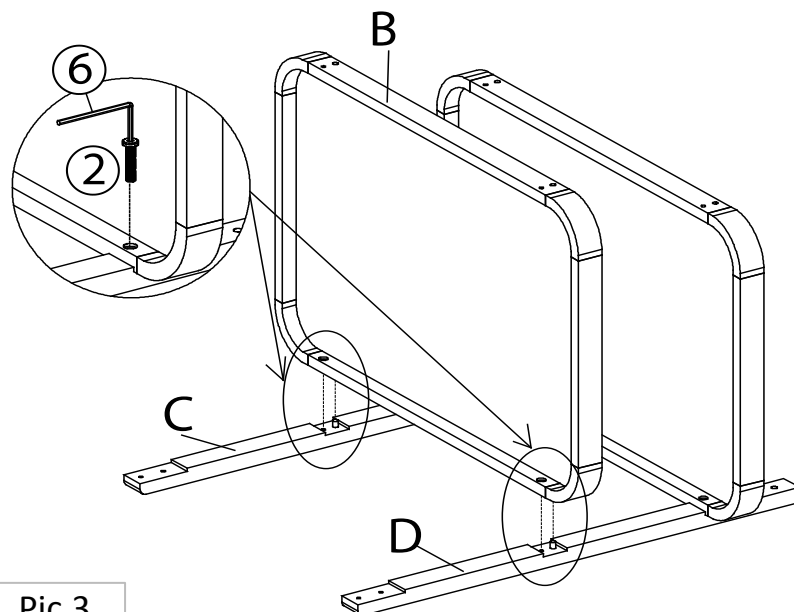
Unpack and place all parts on a clean, non-marring surface.

## Step 2



Place the Long Leg(C), Short Leg (D) facedown as shown in picture above.  
With the assistance from your partner, position Lower Tray(B) sideways, secure the Lower Tray (B) to Long Leg (C), Short Leg (D) using Bolts(②) and with Allen Key(⑥) as shown in the picture above  
**Do not fully tighten the Bolts.**

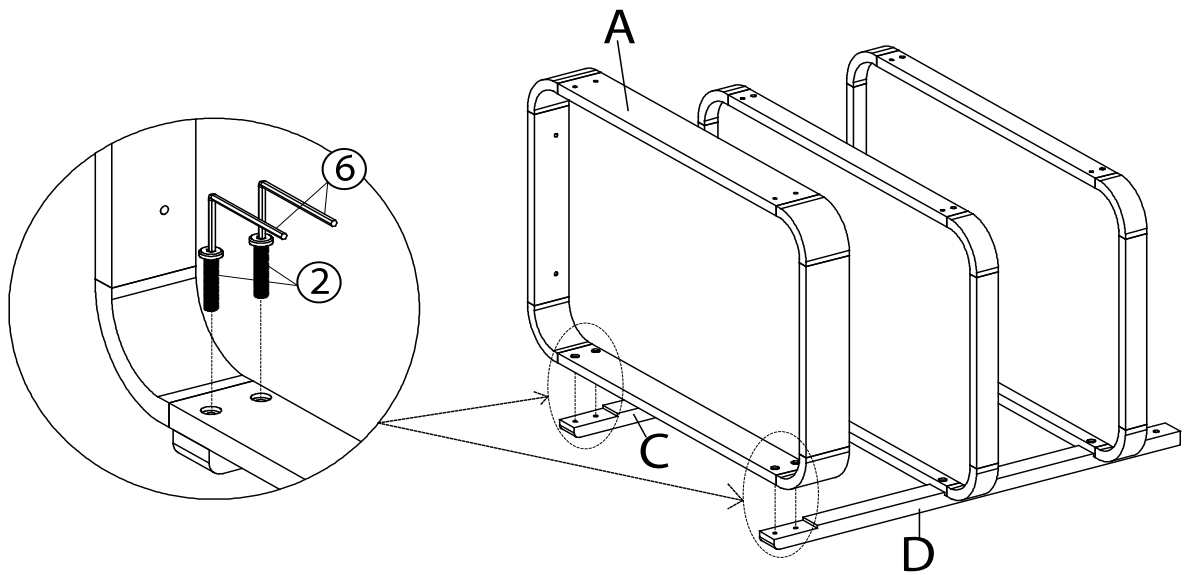
## Step 3

Then, repeat the same process for the Lower Tray(B) as shown in the picture above.  
**Do not fully tighten the Bolts.**

## Step 4

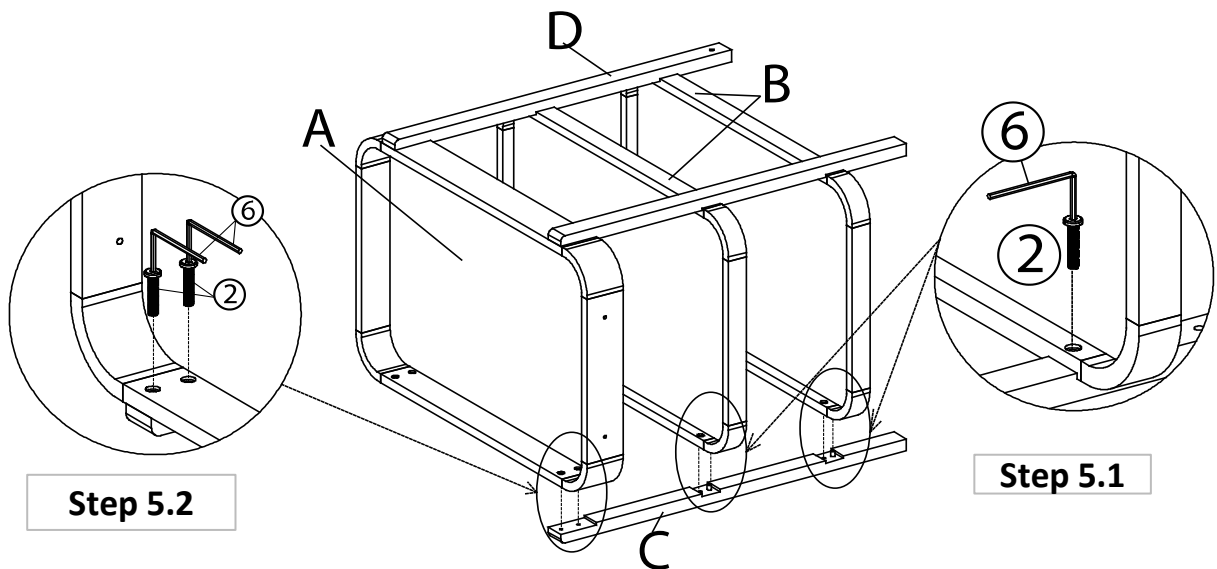


With the assistance from your partner, position Upper Tray (A) sideways as shown in the picture

Attach Upper Tray (A) to Long Leg (C), Short Leg (D) by using Bolts(②) and Allen Key(⑥) as shown in the picture above

**Do not fully tighten the Bolts.**

## Step 5



Place the Long Leg (C) facedown

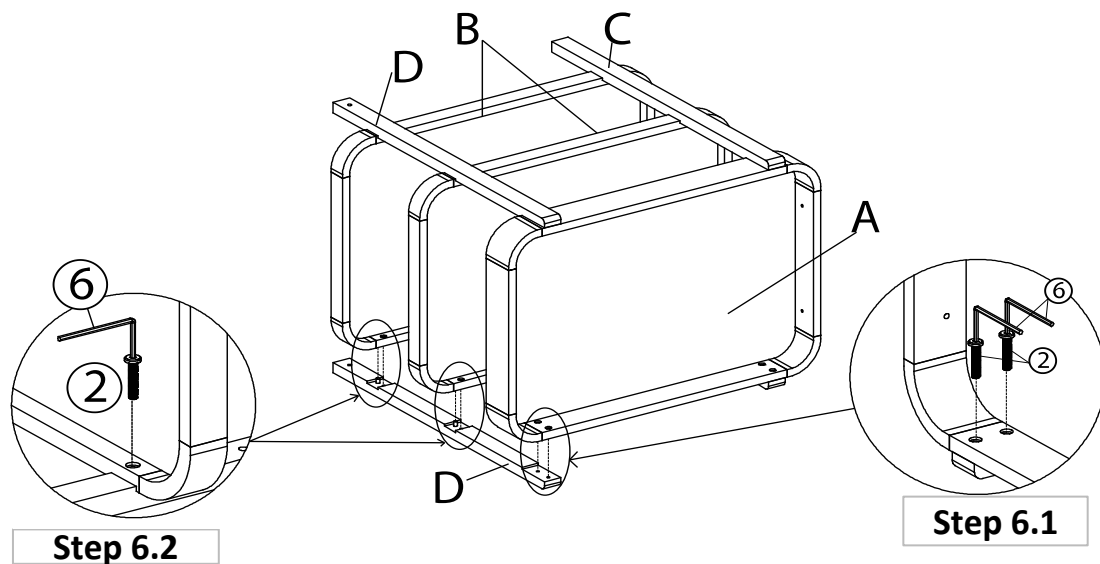
With the assistance from your partner, position pre-assembled in step 4 on Long Leg (C) as shown in the picture.

**Step 5.1:** Secure the Lower Tray (B) to Long Leg (C) by using Bolts(②) and with Allen Key(⑥) as shown in the picture above.

**Step 5.2:** Secure the Upper Tray (A) to the Long Leg (C) by using Bolts(②) and with Allen Key(⑥) as shown in the picture above.

**Do not fully tighten the Bolts.**

## Step 6



Place the Short Leg (D) facedown

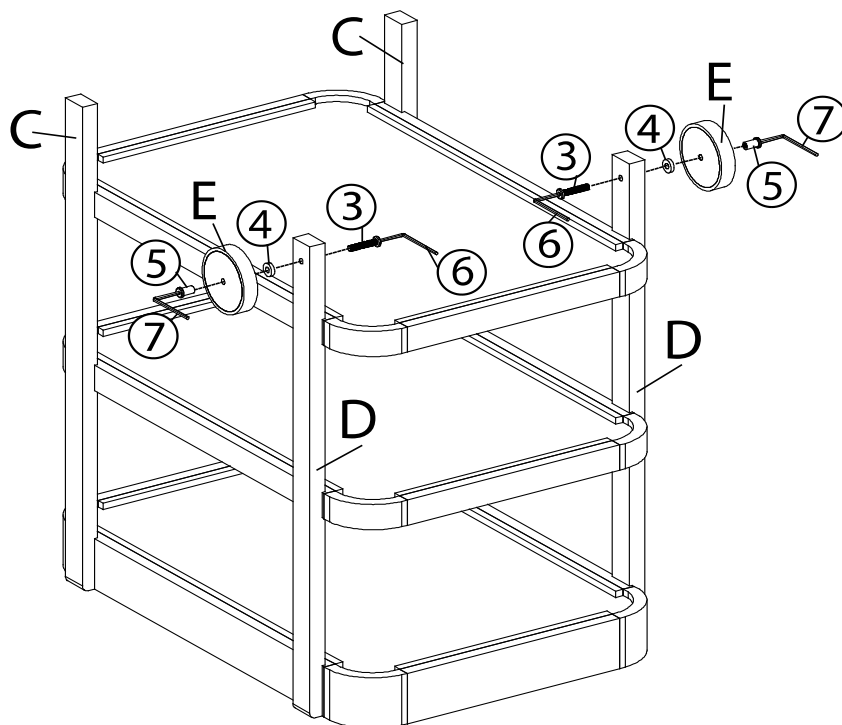
With the assistance from your partner, position pre-assembled in step 5 on Short Leg (C) as shown in the picture.

Step 6.1: Secure the Upper Tray (A) to Short Leg (D) by using Bolts(②) and Allen Key(⑥) as shown in the picture.

Step 6.2: Secure the Lower Tray (B) to Short Leg (D) by using Bolts(②) and Allen Key(⑥) as shown in the picture above.

**Do not fully tighten the Bolts.**

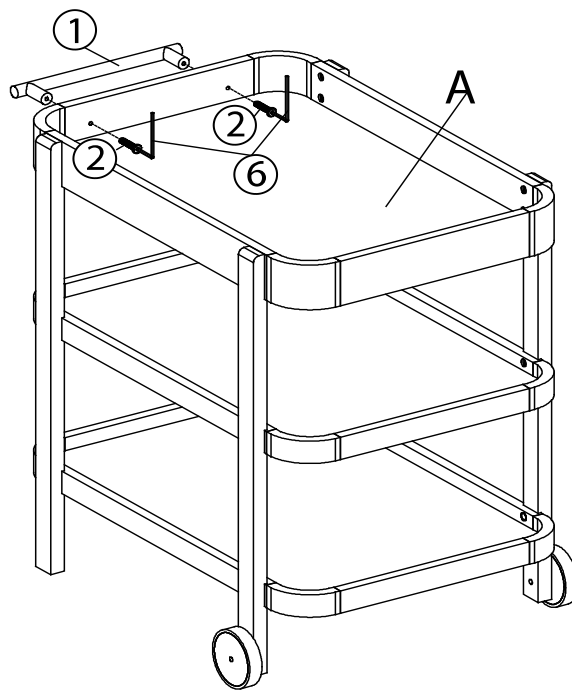
## Step 7



With the assistance from your partner, turn up side down the pre-assembled on step 6

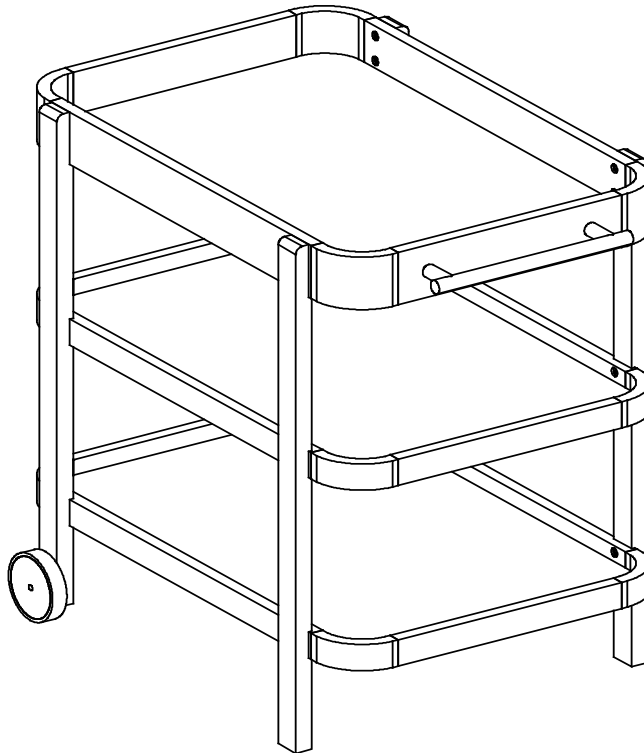
Secure the Wheels (E) to Short Leg(D) by using Bolt (③), Washer (④), Sleeve Nut(⑤) with Allen Key (⑦) and Allen Key (⑥) as shown above.

## Step 8























To affix the Handle (①) to the Upper Tray (A) , align the bolt mounting position of the Handle to the mounting positions at the Upper Tray.  
Insert the Bolts(②) through the mounting position and affix the Handle by the Allen Key(⑥) as shown in picture.

## Step 9



Place the Barcart on a **LEVEL SURFACE**.  
Inspect it and make sure all parts are adequately connected.  
Ensure all screws, bolts are fully locked into position and secured.  
Your Barcart is ready for use.  
This Barcart can only be used on a flat, level surface.

## Care & Maintenance

-   ● Do not put hot items directly on furniture surface.
  -   ● Do not clean furniture with harsh cleansers or polish.
  -   ● Do not place furniture under direct sunlight.
  -   ● Do not place furniture near heating or cooling vents.
  -   ● Do not write on furniture without a padded barrier to protect the surface.
  -   ● Do not place furniture outside . For indoor use only .
  -   ● Not for commercial use. For residential use only .
  -   ● Stains may be removed with mild soap solution and damp cloth.
  -   ● Children should not climb or jump on the furniture.

-   ● Dust and pick-up spills using a clean, non-colored, lint-free cloth .

## Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
